HB 1678 - DIGEST

Eliminates inconsistent tax treatment of digital business inputs.

Ensures that prewritten computer software developers remain eligible for the manufacturing machinery and equipment sales and use tax exemption.

Provides greater clarity for out-of-state sellers concerning their tax obligations.
