House Bills

HB 1008-S by House Committee on General Government & Information Technology (originally sponsored by Representatives Smith, Hudgins, Hayes, Stanford, Moeller, Magendanz, and Buys)

Authorizing the state auditor to conduct audits of state government and local agencies' data storage and management practices thereby protecting privacy and securing personal information from computer hacking or misuse of data.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Authorizes the state auditor to conduct an audit of a state or local agency to determine if the agency's data management and storage practices are consistent with adopted standards.

Requires state agencies and local governments to notify the state auditor of a computer breach.

Requires the state auditor's office to consult with the office of the chief information officer and local governments in providing training on information security for state and local governments.

Creating a silver alert system.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Includes a "silver alert" designation in the amber alert plan and the endangered missing person advisory plan.

HB 1091 by Representatives Van De Wege, Klippert, Carlyle, Fey, Goodman, Tarleton, Holy, Gregerson, Jinkins, Lytton, Stanford, Orwall, Kirby, Fitzgibbon, Sawyer, Ryu, Riccelli, and Morris; by request of Attorney General

Concerning the unauthorized interference of ticket sales over the internet.

(AS OF HOUSE 2ND READING 2/16/15)

Prohibits the use of software to circumvent, thwart, interfere with, or evade a security measure, access control system, or other control or measure on a ticket seller's internet web site.

Prohibits the sale of software that is advertised for profit with the express purpose to circumvent, thwart, interfere with, or evade a security measure, access control system, or other control or measure on a ticket seller's internet web site.

HB 1107-S by House Committee on Community
Development, Housing & Tribal Affairs
(originally sponsored by Representatives Springer, Wilcox,
Reykdal, Fitzgibbon, Bergquist, Hudgins, Lytton, McBride,
Santos, Jinkins, Appleton, Tarleton, and Walkinshaw)

Concerning access to and creation of cultural and heritage
programs and facilities.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Authorizes county legislative authorities to create a
cultural access program.

Authorizes a county to impose sales and use taxes or
additional regular property tax levies for the purposes
authorized in this act.

HB 1120-S by House Committee on Judiciary (originally

Providing immunity for school bus drivers.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Provides immunity from civil or criminal liability for
school bus drivers for certain acts.

HB 1132-S by House Committee on Health Care &
Wellness (originally sponsored by
Representatives Tharinger, Harris, Wylie, Van De Wege,
Johnson, Lytton, Fey, Riccelli, Jinkins, Buys, Cody,
Appleton, Ortiz-Self, Hayes, Gregerson, and Short)

Concerning the regulation of adult family homes.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Requires the department of social and health services to
charge a licensee a nonrefundable fee in the event of a
change in ownership of an adult family home.

Authorizes the department of social and health services
to: (1) Authorize a one-time waiver of all or any portion of
certain licensing, processing, or change of ownership fees
if the department determines that an adult family home is
being relicensed because of exceptional circumstances and
that to require the full payment of the fees would present a
hardship to the applicant; and

(2) Under exceptional circumstances, consider granting
a license to an applicant who has not completed the adult
family home administration and business planning class but
who meets all other requirements.

Concerning remediation plans for licensed health and
health-related professions to resolve eligible complaints of
unprofessional conduct.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Authorizes a disciplining authority to, after
investigation, offer a remediation plan to licensed health and
health-related professions to resolve eligible complaints of
unprofessional conduct.

Requires the remediation plan to be posted on the
department of health's web site during the term of the plan
and requires the department to remove the posting from the
web site after the disciplining authority determines that the
license holder has successfully completed the remediation
plan.

Creating a penalty for concealing the source of a campaign
contribution.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Creates a penalty for concealing the source of a
campaign contribution.

HB 1183-S by House Committee on Health Care &
Wellness (originally sponsored by

Concerning radiology benefit managers.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Requires a radiology benefit manager, in order to
conduct business in this state, to register with the department
of revenue's business licensing service and annually renew
the registration.

HB 1186-S by House Committee on Health Care &
Wellness (originally sponsored by

Requiring notifications to patients in observation status at hospitals.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Requires a hospital to provide oral and written notification to a patient or patient's legal representative within twenty-four hours of classifying the patient as an outpatient in observation status unless the patient has been discharged or has left the hospital before the expiration of the twenty-four-hour period.

Prohibiting retail businesses from recording consumer identification information during transactions.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Prohibits an owner, manager, or employee of a retail store or chain from copying or recording a customer's personal information contained on a photo or other identification.

HB 1320-S2 by House Committee on General Government & Information Technology (originally sponsored by Representatives Goodman and Moscoso; by request of Department of Corrections)

Creating an identicaid program for certain incarcerated offenders.

(DIGEST OF PROPOSED 2ND SUBSTITUTE)

Requires the department of corrections, in conjunction with the department of licensing, to provide offenders with a state-issued identicaid.

Requires an offender receiving a state-issued identicaid to pay a fee of nine dollars to the department of corrections to offset the cost of obtaining the identicaid.

HB 1353-S by House Committee on Health Care & Wellness (originally sponsored by Representatives Robinson, Riccelli, Rodne, Bergquist, Moscoso, and Gregerson)

Requiring free infectious disease testing for good samaritans.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Allows testing of a good samaritan to be performed in order to guide postexposure prophylaxis treatment of the

good samaritan if he or she came into contact with bodily fluids while rendering emergency care.

HB 1440-S by House Committee on Public Safety (originally sponsored by Representatives Taylor, Goodman, Pollet, Scott, Condotta, Shea, G. Hunt, Young, Moscoso, Smith, Ryu, Jinkins, Magendanz, Farrell, and McCaslin)

Prohibiting the use of a cell site simulator device without a warrant.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Prohibits the state and its political subdivisions, by means of a cell site simulator device, from collecting or using a person's electronic data or metadata without: (1) That person's informed consent;

(2) A warrant; or

(3) Acting in accordance with a legally recognized exception to the warrant requirements.

Hunt, Ryu, McBride, Sawyer, Stokesbary, Rodne, Young, Farrell, and Kilduff)

Concerning the sealing of juvenile records and fines imposed in juvenile cases.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Addresses the sealing of juvenile records and fines imposed in juvenile cases.

Feb 11 ELHS - Majority; 1st substitute bill be substituted, do pass.

Minority; do not pass.

Feb 13 Referred to General Government & Information Technology.

HB 1564-S by House Committee on Commerce & Gaming (originally sponsored by Representatives Kilduff and Muri)

Concerning the local option prohibition on the sale of liquor.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Addresses territory annexed into a city after passage of a liquor prohibition by that city.

Feb 12 COG - Majority; 1st substitute bill be substituted, do pass.

Feb 16 Referred to Rules 2 Review.

HB 1575-S by House Committee on Capital Budget

(originally sponsored by Representatives Buys, Dunshee, DeBolt, and Stanford)

Regulating retainage bonds on public contracts.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Modifies public improvement contract provisions relating to retainage bonds.

Feb 10 CB - Majority; 1st substitute bill be substituted, do pass.

Feb 13 Referred to Rules 2 Review.

HB 1639-S by House Committee on Public Safety (originally sponsored by Representatives Taylor, Goodman, Morris, Shea, Walkinshaw, Smith, Ryu, Appleton, Condotta, Moscoso, Kagi, Muri, Young, Scott, Schmick, G. Hunt, and Farrell)

Concerning technology-enhanced government surveillance.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Prohibits a state agency, including the Washington state patrol and the department of natural resources, from procuring an extraordinary sensing device unless money is expressly appropriated by the legislature for this specific purpose.

Prohibits a local agency from procuring an extraordinary sensing device without the explicit approval of the governing body of the locality, given for that specific extraordinary sensing device to be used for a specific purpose.

HB 1668-S by House Committee on Public Safety (originally sponsored by Representatives Kilduff, Muri, Hurst, Fey, Stokesbary, Jinkins, Stambaugh, Kirby, Zeiger, and Sawyer)

Restricting conditional releases of sexually violent predators outside their county of origin.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Requires a court, before authorizing release to a less restrictive alternative, to consider whether it is appropriate to release a sexually violent predator to his or her county of commitment.

Feb 13 PS - Majority; 1st substitute bill be substituted, do pass.

Feb 18 Referred to Appropriations.

HB 1671-S by House Committee on Health Care & Wellness (originally sponsored by Representatives Walkinshaw, Griffey, Cody, Smith, Peterson, Magendanz, Riccelli, Stanford, Appleton, Robinson, Tharinger, and Jinkins)

Concerning access to opioid overdose medications.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Authorizes a practitioner to prescribe, dispense, distribute, and deliver an opioid overdose medication: (1)

Directly to a person at risk of experiencing an opioid-related overdose; or

(2) By collaborative drug therapy agreement, standing order, or protocol to another person who is in a position to assist a person at risk of experiencing an opioid-related overdose.

Authorizes a pharmacist to: (1) Dispense an opioid overdose medication pursuant to a prescription; and

(2) Administer an opioid overdose medication to a person at risk of experiencing an opioid-related overdose.

HB 1673-S by House Committee on Early Learning & Human Services (originally sponsored by Representatives Kagi, Condotta, and Moscoso; by request of Department of Social and Health Services)

Concerning substance abuse prevention and treatment programs funded by the marijuana excise tax.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Provides funding from marijuana excise taxes for the development and evaluation of programs and practices aimed at the prevention or reduction of substance use.

Feb 13 ELHS - Majority; 1st substitute bill be substituted, do pass.

Feb 17 Referred to Appropriations.

HB 1744-S by House Committee on Public Safety (originally sponsored by Representative Appleton; by request of Department of Corrections)

Modifying provisions governing inmate funds subject to deductions.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Exempts from certain deduction requirements, money received by the department of corrections on behalf of an inmate from family or other outside sources for the payment of certain medical expenses.

Feb 13 PS - Majority; 1st substitute bill be substituted, do pass.

Feb 18 Referred to General Government & Information Technology.

HB 1756-S by House Committee on Public Safety (originally sponsored by Representatives Kilduff, Muri, Kirby, Goodman, Sawyer, and Van De Wege)

Concerning community policing at and around western state hospital.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Requires western state hospital to enter into a contract with the city in which it is located for the provision of community policing services at the hospital and in the surrounding areas.

Feb 13 PS - Majority; 1st substitute bill be substituted, do pass.

Minority; do not pass.

Feb 18 Referred to Appropriations.

HB 2001-S by House Committee on Commerce & Gaming (originally sponsored by Representatives Zeiger and Condotta)

Concerning the use of and possession of electronic or electromechanical amusement machines.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Defines a "material degree of skill" with regard to amusement games.

Allows amusement games to contain random features.

Authorizes the gambling commission to set fees to test games for compliance.

-- 2015 REGULAR SESSION --

Feb 12 COG - Majority; 1st substitute bill be substituted, do pass.

Feb 17 Referred to Rules 2 Review.

HB 2145 by Representatives Fitzgibbon and Santos

Modifying the appointment process for trustees and the selection process for librarians of rural county library districts in counties with one million or more residents.

Modifies rural county library district provisions relating to the appointment process for trustees and the selection process for librarians.

-- 2015 REGULAR SESSION --

Feb 18 First reading, referred to Local Government (Not Officially read and referred until adoption of Introduction report).

HB 2146 by Representatives Kilduff, Smith, Dunshee, and Stanford

Concerning public works assistance account program interest rates, project ranking, board membership, and other requirements.

Changes the composition of the public works board.

Modifies public works projects provisions relating to interest rates for loan programs and the priority process for certain projects.

-- 2015 REGULAR SESSION --

Feb 18 First reading, referred to Capital Budget (Not Officially read and referred until adoption of Introduction report).

HB 2147 by Representatives Robinson, Sells, Sullivan, Pollet, Reykdal, Tharinger, Bergquist, Moscoso, and Santos

Providing accountability and transparency for aerospace-related tax incentives.

Establishes the aerospace tax incentive accountability act.

Declares it is the legislature's specific public policy objective to maintain and grow the state's aerospace industry workforce to one hundred thousand five hundred employment positions by 2040.

Requires the joint legislative audit and review committee to assess: (1) Whether aerospace industry employment within the state is on target to reach an

employment level of one hundred thousand five hundred by 2040; and

(2) Growth in high-wage employment, as defined by an annual or hourly wage equal to or greater than the state median wage.

Feb 18 First reading, referred to Finance (Not Officially read and referred until adoption of Introduction report).

HB 2148 by Representatives Chandler, Pike, and Hudgins

Concerning the state auditor including allowing for audits to be conducted by a private entity and establishing an appeal process.

Authorizes local governments to request a financial audit from a private entity in lieu of an audit by the state auditor and requires the state auditor to approve the request.

Allows state agencies and local governments to appeal the results of an audit pursuant to the administrative procedure act.

-- 2015 REGULAR SESSION --

Feb 18 First reading, referred to General Government & Information Technology (Not Officially read and referred until adoption of Introduction report).

Senate Bills

SB 5218-S by Senate Committee on Financial Institutions & Insurance (originally sponsored by Senators Hobbs and Benton)

Concerning unlawful detainer actions for at-will tenancies.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Provides that a person is guilty of unlawful detainer if he or she occupies real property with the prior consent of the owner but without a denominated rental amount or designated period of tenancy on an at-will basis and he or she fails to remove from the premises after twenty days' notice in writing served upon him or her.

-- 2015 REGULAR SESSION --

Feb 13 FI - Majority; 1st substitute bill be substituted, do pass.
Passed to Rules Committee for second reading.

SB 5255-S by Senate Committee on Financial Institutions & Insurance (originally sponsored by Senators Hasegawa, McCoy, Chase, Hatfield, and Keiser; by request of Office of Minority and Women's Business Enterprises)

Concerning the linked deposit program.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Requires the director of the office of minority and women's business enterprises, with regard to the linked deposit program, to adopt rules prioritizing loans to minority or women's business enterprises or veteran-owned businesses for certain applicants that are located in an

underserved area of the state and do not currently have loans with other small business lending agencies.

Requires a minority or women's business enterprise or veteran-owned business, in order to qualify for a loan, to demonstrate the loan will result in the creation of at least five jobs over the life of the loan.

Feb 13 FI - Majority; 1st substitute bill be substituted, do pass.
Passed to Rules Committee for second reading.

SB 5355-S by Senate Committee on Higher Education (originally sponsored by Senators Bailey, Kohl-Welles, Roach, Conway, Braun, Baumgartner, Rolfes, O'Ban, McAuliffe, and Chase; by request of Governor Inslee)

Modifying the definition of resident student to comply with federal requirements established by the veterans access, choice, and accountability act of 2014.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Revises the definition of "resident student," for purposes of chapter 28B.15 RCW (college and university fees), to comply with federal requirements established by the veterans access, choice, and accountability act of 2014.

-- 2015 REGULAR SESSION --

Feb 13 HIE - Majority; 1st substitute bill be substituted, do pass.
And refer to Ways & Means.
Referred to Ways & Means.

SB 5418-S by Senate Committee on Commerce & Labor (originally sponsored by Senators Keiser, Braun, Parlette, McAuliffe, Benton, and Conway)

Creating a pilot program to improve care for catastrophically injured workers.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Requires the department of labor and industries to: (1) Implement a pilot program to substantially improve the health outcomes of catastrophically injured workers;

(2) Partner with a medical management firm with substantial experience in handling catastrophic workers compensation cases; and

(3) Refer catastrophically injured workers to the firm.

-- 2015 REGULAR SESSION --

Feb 13 CL - Majority; 1st substitute bill be substituted, do pass.
Feb 16 Passed to Rules Committee for second reading.

SB 5446-S by Senate Committee on Energy, Environment & Telecommunications (originally sponsored by Senators Hobbs, Liias, Mullet, Litzow, Pedersen, Fain, Frockt, McAuliffe, Benton, Chase, and Jayapal; by request of Governor Inslee)

Requiring incentives for electric vehicle readiness in buildings.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Allows noncommercial electric vehicle infrastructure in areas zoned for multifamily residences and certain other areas.

-- 2015 REGULAR SESSION --

Feb 13 EET - Majority; 1st substitute bill be substituted, do pass.
Minority; do not pass.
Passed to Rules Committee for second reading.

SB 5485-S by Senate Committee on Financial Institutions & Insurance (originally sponsored by Senators Hobbs and Benton)

Concerning debt adjusters.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

(2) Offer and teach medicine and forestry as major lines.

(DIGEST OF PROPOSED 1ST SUBSTITUTE)

Requires the state board for community and technical colleges to conduct a uniform campus climate assessment of community and technical colleges to gauge the prevalence of sexual assault on community and technical college campuses.

Requires institutions of higher education to: (1) Conduct a campus climate assessment to gauge the prevalence of sexual assault on their campuses;

(2) Make information available to current and prospective students and employees regarding campus sexual violence confidentiality and reporting requirements; and

(3) Refrain from establishing a different disciplinary process on the same campus for a matter of sexual violence, based on the status or characteristics of the student involved

in that disciplinary proceeding, including characteristics such as a student's membership on an athletic team, membership in a fraternity or sorority, academic year, or any other characteristics or status of a student.

(3) A person being trained to be a licensed security guard under the supervision of a certified firearms instructor.

assessment may be levied on the property for the expense of abatement.

SB 6025 by Senators Liias, Pearson, and Hargrove

Concerning tax incentives for producers of cross-laminated timber products.

Provides a sales and use tax exemption for labor and services rendered in respect to the constructing of qualified new structures, and expansion or renovation of qualified existing structures, for the purpose of manufacturing cross-laminated timber products.

Allows a business and occupation tax credit for all property taxes paid during the calendar year on property owned by a person qualifying for the sales and use tax exemption.

SB 6026 by Senator Dansel

Concerning volunteer emergency workers volunteering with a nonprofit ambulance service provider.

Increasing Washington state's motion picture and film industry viability by increasing the tax credit available to certain motion picture activities.

Increases the business and occupation tax credit for contributions made by a person to a Washington motion picture competitiveness program.

SB 6028 by Senator Benton

Concerning the issuance of secure drivers' licenses, permits, and identicards.

Requires a person obtaining or renewing his or her driver's license, driver's instruction permit, agricultural

driving permit, identicard, or intermediate license to show proof of his or her United States citizenship or his or her lawful presence within the United States.

Repeals statutes regarding the implementation of the federal REAL ID Act of 2005 and compliance with federal REAL ID Act of 2005 requirements.

SB 6029 by Senator Miloscia

Establishing a living wage.

Prohibits a city, town, county, or port district from requiring, enforcing, or otherwise regulating any of the following for private employers: Payment of wages, hours of work, employee retention, or leave from employment.

Provides for submission of this act to a vote of the people.

Withdraws from the smarter balanced assessment consortium assessments and returns to the prior Washington state measurement of student progress assessments.

Addresses student performance standards for the purpose of high school graduation.

SB 6031 by Senator Chase

Creating contractor reporting requirements for public works contracts awarded or managed by the department of enterprise services.

Requires public works contracts, awarded or managed by the department of enterprise services, to include a provision requiring the contractor and subcontractors on the project to submit the following information to the department at least twice per month: (1) Current and complete certified payroll information for all work on the project subject to prevailing wage requirements; and (2) Apprentice utilization information.

SB 6032 by Senator Miloscia

Revising procedures for petitions for adoption, amendment, or repeal of agency rules.

SB 6033 by Senators Roach, Liias, and Benton

Establishing a task force to examine state and local regulations that affect small businesses.

Expires June 30, 2016.

SB 6034 by Senators Roach, Liias, Benton, and Conway

Increasing visibility of and public contracting opportunities for veteran-owned businesses.

Requires the director of the department of enterprise services to establish a process to facilitate the maximum participation of veteran-owned businesses in procurement contracts.

Requires publicly viewable web sites and databases maintained by the department of enterprise services listing businesses for competitive solicitation purposes to include: (1) An application program interface for filtering to veteran-owned and minority and women's business enterprises businesses; and

(2) An application program interface for state agencies to certify that the process established by the director has been followed.
