House Bills

HB 2251 by Representatives Tharinger, Takko, Taylor, Blake, Van De Wege, Kretz, Short, Wilcox, and Johnson

Providing a sales and use tax exemption for the purchase or use of qualifying timber-felling equipment.

Provides a sales and use tax exemption on qualifying timber-felling equipment to eligible timber harvesters.

May 1 First reading, referred to Finance (Not Officially read and referred until adoption of Introduction report).

HB 2252 by Representatives Hudgins, Wilcox, and S. Hunt

Concerning the state capital historical museum.

Transfers responsibility for the maintenance, operation, and subsequent leasing of the state capital historical museum from the Washington state historical society to the department of enterprise services.

Allows the department of enterprise services to lease the state capital historical museum to other state agencies or private parties.

HB 2253 by Representatives Hudgins and Taylor

Amending statutory timelines governing the administration and organization of the joint administrative rules review committee that prescribe when member, alternate, chair, and vice chair appointments and final decisions regarding petitions for review must be made.

Modifies joint administrative rules review committee provisions with regard to member, alternate, chair, and vice

chair appointments and final decisions regarding petitions for review.

May 1 First reading, referred to State Government (Not Officially read and referred until adoption of Introduction report).

HB 2254 by Representatives Manweller, Bergquist, Magendanz, Reykdal, Griffey, and Parker

Requiring social media safety curricula and programs for common schools.

Requires the office of the superintendent of public instruction to develop a social media safety model curriculum, or update an existing curriculum on social media, that: (1) Includes age-appropriate safety lessons on how to respond to alarming or disturbing social media posts; and

(2) Provides information regarding the availability of means to report the posts anonymously.

Authorizes a school district to: (1) Use the model curriculum developed by the office of the superintendent of public instruction;

(2) Develop its own curriculum; or

(3) Use another curriculum that includes the requisite information.

May 4 First reading, referred to Education (Not Officially read and referred until adoption of Introduction report).

Senate Bills

SB 6118 by Senators O'Ban and Darneille; by request of Department of Social and Health Services

Concerning secure facilities for the criminally insane.

Provides a June 30, 2015, effective date for House Bill No. 1599 relating to secure facilities for the criminally insane.
