SB 5090 - DIGEST

Considers a qualifying utility in compliance with an annual target for a given year if the utility acquired electricity from a small modular reactor after December 31, 2019, and invested two percent of its total annual retail revenue requirement on the incremental costs of eligible renewable resources, the cost of renewable energy credits, or a combination of both.
