1 On page 3, after line 2, insert the following:

2 "Sec. 4. RCW 43.19.565 and 2011 1st sp.s. c 43 s 231 are each
3 amended to read as follows:

4 The department shall establish a motor vehicle transportation
5 service which is hereby empowered to:

6 (1) Provide suitable motor vehicle transportation services to
7 state agencies on either a temporary or permanent basis and upon such
8 demonstration of need as the department may require;

9 (2) Provide motor pools for the use of state agencies located in
10 the Olympia area and such additional motor pools at other locations
11 in the state as may be necessary to provide economic, efficient, and
12 effective motor vehicle transportation services to state agencies.
13 Such additional motor pools may be under either the direct control of
14 the department or under the supervision of another state agency by
15 agreement with the department;

16 (3) Establish an equitable schedule of rental and mileage charges
17 to agencies for motor vehicle transportation services furnished which
18 shall be designed to provide funds to recover the actual total costs
19 of motor pool operations including but not limited to vehicle
20 operation expense, depreciation expense, overhead, and nonrecoverable
21 collision or other damage to vehicles; and

22 (4) Establish guidelines, procedures, and standards for fleet
23 operations that other state agencies and institutions of higher
24 education may adopt. The guidelines, procedures, and standards shall
25 be consistent with and carry out the objectives of any general
26 policies adopted by the office of financial management under RCW
27 43.41.130.

28 Unless otherwise determined by the director after consultation
29 with the office of financial management, vehicles owned and managed
30 by the department of transportation, the department of agriculture
31 for the purpose of conducting livestock inspections, the department
32 of natural resources, and the Washington state patrol are exempt from
33 the requirements of subsections (1), (2), and (4) of this section.

1 **Sec. 5.** RCW 43.19.600 and 2011 1st sp.s. c 43 s 233 are each
2 amended to read as follows:

3 (1) Any passenger motor vehicles currently owned or hereafter
4 acquired by any state agency shall be purchased by or transferred to
5 the department. The director may accept vehicles subject to the
6 provisions of RCW 43.19.560 through 43.19.630, 43.41.130 and
7 43.41.140 prior to July 1, 1975, if he or she deems it expedient to
8 accomplish an orderly transition.

9 (2) The department, in cooperation with the office of financial
10 management, shall study and ascertain current and prospective needs
11 of state agencies for passenger motor vehicles and shall direct the
12 transfer to a state motor pool or other appropriate disposition of
13 any vehicle found not to be required by a state agency.

14 (3) The department shall direct the transfer of passenger motor
15 vehicles from a state agency to a state motor pool or other
16 disposition as appropriate, based on a study under subsection (2) of
17 this section, if a finding is made based on data therein submitted
18 that the economy, efficiency, or effectiveness of state government
19 would be improved by such a transfer or other disposition of
20 passenger motor vehicles. Any dispute over the accuracy of data
21 submitted as to the benefits in state governmental economy,
22 efficiency, and effectiveness to be gained by such transfer shall be
23 resolved by the director and the director of financial management.
24 Unless otherwise determined by the director after consultation with
25 the office of financial management, vehicles owned and managed by the
26 department of transportation, the department of agriculture for the
27 purpose of conducting livestock inspections, the department of
28 natural resources, and the Washington state patrol are exempt from
29 the requirements of (~~subsections (1) through (3) of~~) this section."

30 Correct the title.

EFFECT: Exempts passenger motor vehicles used by the department of agriculture for the purpose of conducting livestock inspections from the requirement that the department of enterprise services own and maintain the state fleet of passenger motor vehicles, from which individual state agencies must obtain motor vehicle transportation services on either a temporary or permanent basis.
