- 5 (1)(a) The joint legislative task force on sexual assault
- 6 forensic examination best practices is established for the purpose
- 7 of reviewing best practice models for managing all aspects of sexual
- 8 assault examinations and for reducing the number of untested sexual
- 9 assault examination kits in Washington state that were collected
- 10 prior to the effective date of this section.
- (i) The caucus leaders from the senate shall appoint one member
- 12 from each of the two largest caucuses of the senate.
- (ii) The caucus leaders from the house of representatives shall
- 14 appoint one member from each of the two largest caucuses of the
- 15 house of representatives.
- 16 (iii) The president of the senate and the speaker of the house
- 17 of representatives shall jointly appoint:
- 18 (A) One member representing each of the following:
- 19 (I) The Washington state patrol;
- 20 (II) The Washington association of sheriffs and police chiefs;
- 21 (III) The Washington association of prosecuting attorneys;
- 22 (IV) The Washington defender association or the Washington
- 23 association of criminal defense lawyers;
- 24 (V) The Washington association of cities;
- 25 (VI) The Washington association of county officials;
- 26 (VII) The Washington coalition of sexual assault programs;
- 27 (VIII) The office of crime victims advocacy;

- 1 (IX) The Washington state hospital association;
- 2 (X) The Washington state forensic investigations council;
- 3 (XI) A public institution of higher education as defined in RCW
- 4 28B.10.016;
- 5 (XII) A private higher education institution as defined in RCW
- 6 28B.07.020; and
- 7 (XIII) The office of the attorney general; and
- 8 (B) Two members representing survivors of sexual assault.
- 9 (b) The task force shall choose two cochairs from among its
- 10 legislative membership. The legislative membership shall convene the
- 11 initial meeting of the task force.
- 12 (2) The duties of the task force include, but are not limited
- 13 to:
- 14 (a) Researching and determining the number of untested sexual
- 15 assault examination kits in Washington state;
- 16 (b) Researching the locations where the untested sexual assault
- 17 examination kits are stored;
- 18 (c) Researching, reviewing, and making recommendations regarding
- 19 legislative policy options for reducing the number of untested
- 20 sexual assault examination kits;
- 21 (d) Researching the best practice models both in state and from
- 22 other states for collaborative responses to victims of sexual
- 23 assault from the point the sexual assault examination kit is
- 24 collected to the conclusion of the investigation and providing
- 25 recommendations regarding any existing gaps in Washington and
- 26 resources that may be necessary to address those gaps; and
- (e) Researching, identifying, and making recommendations for
- 28 securing nonstate funding for testing the sexual assault examination
- 29 kits, and reporting on progress made toward securing such funding.
- 30 (3) Staff support for the task force must be provided by the
- 31 senate committee services and the house of representatives office of
- 32 program research.
- 33 (4) Legislative members of the task force must be reimbursed for
- 34 travel expenses in accordance with RCW 44.04.120. Nonlegislative

- 1 members, except those representing an employer or organization, are
- 2 entitled to be reimbursed for travel expenses in accordance with RCW
- 3 43.03.050 and 43.03.060.
- 4 (5) The expenses of the task force must be paid jointly by the
- 5 senate and the house of representatives. Task force meetings and
- 6 expenditures are subject to approval by the senate facilities and
- 7 operations committee and the house of representatives executive
- 8 rules committee, or their successor committees.
- 9 (6) The first meeting of the task force must occur prior to
- 10 October 1, 2015. The task force shall submit a preliminary report
- 11 regarding its initial findings and recommendations to the
- 12 appropriate committees of the legislature and the governor no later
- 13 than December 1, 2015.
- 14 (7) The task force must meet no less than twice annually.
- 15 (8) The task force shall report its findings and recommendations
- 16 to the appropriate committees of the legislature and the governor by
- 17 September 30, 2016, and by December 1st of the following year.
- 18 (9) This section expires ((<del>June 30, 2018</del>)) June 30, 2019."
