18 (iii) A methodology for comparing the constitutional and 19 statutory obligations of the different types of local governments 20 with the revenues available to each type of local government. This 21 methodology should also include a comparison of the funding levels 22 for the regional services provided by local governments on behalf of 23 the state with state services provided by state agencies;

(iv) A comparison of the regional effect on local governments of court decisions and state policies in the areas of, but not limited to, land ownership, land acquisition patterns, and conservation easements; 1 (v) An assessment of whether the state services provided 2 regionally by local governments on behalf of the state are being 3 provided equitably across the state. This assessment should also 4 include what it would cost the state to provide these services 5 through state agencies rather than local governments; such state 6 services include, but are not limited to, criminal and civil courts, 7 indigent defense, jails, elections, and the collection of taxes; and 8 (vi) Recommendations for how to appropriately distribute 9 existing obligations and revenues between local governments, and 10 between local governments providing regional services on behalf of 11 the state and state agencies.

(b) The report must be in compliance with RCW 43.01.036 and13 provided to the legislature by December 30, 2017.

14 (c) For the purposes of this subsection, "local government" 15 means cities, counties, and special purpose districts."

19 "Sec. 962. RCW 66.08.170 and 2015 3rd sp.s. c 4 s 966 are each
20 amended to read as follows:

21 There shall be a fund, known as the "liquor revolving fund," which 22 shall consist of all license fees, permit fees, penalties, 23 forfeitures, and all other moneys, income, or revenue received by 24 the board. The state treasurer shall be custodian of the fund. All 25 moneys received by the board or any employee thereof, except for 26 change funds and an amount of petty cash as fixed by the board 27 within the authority of law shall be deposited each day in a 28 depository approved by the state treasurer and transferred to the 29 state treasurer to be credited to the liquor revolving fund. During 30 the 2009-2011 fiscal biennium, the legislature may transfer funds 31 from the liquor revolving account [fund] to the state general fund 32 and may direct an additional amount of liquor profits to be 33 distributed to local governments. Neither the transfer of funds nor 34 the additional distribution of liquor profits to local governments

1 during the 2009-2011 fiscal biennium may reduce the excess fund 2 distributions that otherwise would occur under RCW 66.08.190. During 3 the 2011-2013 fiscal biennium, the state treasurer shall transfer 4 from the liquor revolving fund to the state general fund forty-two 5 million five hundred thousand dollars for fiscal year 2012 and 6 forty-two million five hundred thousand dollars for fiscal year 7 2013. The transfer during the 2011-2013 fiscal biennium may not 8 reduce the excess fund distributions that otherwise would occur 9 under RCW 66.08.190. Sales to licensees are exempt from any liquor 10 price increases that may result from the transfer of funds from the 11 liquor revolving fund to the state general fund during the 2011-2013 12 fiscal biennium. Disbursements from the revolving fund shall be on 13 authorization of the board or a duly authorized representative 14 thereof. During the 2017-2019 fiscal biennium, the legislature may 15 also appropriate from the account for local government studies. In 16 order to maintain an effective expenditure and revenue control the 17 liquor revolving fund shall be subject in all respects to chapter 18 43.88 RCW but appropriation shall be required no to permit 19 expenditures and payment of obligations from such fund. During the 20 2013-2015 and 2015-2017 fiscal biennia, the legislature may transfer 21 from the liquor revolving fund to the state general fund such 22 amounts as reflect the excess fund balance of the account."

<u>EFFECT:</u> (1) Requires the Washington State Institution for Public Policy (WSSIP), using funding from the Liquor Revolving Account, to prepare a report to the Legislature by December 30, 2017 regarding: (1) a comparison of the different obligations of counties and cities under statute and under the Washington State Constitution; (2) a comparison of the regional effects of court decisions and state policies on local governments; (3) an assessment of whether state services provided by local governments on behalf of the state are provided equitably across different regions, and (4) recommendations for appropriately distributing obligations and revenues between local governments. (2) Authorizes the Legislature to appropriate moneys from the Liquor Revolving Account for the WSSIP study regarding local governments.
