- 3 (1) The economic development strategic reserve account is created
- 4 in the state treasury to be used only for the purposes of this
- 5 section.
- 6 (2) Only the governor, with the recommendation of the director of
- 7 the department of commerce, may authorize expenditures from the
- 8 account.
- 9 (3) During the 2009-2011 and 2011-2013 fiscal biennia, moneys in
- 10 the account may also be transferred into the state general fund.
- 11 (4) Expenditures from the account may be made to prevent closure
- 12 of a business or facility, to prevent relocation of a business or
- 13 facility in the state to a location outside the state, or to recruit a
- 14 business or facility to the state. Expenditures may be authorized for:
- 15 (a) Workforce development;
- 16 (b) Public infrastructure needed to support or sustain the

EFFECT: Appropriates \$4,000,000 from the Education Legacy Trust Account to the Office of the Superintendent of Public Instruction to implement accounting and information technology changes that enable districts to report programs and activities that are funded by maintenance and operation levies. Transfers \$4,000,000 from the Economic Development Strategic Reserve Account to the Education Legacy Trust Account in the 2017-2019 biennium. Eliminates the \$4,000,000 appropriation from the Economic Development Strategic Reserve Account for the Office of the Governor.

FISCAL IMPACT: No net change to appropriated levels.
