#### **Background:**

All state agencies, institutions of higher education, counties, cities, and towns are required to display the National League of Families' POW/MIA flag along with the flag of the United States, and the state flag on the following days:

• March 30, Welcome Home Vietnam Veterans Day;

- the third Saturday in May, Armed Forces Day;
- the last Monday in May, Memorial Day;
- June 14, Flag Day;
- July 4, Independence Day;
- July 27, National Korean War Veterans Armistice Day;
- the third Friday in September, National POW/MIA Recognition Day; and
- November 11, Veterans' Day.

# **Summary of Bill:**

The bill requires public entities to display the POW/MIA flag on April 9, former POW recognition day and December 7, Pearl Harbor Remembrance Day.

Appropriation: None.

Fiscal Note: Not requested.

**Effective Date**: The bill takes effect 90 days after adjournment of the session in which the bill is passed.

## **Staff Summary of Public Testimony:**

(In support) The flag reminds the public, especially kids, about the significance of service. There are people missing in action from war. We want to raise awareness that rescue efforts are underway.
