## SECOND SUBSTITUTE HOUSE BILL 1280

1 AN ACT Relating to including referred and diverted youth in 2 establishing community juvenile accountability program guidelines; 3 amending RCW 13.40.510; adding a new section to chapter 13.40 RCW; 4 and providing an expiration date.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6 Sec. 1. RCW 13.40.510 and 2010 1st sp.s. c 7 s 62 are each 7 amended to read as follows:

8 (1) In order to receive funds under RCW 13.40.500 through 9 13.40.540, local governments may, through their respective agencies 10 that administer funding for consolidated juvenile services, submit 11 proposals that establish community juvenile accountability programs 12 within their communities. These proposals must be submitted to the 13 juvenile rehabilitation administration of the department of social 14 and health services for certification.

15

(2) The proposals must:

16 (a) Demonstrate that the proposals were developed with the input 17 of the local law and justice councils established under RCW 18 72.09.300;

(b) Describe how local community groups or members are involved in the implementation of the programs funded under RCW 13.40.500 through 13.40.540; 1 (c) Include a description of how the grant funds will contribute 2 to the expected outcomes of the program and the reduction of youth 3 violence and juvenile crime in their community. Data approaches are 4 not required to be replicated if the networks have information that 5 addresses risks in the community for juvenile offenders.

6 (3) A local government receiving a grant under this section shall agree that any funds received must be used efficiently to encourage 7 the use of community-based programs that reduce the reliance on 8 secure confinement as the sole means of holding juvenile offenders 9 accountable for their crimes. The local government shall also agree 10 11 to account for the expenditure of all funds received under the grant 12 and to submit to audits for compliance with the grant criteria developed under RCW 13.40.520. 13

(4) The juvenile rehabilitation administration, in consultation 14 with the Washington association of juvenile court administrators and 15 16 state law and justice advisory council, shall the establish 17 guidelines for programs that may be funded under RCW 13.40.500 18 through 13.40.540. The guidelines must:

19 (a) Target <u>referred and</u> diverted ((and)) <u>youth, as well as</u> 20 adjudicated juvenile offenders;

(b) Include assessment methods to determine services, programs, and intervention strategies most likely to change behaviors and norms of juvenile offenders;

(c) Provide maximum structured supervision in the community.
Programs should use natural surveillance and community guardians such as employers, relatives, teachers, clergy, and community mentors to the greatest extent possible;

(d) Promote good work ethic values and educational skills and competencies necessary for the juvenile offender to function effectively and positively in the community;

31 (e) Maximize the efficient delivery of treatment services aimed 32 at reducing risk factors associated with the commission of juvenile 33 offenses;

34 (f) Maximize the reintegration of the juvenile offender into the 35 community upon release from confinement;

36 (g) Maximize the juvenile offender's opportunities to make full 37 restitution to the victims and amends to the community;

(h) Support and encourage increased court discretion in imposingcommunity-based intervention strategies;

1 (i) Be compatible with research that shows which prevention and 2 early intervention strategies work with juvenile offenders;

3 (j) Be outcome-based in that it describes what outcomes will be 4 achieved or what outcomes have already been achieved;

(k) Include an evaluation component; and

(1) Recognize the diversity of local needs.

7 (5) The state law and justice advisory council may provide 8 support and technical assistance to local governments for training 9 and education regarding community-based prevention and intervention 10 strategies.

11 (6) For purposes of this section and section 2 of this act
12 <u>"referred youth" means a youth who:</u>

13 (a) Was contacted by a law enforcement officer and the law 14 enforcement officer has probable cause to believe that he or she has 15 committed a crime;

16 (b) Was referred to a program that allows youth to enter before 17 being diverted or charged with a juvenile offense; and

18 (c) If not for the program that he or she was referred to, would 19 have been diverted or charged with a juvenile offense.

20 <u>NEW SECTION.</u> Sec. 2. A new section is added to chapter 13.40 21 RCW to read as follows:

(1) The department shall provide an annual report on December 1st to the appropriate committees of the legislature that includes a county by county description of the youth served by the programs funded under RCW 13.40.500 through 13.40.540 including the number of youth in each of those counties who were eligible for programs based on being a referred youth as defined by RCW 13.40.510.

28 (2) This section expires on July 1, 2020.
