1 AN ACT Relating to eliminating various occupational licensure and
2 certification requirements through creation of a state review web
3 site; amending RCW 18.11.050, 18.11.070, 18.11.085, 18.11.095,
4 18.11.160, 18.11.200, 18.11.220, 18.11.240, 18.16.020, 18.16.050,
5 18.16.060, 18.16.130, 18.16.170, 18.16.175, 18.16.190, 18.16.200,
6 18.16.290, 18.96.010, 18.96.020, 18.96.030, 18.240.005, 18.240.010,
7 18.240.020, 67.08.100, 77.65.010, 77.65.480, 77.65.490, 18.92.060,

17 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

18 NEW SECTION. **Sec. 1.** The definitions in this section apply
19 throughout this chapter unless the context clearly requires
20 otherwise.

21 (1) "Department" means the department of licensing.

1 (2) "Registered individual" means an individual performing one or
2 more of the occupations listed in section 2 of this act who has met
3 the registration requirements with Washington effective licensing
4 port.

5 (3) "Washington effective licensing port" means the web site
6 created by the department for purposes of registering individuals
7 working in one or more of the occupations listed in section 2 of this
8 act.

9 NEW SECTION. **Sec. 2.** Any individual working in the state in one
10 or more of the following occupations must have an active registration
11 profile on the Washington effective licensing port web site:

- 12 (1) Animal massage;
- 13 (2) Auctioneer;
- 14 (3) Boxing announcer;
- 15 (4) Food fish or game fishing guide, or both;
- 16 (5) Landscape architect;
- 17 (6) Manicurist; and
- 18 (7) Horse floater.

19 NEW SECTION. **Sec. 3.** The department shall create a
20 comprehensive and user-friendly web site for public comment on and
21 review of all individuals working in one or more of the occupations
22 listed in section 2 of this act. The department may contract with
23 outside vendors and experts to assist in the development of the web
24 site. The web site must allow any individual working in one or more
25 of the occupations in section 2 of this act to register and create a
26 profile that lists business contact information and allows for public
27 comment and review of that individual's service. The web site must
28 also allow any individual working in one or more of the occupations
29 in section 2 of this act who registers and creates a profile on the
30 web site to include information about any training, degrees, or
31 certificates that the individual holds. The department may charge a
32 fee of no more than twenty-five dollars for the individual's first
33 creation of their profile. The web site must allow any member of the
34 public to view postings regarding registered individuals and allow
35 consumers to post reviews of registered individuals. The consumer's
36 post must include a "star" rating on a scale of one to five stars,
37 with five stars being the highest rating of service, and the consumer
38 must be allowed to post additional comments if they choose. Prior to

1 posting a review, the web site should require the consumer to attest
2 that they actually received services from the registered individual
3 and that the information provided in the review is accurate to his or
4 her knowledge. The consumer must attest by checking a box provided on
5 the web site. The web site should include a searchable list of all
6 registered individuals in each occupational category, with links to
7 any enforcement actions by the department. The web site should list
8 contact information for the department so as to facilitate complaints
9 against individuals performing work in the above-referenced
10 occupations that are not registered with Washington effective
11 licensing port.

12 NEW SECTION. **Sec. 4.** (1) The department is authorized to take
13 one or more of the actions listed in subsection (2) of this section
14 in any case in which the department finds that an individual has:

15 (a) Performed work in which he or she should be registered with
16 Washington effective licensing port under section 2 of this act, but
17 failed or refused to comply with the registration requirements; or

18 (b) Failed or refused to post their current star rating in a
19 conspicuous place at their location of business within the previous
20 three hundred sixty-four days. The department shall determine the
21 form of posting of the current star rating.

22 (2) When authorized by subsection (1) of this section, the
23 department may take one or more of the following actions:

24 (a) Refuse to allow the individual to register with Washington
25 effective licensing port;

26 (b) Revoke the individual's registration with Washington
27 effective licensing port;

28 (c) Suspend the individual's registration with Washington
29 effective licensing port until the individual posts their current
30 star rating as required by subsection (1) of this section; or

31 (d) Impose civil penalties of up to one thousand dollars for each
32 violation.

33 **Sec. 5.** RCW 18.11.050 and 1986 c 324 s 2 are each amended to
34 read as follows:

35 Unless the context clearly requires otherwise, the definitions in
36 this section apply throughout this chapter.

37 (1) "Auctioneer" means an individual who calls bids at an
38 auction.

1 (2) "Auction" means a transaction conducted by means of exchanges
2 between an auctioneer and the members of his or her audience,
3 constituting a series of invitations for offers for the purchase of
4 goods or real property made by the auctioneer, offers by members of
5 the audience, and the acceptance of the highest or most favorable
6 offer.

7 (3) "Auction mart" means any fixed or established place designed,
8 intended, or used for the conduct of auctions.

9 (4) "Auction company" means a sole proprietorship, partnership,
10 corporation, or other legal or commercial entity that sells or offers
11 to sell goods or real estate at auction or arranges, sponsors, or
12 manages auctions. The term "auction company" shall exclude any sole
13 proprietorship owned by an auctioneer licensed under this chapter
14 whose gross annual sales do not exceed twenty-five thousand dollars.

16 ~~(6) "Director" means the director of licensing.~~

17 ~~(7))~~ "Person" means an individual, partnership, association,
18 corporation, or any other form of business enterprise.

19 ~~((8))~~ (6) "Goods" means wares, chattels, merchandise, or
20 personal property owned or consigned, which may be lawfully kept or
21 offered for sale.

22 ~~((9) "License" means state authority to operate as an auctioneer
23 or auction company, which authority is conferred by issuance of a
24 certificate of registration subject to annual renewal.~~

25 ~~(10) "Licensee" means an auctioneer or auction company registered
26 under this chapter.)~~

27 **Sec. 6.** RCW 18.11.070 and 1999 c 398 s 1 are each amended to
28 read as follows:

29 (1) It is unlawful for any person to act as an auctioneer or for
30 an auction company to engage in any business in this state without
31 ~~((a license))~~ registering with Washington effective licensing port in
32 accordance with section 2 of this act.

33 (2) This chapter does not apply to:

34 (a) An auction of goods conducted by an individual who personally
35 owns those goods and who did not acquire those goods for resale;

36 (b) An auction conducted by or under the direction of a public
37 authority;

38 (c) An auction held under judicial order in the settlement of a
39 decedent's estate;

1 (d) An auction which is required by law to be at auction;

2 (e) An auction conducted by or on behalf of a political
3 organization or a charitable corporation or association if the person
4 conducting the sale receives no compensation;

5 (f) An auction of livestock or agricultural products which is
6 conducted under chapter 16.65 or 20.01 RCW. Auctions not regulated
7 under chapter 16.65 or 20.01 RCW shall be fully subject to the
8 provisions of this chapter;

9 (g) An auction held under chapter 19.150 RCW;

10 (h) An auction of an abandoned vehicle under chapter 46.55 RCW;
11 or

12 (i) An auction of fur pelts conducted by any cooperative
13 association organized under chapter 23.86 RCW or its wholly owned
14 subsidiary. In order to qualify for this exemption, the fur pelts
15 must be from members of the association. However, the association,
16 without loss of the exemption, may auction pelts that it purchased
17 from nonmembers for the purpose of completing lots or orders, so long
18 as the purchased pelts do not exceed fifteen percent of the total
19 pelts auctioned.

29 ~~has in effect a surety bond or bonds or other security approved by~~
30 ~~the director in the amount that would otherwise be required for an~~
31 ~~auction company to be granted or to retain a license under RCW~~

33 **Sec. 9.** RCW 18.11.160 and 2016 c 81 s 8 are each amended to read
34 as follows:

35 (1) Except as provided in RCW 9.97.020, no ~~((license))~~
36 registration shall be issued by the department to any person who has
37 been convicted of forgery, embezzlement, obtaining money under false
38 pretenses, extortion, criminal conspiracy, fraud, theft, receiving

1 stolen goods, unlawful issuance of checks or drafts, or other similar
2 offense, or to any partnership of which the person is a member, or to
3 any association or corporation of which the person is an officer or
4 in which as a stockholder the person has or exercises a controlling
5 interest either directly or indirectly.

6 (2) In addition to the unprofessional conduct described in RCW
7 18.235.130, the director has the authority to take disciplinary

12 (b) Nonpayment of an administrative fine prior to renewal of a
13 ((license)) registration; and

14 (c) Any other violations of this chapter.

15 (3) The department shall immediately suspend the ((license))
16 registration of a person who has been certified pursuant to RCW
17 74.20A.320 by the department of social and health services as a
18 person who is not in compliance with a support order. If the person
19 has continued to meet all other requirements for reinstatement during
20 the suspension, reissuance of the ((license)) registration shall be
21 automatic upon the department's receipt of a release issued by the
22 department of social and health services stating that the
23 ((licensee)) person is in compliance with the order.

24 **Sec. 10.** RCW 18.11.200 and 2002 c 86 s 211 are each amended to
25 read as follows:

26 The director shall adopt rules for the purpose of carrying out
27 and developing this chapter(~~(, including rules governing the conduct~~
28 ~~of inspections))~~).

29 **Sec. 11.** RCW 18.11.220 and 1987 c 336 s 3 are each amended to
30 read as follows:

31 The client of an auctioneer or auction company has a right to (1)
32 an accounting for any money that the auctioneer or auction company
33 receives from the sale of the client's goods, and (2) payment of all
34 money due to the client within twenty-one calendar days unless the
35 parties have mutually agreed in writing to another time of payment(~~(,~~
36 ~~and (3) bring an action against the surety bond or other security~~
37 ~~filed in lieu of the surety bond for any violation of this chapter or~~
38 ~~the rules adopted pursuant to this chapter))~~).

1 **Sec. 12.** RCW 18.11.240 and 1986 c 324 s 22 are each amended to
2 read as follows:

3 The following requirements shall apply to bidding at auctions:

4 (1) An auctioneer conducting an auction and an auction company
5 where an auction is being held shall not bid on or offer to buy any
6 goods or real property at the auction unless the auctioneer or the
7 auction company discloses the name of the person on whose behalf the
8 bid or offer is being made.

9 (2) An auctioneer and an auction company shall not use any method
10 of bidding at an auction that will allow goods or real property to be
11 purchased in an undisclosed manner on behalf of the auctioneer or
12 auction company.

13 (3) At a public auction conducted or supervised by an auctioneer
14 or auction company, the auctioneer or auction company shall not
15 fictitiously raise any bid, knowingly permit any person to make a
16 fictitious bid, or employ or use another person to act as a bidder or
17 buyer.

18 (4) All goods or real property offered for sale at an auction
19 shall be subject to a reserve or a confirmation from the owner or
20 consignor unless otherwise indicated by the auctioneer or auction
21 company. Except as provided in this subsection, an auctioneer or
22 auction company shall not use any method of bidding at an auction
23 that allows the auctioneer or auction company to avoid selling any
24 property offered for sale at auction.

25 (5) (~~A licensee~~) An individual registered with Washington
26 effective licensing port who violates any provision of this section
27 shall be subject to an administrative fine in a sum not exceeding
28 five hundred dollars for each violation.

29 **Sec. 13.** RCW 18.16.020 and 2015 c 62 s 1 are each amended to
30 read as follows:

31 As used in this chapter, the following terms have the meanings
32 indicated unless the context clearly requires otherwise:

33 (1) "Apprentice" means a person who is engaged in a state-
34 approved apprenticeship program and who must receive a wage or
35 compensation while engaged in the program.

36 (2) "Apprentice monthly report" means the apprentice record of
37 daily activities and the number of hours completed in each course of
38 a curriculum that is prepared monthly by the approved apprenticeship
39 program and provided to the apprentice, audited annually by the

1 department, and kept on file by the approved apprenticeship program
2 for three years.

3 (3) "Apprentice trainer" means a person who gives training to an
4 apprentice in an approved apprenticeship program and who is approved
5 under RCW 18.16.280.

6 (4) "Apprenticeship program" means a state-approved
7 apprenticeship program pursuant to chapter 49.04 RCW and approved
8 under RCW 18.16.280 for the training of cosmetology, hair design,
9 barbering, esthetics, and master esthetics(~~(, and manieuring)~~)).

10 (5) "Apprenticeship training committee" means a committee
11 approved by the Washington apprenticeship and training council
12 established in chapter 49.04 RCW.

13 (6) "Approved apprenticeship shop" means a salon/shop that has
14 been approved under RCW 18.16.280 and chapter 49.04 RCW to
15 participate in an apprenticeship program.

16 (7) "Approved security" means surety bond.

17 (8) "Barber" means a person licensed under this chapter to engage
18 in the practice of barbering.

19 (9) "Board" means the cosmetology, hair design, barbering, and
20 esthetics(~~(, and manieuring)~~) advisory board.

21 (10) "Cosmetologist" means a person licensed under this chapter
22 to engage in the practice of cosmetology.

23 (11) "Crossover training" means training approved by the director
24 as training hours that may be credited to current licensees for
25 similar training received in another profession licensed under this
26 chapter.

27 (12) "Curriculum" means the courses of study taught at a school,
28 online training by a school, in an approved apprenticeship program
29 established by the Washington state apprenticeship and training
30 council and conducted in an approved salon/shop, or online training
31 by an approved apprenticeship program, set by rule under this
32 chapter, and approved by the department. After consulting with the
33 board, the director may set by rule a percentage of hours in a
34 curriculum, up to a maximum of ten percent, that could include hours
35 a student receives while training in a salon/shop under a contract
36 approved by the department. Each curriculum must include at least the
37 following required hours:

38 (a) School curriculum:

39 (i) Cosmetologist, one thousand six hundred hours;

40 (ii) Hair design, one thousand four hundred hours;

1 (iii) Barber, one thousand hours;
2 (iv) (~~(Manicurist, six hundred hours;~~

8 (vi) (~~(vii))~~) Instructor-trainee, five hundred hours, except
9 that an instructor-trainee may submit documentation that provides
10 evidence of experience as a licensed cosmetologist, hair designer,
11 barber, (~~(manicurist,))~~) esthetician, or master esthetician for
12 competency evaluation toward credit of not more than three hundred
13 hours of instructor-training.
14 (b) Apprentice training curriculum:
15 (i) Cosmetologist, two thousand hours;
16 (ii) Hair design, one thousand seven hundred fifty hours;
17 (iii) Barber, one thousand two hundred hours;
18 (iv) (~~(Manicurist, eight hundred hours;~~
19 ~~(v))~~) Esthetician, eight hundred hours;
20 (~~(vi))~~) (v) Master esthetician, one thousand four hundred hours.
21 (13) "Department" means the department of licensing.
22 (14) "Director" means the director of the department of licensing
23 or the director's designee.
24 (15) "Esthetician" means a person licensed under this chapter to
25 engage in the practice of esthetics.
26 (16) "Hair design" means the practice of arranging, dressing,
27 cutting, trimming, styling, shampooing, permanent waving, chemical
28 relaxing, straightening, curling, bleaching, lightening, coloring,
29 mustache and beard design, and superficial skin stimulation of the
30 scalp.
31 (17) "Hair designer" means a person licensed under this chapter
32 to engage in the practice of hair design.
33 (18) "Individual license" means a cosmetology, hair design,
34 barber, (~~(manicurist,))~~) esthetician, master esthetician, or
35 instructor license issued under this chapter.
36 (19) "Instructor" means a person who gives instruction in a
37 school, or who provides classroom theory training to apprentices in
38 locations other than in a school, in a curriculum in which he or she
39 holds a license under this chapter, has completed at least five
40 hundred hours of instruction in teaching techniques and lesson

1 planning in a school, or who has documented experience as an
2 instructor for more than five hundred hours in another state in the
3 curriculum of study, and has passed a licensing examination approved
4 or administered by the director. An applicant who holds a degree in
5 education from an accredited postsecondary institution shall upon
6 application be licensed as an instructor to give instruction in a
7 school, or to provide classroom theory training to apprentices in
8 locations other than in a school, in a curriculum in which he or she
9 holds a license under this chapter. An applicant who holds an
10 instructional credential from an accredited community or technical
11 college and who has passed a licensing examination approved or
12 administered by the director shall upon application be licensed as an
13 instructor to give instruction in a school, or to provide classroom
14 theory training to apprentices in locations other than in a school,
15 in a curriculum in which he or she holds a license under this
16 chapter. To be approved as an "instructor" in an approved
17 apprenticeship program, the instructor must be a competent instructor
18 as defined in rules adopted under chapter 49.04 RCW.

19 (20) "Instructor-trainee" means a person who is currently
20 licensed in this state as a cosmetologist, hair designer, barber,
21 (~~(manicurist,)~~) esthetician, or master esthetician, and is enrolled
22 in an instructor-trainee curriculum in a school licensed under this
23 chapter.

24 (21) "Location license" means a license issued under this chapter
25 for a salon/shop, school, personal services, or mobile unit.

26 (22) (~~("Manicurist" means a person licensed under this chapter to~~
27 ~~engage in the practice of manicuring.~~

28 ~~(23))~~ "Master esthetician" means a person licensed under this
29 chapter to engage in the practice of master esthetics.

30 (~~(24))~~ (23) "Mobile unit" is a location license under this
31 chapter where the practice of cosmetology, barbering, esthetics, or
32 master esthetics(~~(, or manicuring)~~) is conducted in a mobile
33 structure. Mobile units must conform to the health and safety
34 standards set by rule under this chapter.

35 (~~(25))~~ (24) "Online training" means theory training provided
36 online, by a school licensed under this chapter or an approved
37 apprenticeship program established by the Washington state
38 apprenticeship and training council, in the areas of cosmetology,
39 hair design, master esthetics, (~~(manicuring,)~~) barbering, esthetics,
40 and instructor-training.

1 ~~((+26+))~~ (25) "Person" means any individual, partnership,
2 professional service corporation, joint stock association, joint
3 venture, or any other entity authorized to do business in this state.

4 ~~((+27+))~~ (26) "Personal services" means a location licensed under
5 this chapter where the practice of cosmetology, hair design,
6 barbering, manicuring, esthetics, or master esthetics is performed
7 for clients in the client's home, office, or other location that is
8 convenient for the client.

9 ~~((+28+))~~ (27) "Practice of barbering" means the cutting,
10 trimming, arranging, dressing, curling, shampooing, shaving, and
11 mustache and beard design of the hair of the face, neck, and scalp.

12 ~~((+29+))~~ (28) "Practice of cosmetology" means arranging,
13 dressing, cutting, trimming, styling, shampooing, permanent waving,
14 chemical relaxing, straightening, curling, bleaching, lightening,
15 coloring, waxing, tweezing, shaving, and mustache and beard design of
16 the hair of the face, neck, and scalp; temporary removal of
17 superfluous hair by use of depilatories, waxing, or tweezing;
18 ~~((manicuring and pedicuring, limited to cleaning, shaping, polishing,
19 decorating, and caring for and treatment of the cuticles and nails of
20 the hands and feet, excluding the application and removal of
21 sculptured or otherwise artificial nails;))~~ esthetics limited to
22 toning the skin of the scalp, stimulating the skin of the body by the
23 use of preparations, tonics, lotions, or creams; and tinting
24 eyelashes and eyebrows.

25 ~~((+30+))~~ (29) "Practice of esthetics" means the care of the skin
26 for compensation by application, use of preparations, antiseptics,
27 tonics, essential oils, exfoliants, superficial and light peels, or
28 by any device, except laser, or equipment, electrical or otherwise,
29 or by wraps, compresses, cleansing, conditioning, stimulation,
30 superficial skin stimulation, pore extraction, or product application
31 and removal; temporary removal of superfluous hair by means of
32 lotions, creams, appliance, waxing, threading, tweezing, or
33 depilatories, including chemical means; and application of product to
34 the eyelashes and eyebrows, including extensions, design and
35 treatment, tinting and lightening of the hair, excluding the scalp.
36 Under no circumstances does the practice of esthetics include the
37 administration of injections.

39 shaping, polishing, decorating, and caring for and treatment of the
40 cuticles and the nails of the hands or feet, and the application and

1 removal of sculptured or otherwise artificial nails by hand or with
2 mechanical or electrical apparatus or appliances.

3 ~~((32))~~ (31) "Practice of master esthetics" means the care of
4 the skin for compensation including all of the methods allowed in the
5 definition of the practice of esthetics. It also includes the
6 performance of medium depth peels and the use of medical devices for
7 care of the skin and permanent hair reduction. The medical devices
