1 AN ACT Relating to open educational resources; adding a new  
2 section to chapter 28B.10 RCW; and creating a new section.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 NEW SECTION. **Sec. 1.** A new section is added to chapter 28B.10  
5 RCW to read as follows:

6 (1) The definitions in this subsection apply throughout this  
7 section unless the context clearly requires otherwise.

8 (a) "Campus coordinator" means a designated facilitator to  
9 promote, assist, and support the creation of open educational  
10 resources by establishing and coordinating training seminars,  
11 creating workshops, helping faculty and staff identify available  
12 resources and funding, and cataloging and evaluating open educational  
13 resources used or created by an institution of higher education's  
14 faculty.

15 (b) "Open educational resources" means freely accessible, openly  
16 licensed educational textbooks, documents, materials, and media that  
17 reside in the public domain for free use and repurposing for the  
18 intention of teaching, learning, assessing, and researching.

19 (2)(a) Subject to availability of amounts appropriated for this  
20 specific purpose, the student achievement council shall administer  
21 the open educational resources grant pilot program for the four-year

1 institutions of higher education. A grant received under the pilot  
2 program must be used for either (a)(i) or (ii) of this subsection, or  
3 both:

4 (i) Create a designated campus coordinator who will be the campus  
5 lead and centralized contact regarding open educational resources; or

6 (ii) Support faculty to adopt or create open educational  
7 resources for the purpose of reducing students' cost of attendance.

8 (b) The student achievement council shall develop an application  
9 form for the grant, a process for reviewing and selecting grant  
10 applicants, a process for awarding grant funding, and a process for  
11 the grant awardee to report back to the student achievement council  
12 on the use of the grant. The student achievement council shall  
13 prioritize applications that estimate the highest cost reduction to  
14 students, whether it be on an individual basis or across a field of  
15 study or the institution.

16 (c) The student achievement council shall determine how many  
17 grants may be awarded based on the funding received for the pilot  
18 program.

19 (d) In addition to the grant program, the student achievement  
20 council shall conduct outreach to other states and higher education  
21 agencies to identify whether there is interest in establishing a  
22 multistate open educational resources network to facilitate and  
23 establish a platform for peer review, coordinating, and sharing of  
24 open educational resources.

25 (e) The student achievement council shall report to the  
26 appropriate committees of the legislature in accordance with the  
27 reporting requirements in RCW 43.01.036 by December 1, 2018, on the  
28 open educational resources grant pilot program and on the outreach  
29 conducted regarding a multistate open educational resources network.  
30 The report must include information on the number of grant  
31 applications received, the number of grants awarded, and an  
32 evaluation of how the grants were used to expand the use of open  
33 educational resources. In addition, the report must include how the  
34 student achievement council conducted outreach to other states on the  
35 concept of a multistate open educational resources network and the  
36 feedback from those states.

37 (3) By December 1, 2018, the Washington state institute for  
38 public policy shall conduct a study on the cost of textbooks and  
39 course materials and the use of open educational resources at four-  
40 year institutions of higher education across the state and submit a

1 report to the appropriate committees of the legislature in accordance  
2 with RCW 43.01.036. To the extent data are available, the study  
3 should address:

4 (a) The types of and average cost per student for required  
5 textbooks and course materials, including digital access codes and  
6 bundled items, in the state, at each four-year institution of higher  
7 education, and in specific degree programs;

8 (b) The use of open educational resources at four-year  
9 institutions of higher education and in specific degree programs or  
10 courses, or both; and

11 (c) Any other information regarding textbooks, course materials,  
12 or open educational resources that the Washington state institute for  
13 public policy deems relevant.

14 NEW SECTION. **Sec. 2.** If specific funding for the purposes of  
15 this act, referencing this act by bill or chapter number, is not  
16 provided by June 30, 2017, in the omnibus appropriations act, this  
17 act is null and void.
