AN ACT Relating to providing flexibility in high school 1 2 graduation requirements and supporting student success during the 3 transition federal every student succeeds to а act-compliant amending 28A.655.061, 4 accountability system; RCW 28A.655.065, 28A.305.130, 28A.230.090, 28A.655.061, and 28A.655.068; creating a 5 new section; and declaring an emergency. 6

7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

8 Sec. 1. RCW 28A.655.061 and 2017 3rd sp.s. c ... s 5 (section 5 9 of this act) are each amended to read as follows:

(1) The high school assessment system shall include but need not 10 11 be limited to the statewide student assessment, opportunities for a student to retake the content areas of the assessment in which the 12 student was not successful, and, if approved by the legislature 13 14 pursuant to subsection (10) of this section, one or more objective alternative assessments for a student to demonstrate achievement of 15 state academic standards. The objective alternative assessments for 16 each content area shall be comparable in rigor to the skills and 17 knowledge that the student must demonstrate on the statewide student 18 19 assessment for each content area.

20 (2) Subject to the conditions in this section, a certificate of 21 academic achievement shall be obtained and is evidence that the students have successfully met the state standard in the content areas included in the certificate. With the exception of students satisfying the provisions of RCW 28A.155.045 or 28A.655.0611, acquisition of the certificate is required for graduation from a public high school but is not the only requirement for graduation.

6 (3)(a) Beginning with the graduating class of 2008 through the graduating class of 2015, with the exception of students satisfying 7 the provisions of RCW 28A.155.045, a student who meets the state 8 standards on the ((reading, writing,)) English language arts and 9 mathematics high school statewide student assessment shall earn a 10 certificate of academic achievement. The mathematics assessment shall 11 12 be the end-of-course assessment for the first year of high school mathematics that assesses the standards common to algebra I and 13 integrated mathematics I or the end-of-course assessment for the 14 second year of high school mathematics that assesses standards common 15 16 to geometry and integrated mathematics II.

(b) As the state transitions from reading and writing assessments to an English language arts assessment and from end-of-course assessments to a comprehensive assessment for high school mathematics, a student in a graduating class of 2016 through 2018 shall earn a certificate of academic achievement if the student meets the ((state)) high school graduation standard as follows:

23 (i) Students in the graduating class of 2016 may use the results 24 from:

(A) The reading and writing assessment or the English language
 arts assessment developed with the multistate consortium; and

(B) The end-of-course assessment for the first year of high school mathematics, the end-of-course assessment for the second year of high school mathematics, or the comprehensive mathematics assessment developed with the multistate consortium.

31 (ii) Students in the graduating classes of 2017 and 2018 may use 32 the results from:

33 (A) The tenth grade English language arts assessment developed by 34 the superintendent of public instruction using resources from the 35 multistate consortium or the English language arts assessment 36 developed with the multistate consortium; and

37 (B) The end-of-course assessment for the first year of high 38 school mathematics, the end-of-course assessment for the second year 39 of high school mathematics, or the comprehensive mathematics 40 assessment developed with the multistate consortium.

1 (c) Beginning with the graduating class of 2019, a student who 2 meets the ((state)) <u>high school graduation</u> standard((s)) on the high 3 school English language arts assessment developed with the multistate 4 consortium and the comprehensive mathematics assessment developed 5 with the multistate consortium shall earn a certificate of academic 6 achievement.

7 (d) <u>Beginning with the graduating class of 2020, a student who</u> 8 <u>meets the high school graduation standard on the high school English</u> 9 <u>language arts assessment developed with the multistate consortium and</u> 10 <u>the comprehensive mathematics assessment developed with the</u> 11 <u>multistate consortium to be administered in tenth grade shall earn a</u> 12 <u>certificate of academic achievement.</u>

(e) If a student does not successfully meet the state standards 13 in one or more content areas required for the certificate of academic 14 achievement, then the student may retake the assessment in the 15 16 content area at least twice a year at no cost to the student. If the 17 student successfully meets the state standards on a retake of the assessment then the student shall earn a certificate of academic 18 achievement. Once objective alternative assessments are authorized 19 pursuant to subsection (10) of this section, a student may use the 20 21 objective alternative assessments to demonstrate that the student successfully meets the state standards for that content area if the 22 student has taken the statewide student assessment at least once. If 23 the student successfully meets the state standards on the objective 24 25 alternative assessments then the student shall earn a certificate of 26 academic achievement.

(4) Beginning with the graduating class of 2021, a student must 27 meet the state standards in science in addition to the other content 28 areas required under subsection (3) of this section on the statewide 29 student assessment, a retake, or the objective alternative 30 31 assessments in order to earn a certificate of academic achievement. 32 The assessment under this subsection must be a comprehensive assessment of the science essential academic learning requirements 33 adopted by the superintendent of public instruction in 2013. 34

35 (5) The state board of education may not require the acquisition 36 of the certificate of academic achievement for students in home-based 37 instruction under chapter 28A.200 RCW, for students enrolled in 38 private schools under chapter 28A.195 RCW, or for students satisfying 39 the provisions of RCW 28A.155.045.

1 (6) A student may retain and use the highest result from each successfully completed content area of the high school assessment. 2

3 (7) School districts must make available to students the following options: 4

(a) To retake the statewide student assessment at least twice a 5 б year in the content areas in which the student did not meet the state standards if the student is enrolled in a public school; or 7

(b) To retake the statewide student assessment at least twice a 8 year in the content areas in which the student did not meet the state 9 standards if the student is enrolled in a high school completion 10 11 program at a community or technical college. The superintendent of 12 public instruction and the state board for community and technical colleges shall jointly identify means by which students in these 13 14 programs can be assessed.

(8) Students who achieve the standard in a content area of the 15 16 high school assessment but who wish to improve their results shall 17 pay for retaking the assessment, using a uniform cost determined by the superintendent of public instruction. 18

(9) Opportunities to retake the assessment at least twice a year 19 shall be available to each school district. 20

21 (10)(a) The office of the superintendent of public instruction develop options for implementing objective alternative 22 shall assessments, which may include an appeals process for students' 23 scores, for students to demonstrate achievement of the state academic 24 25 standards. The objective alternative assessments shall be comparable 26 in rigor to the skills and knowledge that the student must demonstrate on the statewide student assessment and be objective in 27 its determination of student achievement of the state standards. 28 Before any objective alternative assessments in addition to those 29 authorized in RCW 28A.655.065 or (b) of this subsection are used by a 30 31 student to demonstrate that the student has met the state standards in a content area required to obtain a certificate, the legislature 32 shall formally approve the use of any objective alternative 33 assessments through the omnibus appropriations act or by statute or 34 concurrent resolution. 35

36 (b)(i) A student's score on the mathematics, reading or English, or writing portion of the SAT or the ACT may be used as an objective 37 alternative assessment under this section for demonstrating that a 38 39 student has met or exceeded the state standards for the certificate 40 of academic achievement. The state board of education shall identify

1 the scores students must achieve on the relevant portion of the SAT or ACT to meet or exceed the state standard in the relevant content 2 area on the statewide student assessment. A student's score on the 3 science portion of the ACT or the science subject area tests of the 4 SAT may be used as an objective alternative assessment under this 5 б section as soon as the state board of education determines that 7 sufficient data is available to identify reliable equivalent scores for the science content area of the statewide student assessment. 8 After the first scores are established, the state board may increase 9 but not decrease the scores required for students to meet or exceed 10 11 the state standards.

12 (ii) A student who scores at least a three on the grading scale of one to five for selected AP examinations may use the score as an 13 objective alternative assessment under this section for demonstrating 14 that a student has met or exceeded state standards for the 15 16 certificate of academic achievement. A score of three on the AP 17 examinations in calculus or statistics may be used as an alternative 18 assessment for the mathematics portion of the statewide student 19 assessment. A score of three on the AP examinations in English language and composition may be used as an alternative assessment for 20 the writing portion of the statewide student assessment; and for the 21 English language arts portion of the assessment developed with the 22 multistate consortium, once established in the 2014-15 school year. A 23 score of three on the AP examinations in English literature and 24 25 composition, macroeconomics, microeconomics, psychology, United States history, world history, United States government and politics, 26 or comparative government and politics may be used as an alternative 27 28 for the reading portion of the statewide assessment student 29 assessment; and for the English language arts portion of the assessment developed with the multistate consortium, once established 30 31 in the 2014-15 school year. A score of three on the AP examination in 32 biology, physics, chemistry, or environmental science may be used as an alternative assessment for the science portion of the statewide 33 student assessment. 34

(iii) A student who scores at least a four on selected externally administered international baccalaureate (IB) examinations may use the score as an objective alternative assessment under this section for demonstrating that the student has met or exceeded state standards for the certificate of academic achievement. A score of four on the higher level IB examinations for any of the IB English

1 language and literature courses or for any of the IB individuals and societies courses may be used as an alternative assessment for the 2 3 reading, writing, or English language arts portions of the statewide 4 student assessment. A score of four on the higher level IΒ examinations for any of the IB mathematics courses may be used as an 5 б alternative assessment for the mathematics portion of the statewide student assessment. A score of four on 7 the higher level IΒ examinations for IB biology, chemistry, or physics may be used as an 8 alternative assessment for the science portion of the statewide 9 10 student assessment.

(iv)(A) Beginning in the 2018-19 school year, high school 11 12 students who have not earned a certificate of academic achievement due to not meeting the high school graduation standard on the 13 mathematics or English language arts assessment may take and pass a 14 15 locally determined course in the content area in which the student was not successful, and may use the passing score on a locally 16 17 administered assessment tied to that course and approved under the provisions of this subsection (10)(b)(iv), as an objective 18 19 alternative assessment for demonstrating that the student has met or exceeded the high school graduation standard. High school transition 20 courses and the assessments offered in association with high school 21 22 transition courses shall be considered an approved locally determined 23 course and assessment for demonstrating that the student met or exceeded the high school graduation standard. The course must be 24 25 rigorous and consistent with the student's educational and career goals identified in his or her high school and beyond plan, and may 26 include career and technical education equivalencies in English 27 28 language arts or mathematics adopted pursuant to RCW 28A.230.097. School districts shall record students' participation in locally 29 30 determined courses under this section in the statewide individual 31 data system.

(B) The office of the superintendent of public instruction shall 32 develop a process by which local school districts can submit 33 34 assessments for review and approval for use as objective alternative assessments for graduation as allowed by (b)(iv) of this subsection. 35 This process shall establish means to determine whether a local 36 school district-administered assessment is comparable in rigor to the 37 skills and knowledge that the student must demonstrate on the 38 39 statewide student assessment and is objective in its determination of 40 student achievement of the state standards. The office of the 1 superintendent of public instruction shall post on its agency web
2 site a compiled list of local school district-administered
3 assessments approved as objective alternative assessments, including
4 the comparable scores on these assessments necessary to meet the
5 standard.

б (C) For the purpose of this section, "high school transition 7 course" means an English language arts or mathematics course offered in high school where successful completion by a high school student 8 ensures the student college-level placement at participating 9 10 institutions of higher education as defined in RCW 28B.10.016. High school transition courses must, in accordance with this section, 11 satisfy core or elective credit graduation requirements established 12 by the state board of education. A student's successful completion of 13 a high school transition course does not entitle the student to be 14 admitted to any institution of higher education as defined in RCW 15 16 28B.10.016.

17 <u>(v) A student who completes a dual credit course in English</u> 18 <u>language arts or mathematics in which the student earns college</u> 19 <u>credit may use passage of the course as an objective alternative</u> 20 <u>assessment under this section for demonstrating that the student has</u> 21 <u>met or exceeded the high school graduation standard for the</u> 22 <u>certificate of academic achievement.</u>

(11) To help assure continued progress in academic achievement as a foundation for high school graduation and to assure that students are on track for high school graduation, each school district shall:

(a) Provide students who have not earned a certificate of 26 academic achievement before the beginning of grade eleven with the 27 28 opportunity to access interventions and academic supports, courses, or both, designed to enable students to meet the high school 29 graduation standard. These interventions, supports, or courses must 30 31 be rigorous and consistent with the student's educational and career 32 goals identified in his or her high school and beyond plan, and may include career and technical education equivalencies in English 33 34 language arts or mathematics adopted pursuant to RCW 28A.230.097; and

35 (b) Prepare student learning plans ((for)) and notify students 36 and their parents or legal guardians as provided in this subsection. 37 Student learning plans are required for eighth grade students who 38 were not successful on any or all of the content areas of the state 39 assessment during the previous school year or who may not be on track 40 to graduate due to credit deficiencies or absences. The parent or legal guardian shall be notified about the information in the student learning plan, preferably through a parent conference and at least annually. To the extent feasible, schools serving English language learner students and their parents shall translate the plan into the primary language of the family. The plan shall include the following information as applicable:

(((a))) <u>(i)</u> The student's results on the state assessment;

8 (((b))) <u>(ii)</u> If the student is in the transitional bilingual 9 program, the score on his or her Washington language proficiency test 10 II;

11 ((((c))) (iii) Any credit deficiencies;

12 (((d))) (iv) The student's attendance rates over the previous two 13 years;

14 ((((e)))) <u>(v)</u> The student's progress toward meeting state and local 15 graduation requirements;

16 (((f))) <u>(vi)</u> The courses, competencies, and other steps needed to 17 be taken by the student to meet state academic standards and stay on 18 track for graduation;

19 (((g))) <u>(vii)</u> Remediation strategies and alternative education 20 options available to students, including informing students of the 21 option to continue to receive instructional services after grade 22 twelve or until the age of twenty-one;

23 (((h))) <u>(viii)</u> The alternative assessment options available to 24 students under this section and RCW 28A.655.065;

25 (((i))) (ix) School district programs, high school courses, and 26 career and technical education options available for students to meet 27 graduation requirements; and

28 $(((\frac{j})))$ (x) Available programs offered through skill centers or 29 community and technical colleges, including the college high school 30 diploma options under RCW 28B.50.535.

31 **Sec. 2.** RCW 28A.655.065 and 2009 c 556 s 19 are each amended to 32 read as follows:

(1) The legislature has made a commitment to rigorous academic standards for receipt of a high school diploma. The primary way that students will demonstrate that they meet the standards in reading, writing, mathematics, and science is through the ((Washington)) statewide student assessment ((of student learning)). Only objective assessments that are comparable in rigor to the state assessment are authorized as an alternative assessment. Before seeking an

1 alternative assessment, the legislature expects students to make a 2 genuine effort to meet state standards, through regular and 3 consistent attendance at school and participation in extended 4 learning and other assistance programs.

(2) Under RCW 28A.655.061, beginning in the 2006-07 school year, 5 6 the superintendent of public instruction shall implement objective 7 alternative assessment methods as provided in this section for students to demonstrate achievement of the state standards in content 8 areas in which the student has not yet met the standard on the high 9 school ((Washington)) statewide student assessment ((of student 10 11 learning)). A student may access an alternative if the student meets 12 applicable eligibility criteria in RCW 28A.655.061 and this section and other eligibility criteria established by the superintendent of 13 public instruction, including but not limited to attendance criteria 14 and participation in the remediation or supplemental instruction 15 16 contained in the student learning plan developed under RCW 17 28A.655.061. A school district may waive attendance and/or remediation criteria for special, unavoidable circumstances. 18

19 (3) For the purposes of this section, "applicant" means a student 20 seeking to use one of the alternative assessment methods in this 21 section.

(4) One alternative assessment method shall be a combination of 22 the applicant's grades in applicable courses and the applicant's 23 highest score on the high school ((Washington)) statewide student 24 25 assessment ((of student learning)), as provided in this subsection. A student is eligible to apply for the alternative assessment method 26 under this subsection (4) if the student has a cumulative grade point 27 28 average of at least 3.2 on a four point grading scale. The superintendent of public instruction shall determine which high 29 school courses are applicable to the alternative assessment method 30 31 and shall issue guidelines to school districts.

32 (a) Using guidelines prepared by the superintendent of public instruction, a school district shall identify the group of students 33 in the same school as the applicant who took the same high school 34 courses as the applicant in the applicable content area. From the 35 group of students identified in this manner, the district shall 36 select the comparison cohort that shall be those students who met or 37 slightly exceeded the state standard on the ((Washington)) statewide 38 39 student assessment ((of student learning)).

1 (b) The district shall compare the applicant's grades in high 2 school courses in the applicable content area to the grades of 3 students in the comparison cohort for the same high school courses. 4 If the applicant's grades are equal to or above the mean grades of 5 the comparison cohort, the applicant shall be deemed to have met the 6 state standard on the alternative assessment.

7 (c) An applicant may not use the alternative assessment under 8 this subsection (4) if there are fewer than six students in the 9 comparison cohort.

10 (5) ((The superintendent of public instruction shall develop an 11 alternative assessment method that shall be an evaluation of a 12 collection of work samples prepared and submitted by the applicant. 13 Effective September 1, 2009, collection of work samples may be 14 submitted only in content areas where meeting the state standard on 15 the high school assessment is required for purposes of graduation.

16 (a) The superintendent of public instruction shall develop 17 guidelines for the types and number of work samples in each content area that may be submitted as a collection of evidence that the 18 applicant has met the state standard in that content area. Work 19 samples may be collected from academic, career and technical, or 20 remedial courses and may include performance tasks as well as written 21 products. The superintendent shall submit the quidelines for approval 22 23 by the state board of education.

(b) The superintendent shall develop protocols for submission of the collection of work samples that include affidavits from the applicant's teachers and school district that the samples are the work of the applicant and a requirement that a portion of the samples be prepared under the direct supervision of a classroom teacher. The superintendent shall submit the protocols for approval by the state beard of education.

31 (c) The superintendent shall develop uniform scoring criteria for 32 evaluating the collection of work samples and submit the scoring criteria for approval by the state board of education. Collections 33 shall be scored at the state level or regionally by a panel of 34 educators selected and trained by the superintendent to ensure 35 objectivity, reliability, and rigor in the evaluation. An educator 36 37 may not score work samples submitted by applicants from the educator's school district. If the panel awards an applicant's 38 39 collection of work samples the minimum required score, the applicant

1 shall be deemed to have met the state standard on the alternative

2 assessment.

3 (d) Using an open and public process that includes consultation with district superintendents, school principals, and other 4 educators, the state board of education shall consider the 5 guidelines, protocols, scoring criteria, and other information 6 regarding the collection of work samples submitted by the 7 superintendent of public instruction. The collection of work samples 8 may be implemented as an alternative assessment after the state board 9 10 of education has approved the guidelines, protocols, and scoring criteria and determined that the collection of work samples: (i) Will 11 meet professionally accepted standards for a valid and reliable 12 measure of the grade level expectations and the essential academic 13 learning requirements; and (ii) is comparable to or exceeds the rigor 14 15 of the skills and knowledge that a student must demonstrate on the 16 Washington assessment of student learning in the applicable content 17 area. The state board shall make an approval decision and determination no later than December 1, 2006, and thereafter may 18 increase the required rigor of the collection of work samples. 19

(e) By September of 2006, the superintendent of public 20 21 instruction shall develop informational materials for parents, teachers, and students regarding the collection of work samples and 22 the status of its development as an alternative assessment method. 23 24 The materials shall provide specific guidance regarding the type and 25 number of work samples likely to be required, include examples of work that meets the state learning standards, and describe the 26 27 scoring criteria and process for the collection. The materials shall 28 also encourage students in the graduating class of 2008 to begin creating a collection if they believe they may seek to use the 29 30 collection once it is implemented as an alternative assessment.

31 (6)(a) For students enrolled in a career and technical education 32 program approved under RCW 28A.700.030, the superintendent of public 33 instruction shall develop additional guidelines for collections of 34 work samples that are tailored to different career and technical 35 programs. The additional guidelines shall:

36 (i) Provide multiple examples of work samples that are related to 37 the particular career and technical program;

38 (ii) Permit work samples based on completed activities or 39 projects where demonstration of academic knowledge is inferred; and (iii) Provide multiple examples of work samples drawn from career
 and technical courses.

3 (b) The purpose of the additional guidelines is to provide a clear pathway toward a certificate of academic achievement for career 4 and technical students by showing them applied and relevant 5 opportunities to demonstrate their knowledge and skills, and to 6 provide quidance to teachers in integrating academic and career and 7 technical instruction and assessment and assisting career and 8 technical students in compiling a collection. The superintendent of 9 10 public instruction shall develop and disseminate additional quidelines for no fewer than ten career and technical education 11 12 programs representing a variety of program offerings by no later than September 1, 2008. Guidelines for ten additional programs shall be 13 developed and disseminated no later than June 1, 2009. 14

15 (c) The superintendent shall consult with community and technical 16 colleges, employers, the workforce training and education 17 coordinating board, apprenticeship programs, and other regional and 18 national experts in career and technical education to create 19 appropriate guidelines and examples of work samples and other 20 evidence of a career and technical student's knowledge and skills on 21 the state academic standards.

22 (7) The superintendent of public instruction shall study the 23 feasibility of using existing mathematics assessments in languages 24 other than English as an additional alternative assessment option. 25 The study shall include an estimation of the cost of translating the 26 tenth grade mathematics assessment into other languages and scoring 27 the assessments should they be implemented.

(8))) The superintendent of public instruction shall implement:

(a) By June 1, 2006, a process for students to appeal the score
 they received on the high school assessments; ((and))

(b) By January 1, 2007, guidelines and appeal processes for waiving specific requirements in RCW 28A.655.061 pertaining to the certificate of academic achievement and to the certificate of individual achievement for students who: (i) Transfer to a Washington public school in their junior or senior year with the intent of obtaining a public high school diploma, or (ii) have special, unavoidable circumstances<u>;</u>

38 (c)(i) For the graduating classes of 2014, 2015, 2016, 2017, and 39 2018, an expedited appeal process for waiving specific requirements 40 in RCW 28A.655.061 pertaining to the certificate of academic

achievement and the certificate of individual achievement for 1 eligible students who have not met the state standard on the English 2 language arts statewide student assessment, the mathematics high 3 school statewide student assessment, or both. The student or the 4 student's parent, quardian, or principal may initiate an appeal with 5 б the district and the district has the authority to determine which 7 appeals are submitted to the superintendent of public instruction for review and approval. The superintendent of public instruction may 8 only approve an appeal if it has been demonstrated that the student 9 has the necessary skills and knowledge to meet the high school 10 graduation standard and that the student has the skills necessary to 11 successfully achieve the college or career goals established in his 12 or her high school and beyond plan. Pathways for demonstrating the 13 necessary skills and knowledge may include, but are not limited to: 14

15 <u>(A) Successful completion of a college level class in the</u> 16 <u>relevant subject area;</u>

17 <u>(B) Admission to a higher education institution or career</u> 18 preparation program;

19

(C) Award of a scholarship for higher education; or

20 (D) Enlistment in a branch of the military.

21 (ii) A student in the class of 2014, 2015, 2016, or 2017 is
22 eligible for the expedited appeal process in (c)(i) of this
23 subsection if he or she has met all other graduation requirements
24 established by the state and district.

25 (iii) A student in the class of 2018 is eligible for the 26 expedited appeal process in (c)(i) of this subsection if he or she 27 has met all other graduation requirements established by the state 28 and district and has attempted at least one alternative assessment 29 option as established in RCW 28A.655.065.

(6) The state board of education shall 30 ((+9))examine 31 opportunities for additional alternative assessments, including the 32 possible use of one or more standardized norm-referenced student 33 achievement tests and the possible use of the reading, writing, or mathematics portions of the ACT ASSET and ACT COMPASS test 34 instruments as objective alternative assessments for demonstrating 35 that a student has met the state standards for the certificate of 36 academic achievement. The state board shall submit its findings and 37 recommendations to the education committees of the legislature by 38 39 January 10, 2008.

1 (((10))) (7) The superintendent of public instruction shall adopt
2 rules to implement this section.

3 Sec. 3. RCW 28A.305.130 and 2013 2nd sp.s. c 22 s 7 are each 4 amended to read as follows:

5 The purpose of the state board of education is to provide advocacy and strategic oversight of public education; implement a 6 7 standards-based accountability framework that creates a unified system of increasing levels of support for schools in order to 8 improve student academic achievement; provide leadership in the 9 10 creation of a system that personalizes education for each student and 11 respects diverse cultures, abilities, and learning styles; and promote achievement of the goals of RCW 28A.150.210. In addition to 12 any other powers and duties as provided by law, the state board of 13 education shall: 14

24 (a) Adopt and revise performance improvement goals in reading, writing, science, and mathematics, by subject and grade level, once 25 assessments in these subjects are required statewide; academic and 26 27 technical skills, as appropriate, in secondary career and technical 28 education programs; and student attendance, as the board deems appropriate to improve student learning. The goals shall 29 be 30 consistent with student privacy protection provisions of RCW 31 28A.655.090(7) and shall not conflict with requirements contained in 32 Title I of the federal elementary and secondary education act of 1965, or the requirements of the Carl D. 37 (2)(a) The superintendent of public instruction may develop or
 38 adopt science end-of-course assessments or a comprehensive science
 39 assessment that includes subjects in addition to biology for purposes

The superintendent of public 24 25 instruction, in consultation with the state board of education, may 26 modify the essential academic learning requirements and statewide student assessments in science, including the high school assessment, 27 28 according to the multistate common student learning standards and assessments as long as the education committees of the legislature 29 have opportunities for review before the modifications are adopted, 30 31 as provided under RCW 28A.655.070.

32 (4) The statewide high school assessment under this section shall 33 be used to demonstrate that a student meets the state standards in 34 the science content area of the statewide student assessment ((for 35 purposes of)) until a comprehensive science assessment is required 36 under RCW 28A.655.061.

37 <u>NEW SECTION.</u> Sec. 7. Section 5 of this act applies
38 retroactively to students in the graduating class of 2017.

1 <u>NEW SECTION.</u> Sec. 8. This act is necessary for the immediate 2 preservation of the public peace, health, or safety, or support of 3 the state government and its existing public institutions, and takes 4 effect immediately.
