WHEREAS, Thousands of United States military veterans live and work near and travel through the South Sound region on Interstate 5 (I-5) by the Nisqually River on its northbound and southbound bridges; and

WHEREAS, According to the United States Department of Veterans 11 12 Affairs, 593,350 veterans currently reside in Washington State; and

13 WHEREAS, According to the Iraq and Afghanistan Veterans America, there are 2.4 million veterans of the Iraq and Afghanistan 14 15
