AN ACT Relating to public hospital district health and wellness promotion activities and superintendent appointment and removal; and amending RCW 70.44.007 and 70.44.070.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 Sec. 1. RCW 70.44.007 and 1997 c 332 s 15 are each amended to 6 read as follows:

7 As used in this chapter, the following words have the meanings8 indicated:

9 (1) "Other health care facilities" means nursing home, extended 10 care, long-term care, outpatient, and rehabilitative facilities((τ)); 11 ambulances((τ)); facilities that promote health, wellness, and 12 prevention of illness and injury; and such other facilities as are 13 appropriate to the health <u>and wellness</u> needs of the population 14 served.

(2) "Other health care services" means nursing home, extended 15 16 care, long-term outpatient, rehabilitative, care, ((health 17 maintenance,)) and ambulance services; services that promote health, wellness, and prevention of illness and injury; and such other 18 19 services as are appropriate to the health needs of the population served. 20

(3) "Public hospital district" or "district" means public health
care service district.

3 **Sec. 2.** RCW 70.44.070 and 1987 c 58 s 1 are each amended to read 4 as follows:

5 (1) The public hospital district commission shall appoint a 6 superintendent, who shall be appointed for an indefinite time and be 7 removable at the will of the commission. Appointments and removals 8 shall be by resolution, introduced at a regular meeting and adopted 9 at <u>the same or</u> a subsequent regular meeting by a majority vote. The 10 superintendent shall receive such compensation as the commission 11 shall fix by resolution.

12 (2) Where a public hospital district operates more than one 13 hospital, the commission may in its discretion appoint up to one 14 superintendent per hospital and assign among the superintendents the 15 powers and duties set forth in RCW 70.44.080 and 70.44.090 as deemed 16 appropriate by the commission.
