- TO THE HONORABLE DONALD J. TRUMP, PRESIDENT OF THE UNITED STATES, 1 2 AND TO THE PRESIDENT OF THE SENATE AND THE SPEAKER OF THE HOUSE OF 3 REPRESENTATIVES, AND TO THE SENATE AND HOUSE OF REPRESENTATIVES OF THE UNITED STATES, IN CONGRESS ASSEMBLED, AND TO THE UNITED STATES 4 5 DEPARTMENT OF DEFENSE AND THE UNITED STATES GENERAL **SERVICES**
- We, your Memorialists, the Senate and House of Representatives of the State of Washington, in legislative session assembled, respectfully represent and petition as follows:
- 10 WHEREAS, Washington state is in imminent danger of a magnitude 11 9.0 Cascadia subduction zone earthquake and subsequent tsunami; and
- WHEREAS, Federal emergency management agency commissioned studies
- 13 by the homeland infrastructure threat and risk analysis center
- 14 indicate the residents of the state will face severe privations due
- 15 to loss of shelter, transportation network, communications, food
- 16 supplies, and medical care; and

ADMINISTRATION:

- 17 WHEREAS, The resulting catastrophic damage to the state's
- 18 infrastructure will severely hinder local, national, and
- 19 international rescue and response activities; and
- 20 WHEREAS, Cities, counties, and fire districts will have to care
- 21 for the residents for up to thirty days before sufficient help
- 22 arrives to meet the residents' needs; and

WHEREAS, Washington cities, counties, and fire districts are gathering supplies and equipment to prepare for the earthquake; and

 WHEREAS, Cities, counties, and fire districts have a low priority for obtaining United States government surplus equipment;

NOW, THEREFORE, Your Memorialists respectfully pray that Congress direct the department of defense and general services administration to give Washington cities, counties, and fire districts first priority for obtaining United States government surplus equipment needed to prepare for the Cascadia subduction zone earthquake and tsunami.

BE IT RESOLVED, That copies of this Memorial be immediately transmitted to the Honorable Donald J. Trump, President of the United States, and to the United States department of defense and the United States general services administration, the President of the United States Senate, the Speaker of the House of Representatives, and each member of Congress from the State of Washington.
