1 AN ACT Relating to removing references to specific nonoperational
2 historical facilities from state statute; and amending RCW 27.34.395
3 and 27.34.900.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 **Sec. 1.** RCW 27.34.395 and 2007 c 138 s 3 are each amended to
6 read as follows:

7 The legislature affirms that the Washington state historical
8 society is the state's designated partner representative for the
9 Vancouver national historic reserve. Accordingly, the Washington
10 state historical society shall:

11 (1) Participate in the regularly scheduled coordination meetings
12 of the Vancouver national historic reserve partners;

13 (2) Participate in the development of management, education, and
14 interpretive plans and policies associated with the Vancouver
15 national historic reserve; and

16 ~~(3) ((Partner with Washington State University and other agencies
17 for purposes of managing the center for Columbia river history,
18 headquartered on the Vancouver national historic reserve, and with
19 the department for preservation and rehabilitation of the site; and~~

20 ~~(4))~~ Develop and submit to the office of financial management
21 and the legislature operating and capital budget requests concurrent

1 with the biennial cycle and oversee the management of all funds
2 appropriated by the state for the Vancouver national historic
3 reserve.

4 **Sec. 2.** RCW 27.34.900 and 1993 c 101 s 13 are each amended to
5 read as follows:

6 The building and grounds designated as Block 2, Grainger's
7 Addition to the City of Olympia, County of Thurston, acquired by the
8 state under senate joint resolution No. 18, session of 1939, is
9 hereby designated a part of the state capitol, to be known as the
10 (~~state capital historical museum. This structure is to be used to~~
11 ~~house and interpret the collection of the Washington state historical~~
12 ~~society. This section does not limit the society's use of other~~
13 ~~structures~~) historic Lord mansion.
