1            AN ACT Relating to the association of Washington generals;  
2 amending RCW 43.15.030 and 46.68.430; reenacting and amending RCW  
3 46.68.420, 46.17.220, and 46.18.200; adding a new section to chapter  
4 43.15 RCW; adding a new section to chapter 46.04 RCW; repealing RCW  
5 46.04.062 and 46.18.215; and providing an effective date.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

7            **Sec. 1.** RCW 43.15.030 and 2005 c 69 s 1 are each amended to read  
8 as follows:

9            (1) The association of Washington generals is organized as a  
10 private, nonprofit, nonpartisan((~~r~~)) corporation in accordance with  
11 chapter 24.03 RCW and this section.

12            (2) The purpose of the association of Washington generals is to:

13            (a) Provide the state a means of extending formal recognition for  
14 an individual's outstanding services to the state; ((and))

15            (b) Bring together those individuals to serve the state as  
16 ambassadors of trade, tourism, and international goodwill; and

17            (c) Expand educational, sports, and/or employment opportunities  
18 for youth, veterans, and people with disabilities in Washington  
19 state.

20            (3) The association of Washington generals may conduct activities  
21 in support of their mission, including but not limited to:

1 (a) Establishing selection criteria for selecting Washington  
2 generals;

3 ~~((Operating a statewide essay competition;~~  
4 ~~(e)))~~ Training Washington generals as ambassadors of the state of  
5 Washington, nationally and internationally; and

6 ~~((d)))~~ (c) Promoting Washington generals as ambassadors of the  
7 state of Washington.

8 (4) The association of Washington generals is governed by a board  
9 of directors. The board is composed of the governor, lieutenant  
10 governor, and the secretary of state, who serve as ex officio,  
11 nonvoting members, and other officers and members as the association  
12 of Washington generals designates.

13 (5) The board shall:

14 (a) Review nominations for and be responsible for the selection  
15 of Washington generals; ~~((and))~~

16 (b) Establish the title of honorary Washington general to honor  
17 worthy individuals from outside the state of Washington; and

18 (c) Adopt bylaws and establish governance and transparency  
19 policies.

20 ~~((5)))~~ (6) The lieutenant governor's office may provide  
21 technical and financial assistance for the association of Washington  
22 generals, where the work of the association aligns with the mission  
23 of the office. Assistance from the lieutenant governor's office may  
24 include, but is not limited to:

25 (a) Collaboration with the association of Washington generals on  
26 the Washington world fellows program, a college readiness and study  
27 abroad fellowship administered by the office of the lieutenant  
28 governor;

29 (b) Beginning January 1, 2019, collaboration with the association  
30 of Washington generals to administer the sports mentoring program as  
31 established under section 3 of this act, a mentoring program to  
32 encourage underserved youth to join sports or otherwise participate  
33 in the area of sports; and

34 (c) The compilation of a yearly financial report, which shall be  
35 made available to the legislature no later than January 15th of each  
36 year, detailing all revenues and expenditures associated with the  
37 Washington world fellows program and the sports mentoring program.  
38 Any expenditures made by the association of Washington generals in  
39 support of the Washington world fellows program and the sports  
40 mentoring program shall be made available to the office of the

1 lieutenant governor for the purpose of inclusion in the annual  
2 financial report.

3 ~~((6))~~ (7) The legislature may make appropriations in support of  
4 the Washington generals subject to the availability of funds.

5 (8) The office of the lieutenant governor must post on its web  
6 site detailed information on all funds received by the association of  
7 Washington generals and all expenditures by the association of  
8 Washington generals.

9 **Sec. 2.** RCW 46.68.420 and 2017 c 25 s 3 and 2017 c 11 s 4 are  
10 each reenacted and amended to read as follows:

11 (1) The department shall:

12 (a) Collect special license plate fees established under RCW  
13 46.17.220;

14 (b) Deduct an amount not to exceed twelve dollars for initial  
15 issue and two dollars for renewal issue for administration and  
16 collection expenses incurred by it; and

17 (c) Remit the remaining proceeds to the custody of the state  
18 treasurer with a proper identifying detailed report.

19 (2) The state treasurer shall credit the proceeds to the motor  
20 vehicle account until the department determines that the state has  
21 been reimbursed for the cost of implementing the special license  
22 plate. Upon determination by the department that the state has been  
23 reimbursed, the state treasurer shall credit the remaining special  
24 license plate fee amounts for each special license plate to the  
25 following appropriate account as created in this section in the  
26 custody of the state treasurer:

((Washington state council of firefighters benevolent fund Receive and disseminate funds for charitable purposes on behalf of members of the Washington state council of firefighters, their families, and others deemed in need))

Washington tennis Provide funds to cities to assist in the construction and maintenance of a public tennis facility with at least four indoor tennis courts. A city is eligible for construction funds if the city does not already have a public or private facility with at least four indoor tennis courts. Funds for construction must first be made available to the most populous eligible city, according to the most recent census, for a time period not to exceed five years after January 1, 2017. After the five-year time period, the funds for construction must be made available to the next most populous eligible city. Funds for the maintenance of a public tennis facility with at least four indoor tennis courts must first be made available to the first eligible city that utilizes funds for construction provided by chapter 16, Laws of 2016

16 (3) Except as otherwise provided in this section, only the  
17 director or the director's designee may authorize expenditures from  
18 the accounts described in subsection (2) of this section. The  
19 accounts are subject to allotment procedures under chapter 43.88 RCW,  
20 but an appropriation is not required for expenditures.

21 (4) Except as otherwise provided in this section, funds in the  
22 special license plate accounts described in subsection (2) of this  
23 section must be disbursed subject to the conditions described in  
24 subsection (2) of this section and under contract between the  
25 department and qualified nonprofit organizations that provide the  
26 services described in subsection (2) of this section.

27 (5) Funds from the Seattle Seahawks account may be provided to  
28 the lieutenant governor solely for the purpose of administering the  
29 Washington world fellows program. Of the amounts received by the  
30 lieutenant governor's office under this subsection, at least ninety  
31 percent must be provided as fellowships under the program.

32 (6) Beginning January 1, 2019, funds from the Seattle Mariners  
33 account may be provided to the office of lieutenant governor solely  
34 for the purpose of administering the sports mentoring program. Of the  
35 amounts received by the office of lieutenant governor, at least  
36 ninety percent must be applied towards services directly provided to  
37 youth participants.

38 (7) For the purposes of this section, a "qualified nonprofit  
39 organization" means a not-for-profit corporation operating in

1 Washington that has received a determination of tax exempt status  
2 under 26 U.S.C. Sec. 501(c)(3). The qualified nonprofit organization  
3 must meet all the requirements under RCW 46.18.100(1).

4 NEW SECTION. **Sec. 3.** A new section is added to chapter 43.15  
5 RCW to read as follows:

6 (1) The sports mentoring program is established to enable  
7 eligible nonprofit community-based organizations to provide  
8 opportunities for underserved youth to join sports teams or otherwise  
9 participate in the area of sports. The goal of the program is to  
10 support youth in building self-confidence, developing skills in the  
11 areas of goal setting and collaboration, and promoting a healthy  
12 lifestyle through forming positive relationships with peers and  
13 family, avoiding risky or delinquent behavior, and achieving  
14 educational success. Proceeds from the Seattle Mariners special  
15 license plate, issued under RCW 46.18.200, must be deposited into the  
16 Seattle Mariners account in accordance with RCW 46.68.420. Funds in  
17 the account may only be used, except as provided under RCW  
18 46.68.420(6), for grants to support youth to stay in school,  
19 participate in sports, and receive mentorships.

20 (2) The office of lieutenant governor will collaborate with the  
21 association of Washington generals to issue competitive grants to  
22 eligible organizations. The following criteria must be used to  
23 prioritize applications:

24 (a) Services provided by the organization to program participants  
25 are provided without a fee;

26 (b) Eligible organizations must assist children with enrolling in  
27 sports through their parents, guardians, or coach; and

28 (c) Eligible organizations must provide professional staff  
29 support to the mentor, child, and parent.

30 (3) Eligible organizations must meet the following requirements:

31 (a) Be a 501(c)(3) nonprofit organization;

32 (b) Conduct national criminal background checks for all employees  
33 and volunteer mentors who work with children;

34 (c) Have adopted standards for care including staff training,  
35 health and safety standards, and mechanisms for assessing and  
36 enforcing the program's compliance with the standards adopted;

37 (d) Ensure that sixty percent or more of the children they serve  
38 are eligible for free or reduced-price lunch;

1 (e) Provide free, direct services to children through volunteer  
2 mentoring; and

3 (f) Provide professional oversight of all mentoring relationships  
4 for each child served.

5 **Sec. 4.** RCW 46.17.220 and 2017 c 25 s 2 and 2017 c 11 s 3 are  
6 each reenacted and amended to read as follows:

7 ~~((1))~~ In addition to all fees and taxes required to be paid  
8 upon application for a vehicle registration in chapter 46.16A RCW,  
9 the holder of a special license plate shall pay the appropriate  
10 special license plate fee as listed in this section.

20 each reenacted and amended to read as follows:

21 (1) Special license plate series reviewed and approved by the  
22 department:

23 (a) May be issued in lieu of standard issue or personalized  
24 license plates for vehicles required to display one and two license  
25 plates unless otherwise specified;

26 (b) Must be issued under terms and conditions established by the  
27 department;

28 (c) Must not be issued for vehicles registered under chapter  
29 46.87 RCW; and

30 (d) Must display a symbol or artwork approved by the department.

25 and paramedics special license plates must show proof of eligibility  
26 by providing a certificate of current membership from the Washington  
27 state council of firefighters.

28 (4) Applicants for initial volunteer firefighters special license  
29 plates must (a) have been a volunteer firefighter for at least ten  
30 years or be a volunteer firefighter for one or more years and (b)  
31 have documentation of service from the district of the appropriate  
32 fire service. If the volunteer firefighter leaves firefighting  
33 service before ten years of service have been completed, the  
34 volunteer firefighter shall surrender the license plates to the  
35 department on the registration renewal date. If the volunteer  
36 firefighter stays in service for at least ten years and then leaves,  
37 the license plate may be retained by the former volunteer firefighter  
38 and as long as the license plate is retained for use the person will

1 continue to pay the future registration renewals. A qualifying  
2 volunteer firefighter may have no more than one set of license plates  
3 per vehicle, and a maximum of two sets per applicant, for their  
4 personal vehicles. If the volunteer firefighter is convicted of a  
5 violation of RCW 46.61.502 or a felony, the license plates must be  
6 surrendered upon conviction.

7 **Sec. 6.** RCW 46.68.430 and 2010 c 161 s 811 are each amended to  
8 read as follows:

9 (1) The department shall:

10 (a) Collect special license plates fees established under RCW  
11 46.17.220(~~((1)-(e) and (e))~~) (6);

12 (b) Deduct an amount not to exceed twelve dollars for initial  
13 issue and two dollars for renewal issue for administration and  
14 collection expenses incurred by it; and

15 (c) Remit the remaining proceeds to the custody of the state  
16 treasurer with a proper identifying detailed report.

17 (2) The state treasurer shall credit the remaining special  
18 license plate fees to the following accounts by special license plate  
19 type:
