- 5 **Sec. 1.** RCW 43.22A.190 and 2007 c 432 s 5 are each amended to 6 read as follows:
- 7 (1) A person found to have committed an infraction under this
- 8 chapter (($\frac{\text{shall}}{\text{o}}$)) $\underline{\text{may}}$ be assessed a monetary penalty of $\underline{\text{two hundred}}$
- 9 fifty dollars for the first infraction and not more than one thousand
- 10 dollars for a second or subsequent infraction. The department shall
- 11 set by rule a schedule of monetary penalties for infractions imposed
- 12 <u>under this chapter</u>.
- 13 (2) The administrative law judge may waive, reduce, or suspend
- 14 the monetary penalty imposed for the infraction.
