5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6 Sec. 1. RCW 28A.300.035 and 1994 c 113 s 1 are each amended to 7 read as follows:

the superintendent of public instruction, the Washington 8 Ιf professional educator standards board, or the state 9 board of 10 education, in carrying out their powers and duties under Title 28A 11 RCW, request the service of any certificated or classified employee of a school district upon any committee formed for the purpose of 12 13 furthering education within the state, or within any school district 14 therein, and such service would result in a need for a school district to employ a substitute for such certificated or classified 15 16 employee during such service, payment for such a substitute may be 17 superintendent of public instruction made by the from funds 18 appropriated by the legislature for the current use of the common schools and such payments shall be construed as amounts needed for 19 state support to the common schools under RCW 28A.150.380. If such 20 21 substitute is paid by the superintendent of public instruction, no

1 deduction shall be made from the salary of the certificated or 2 classified employee. In no event shall a school district deduct from 3 the salary of a certificated or classified employee serving on such 4 committee more than the amount paid the substitute employed by the 5 district.
