1 AN ACT Relating to making expenditures from the budget 2 stabilization account for declared catastrophic events; creating a 3 new section; making appropriations; and declaring an emergency.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 <u>NEW SECTION.</u> Sec. 1. On September 2, 2017, the governor 6 declared a state of emergency in all counties due to threats to life 7 and property from existing and threatened wildfires.

Sec. 2. FOR THE DEPARTMENT OF NATURAL RESOURCES-8 NEW SECTION. FIRES. The sum of nineteen million eight hundred eight thousand 9 dollars is appropriated from the budget stabilization account for the 10 11 fiscal year ending June 30, 2018, and is provided solely for fire suppression costs incurred by the department of natural resources 12 13 during the 2017 fire season. For purposes of RCW 43.88.055(4), the 14 appropriation in this section does not alter the requirement to 15 balance in ensuing biennia.

16 <u>NEW SECTION.</u> Sec. 3. FOR THE WASHINGTON STATE PATROL—FIRES. The 17 sum of two million six hundred fifty thousand dollars is appropriated 18 from the budget stabilization account for the fiscal year ending June 19 30, 2018, and is provided solely for Washington state fire service 1 resource mobilization costs incurred in response to an emergency or 2 disaster authorized under RCW 43.43.960 through 43.43.964. For 3 purposes of RCW 43.88.055(4), the appropriation in this section does 4 not alter the requirement to balance in ensuing biennia.

5 <u>NEW SECTION.</u> Sec. 4. This act is necessary for the immediate 6 preservation of the public peace, health, or safety, or support of 7 the state government and its existing public institutions, and takes 8 effect immediately.
