- On page 3, after line 32, insert the following:
- 2 "Sec. 3. RCW 28A.300.080 and 1983 1st ex.s. c 34 s 1 are each
- 3 amended to read as follows:
- 4 (1) The legislature recognizes that agriculture is the most
- 5 basic and singularly important industry in the state, that
- 6 agriculture is of central importance to the welfare and economic
- 7 stability of the state, and that the maintenance of this vital
- 8 industry requires a continued source of trained and qualified
- 9 individuals who qualify for employment in agriculture, food, and
- 10 natural resource career pathways.
- 11 (2) The legislature finds that research shows that students
- 12 enrolled in a career and technical education program in high school
- 13 have a higher graduation rate than other students, and that the
- 14 agricultural education branch of career and technical education
- 15 fosters an understanding of the history and principles of
- 16 agriculture, agriscience, manufacturing, agribusiness, leadership,
- 17 <u>advocacy</u>, and <u>community service</u>.
- 18 (3) The legislature, therefore, intends to promote comprehensive
- 19 and formal instruction in agricultural education, and membership in
- 20 the corresponding career and technical student organizations, to
- 21 provide students with the opportunity to:
- 22 (a) Develop fundamental leadership and communication skills;
- 23 (b) Develop an applied understanding of the agricultural
- 24 industry and its potential;
- 25 (c) Explore and understand career opportunities through
- 26 supervised agricultural experiences;
- 27 (d) Engage with industry mentors; and

- 1 (e) Plan for career and college success.
- 2 (4) In an effort to assist actions of schools to offer career
- 3 and technical education courses, the legislature intends to support
- 4 dropout prevention programs and career readiness, and improve
- 5 learning opportunities and educational outcomes in agriculture,
- 6 food, and natural resource education.
- 7 (5) The legislature declares that it is within the best
- 8 interests of the people and state of Washington that a comprehensive
- 9 ((vocational education)) program in agriculture education through
- 10 career and technical education be maintained in the state's
- 11 secondary school system in order to ensure both an adequate supply
- 12 of trained and skilled individuals, and appropriate representation
- 13 of sexual orientation, racial, and ethnic groups in all phases of
- 14 the agricultural, food, and natural resource supply chain.
- 16 Sec. 4. RCW 28A.300.090 and 1983 1st ex.s. c 34 s 2 are each
- 17 amended to read as follows:

- 18 (1) ((A vocational)) An agriculture education ((service area
- 19 within)) program must be established as a career and technical
- 20 education program in the office of the superintendent of public
- 21 instruction ((shall be established)). The program must serve the
- 22 agriculture, food, and natural resource career cluster. Adequate
- 23 <u>funding for the</u> staffing of individuals trained or experienced in
- 24 the field of ((vocational agriculture shall be provided for the
- 25 vocational)) agriculture education ((service area for coordination
- 26 of the state)) must be provided for program ((and to)) oversight.
- 27 (2) The program must provide assistance to ((local)) school
- 28 districts ((for the coordination of the)) and coordinate its
- 29 activities ((of)) with applicable career and technical student
- 30 ((agricultural)) organizations ((and associations)). The program
- 31 staff members must include, but are not limited to, a 1.0 FTE
- 32 supervisor of agriculture education employed by the office of the
- 33 superintendent of public instruction, and any additional staff
- 34 member deemed appropriate.

- 1 (((2))) <u>(3)</u> The ((vocational agriculture education service 2 area)) program supervisor shall:
- 3 (a) Assess needs in ((vocational)) agriculture ((education)),
- 4 food, and natural resource sciences, assist local school districts
- 5 in establishing ((vocational)) agriculture programs, review local
- 6 school district applications for approval of ((vocational))
- 7 agriculture programs, evaluate existing programs, and plan research
- 3 and studies for the improvement of curriculum materials for
- 9 specialty areas of ((vocational)) agriculture. Standards and
- 10 criteria developed under this subsection shall satisfy the mandates
- 11 of federally-assisted ((vocational)) career and technical education;
- 12 (b) Develop in-service programs for teachers and administrators
- 13 of ((vocational)) agriculture <u>education</u>, review application<u>s</u> for
- 14 ((vocational)) career and technical education agriculture teacher
- 15 certification, and assist in teacher recruitment and placement in
- 16 ((vocational)) career and technical education agriculture programs;
- 17 (c) Serve ((as a liaison with)) on the ((Future Farmers of
- 18 America,)) Washington FFA association board of directors, consisting
- 19 of representatives of business, industry, and appropriate public
- 20 agencies, and institutions of higher education in order to
- 21 disseminate information, promote improvement of ((vocational))
- 22 career and technical education agriculture programs, and assist in
- 23 the development of adult and continuing education programs in
- 24 ((vocational)) agriculture; ((and))
- 25 (d) Serve as the FFA state advisor for Washington; and
- 26 (e) Establish an advisory task force committee of
- 27 agriculturists, who represent the diverse areas of the agricultural
- 28 industry in Washington, which shall make annual recommendations
- 29 including, but not limited to, the development of curriculum,
- 30 staffing, strategies for the purpose of establishing a source of
- 31 trained and qualified individuals in agriculture, and strategies for
- 32 articulating the state program in ((vocational)) agriculture
- 33 education, including youth leadership throughout the state school
- 34 system.

- 1 (4) For the purposes of this section, "agriculture, food, and
- 2 natural resource career cluster area" means a program of study
- 3 requiring the student to:
- 4 (a) Complete courses in the following areas:
- 5 <u>(i) Agribusiness systems;</u>
- 6 (ii) Animal systems;
- 7 (iii) Biotechnology systems;
- 8 (iv) Environmental service systems;
- 9 (v) Food products and processing systems;
- 10 <u>(vi) Natural resource systems;</u>
- 11 (vii) Plant systems; and
- (viii) Power, structural, and technical systems;
- 13 (b) Develop a supervised agriculture experience extended
- 14 <u>learning program that is supervised by the student's agriculture</u>
- 15 <u>educator; and</u>
- 16 (c) Be engaged in a career and technical student organization.

- NEW SECTION. Sec. 5. A new section is added to chapter 28A.300
- 19 RCW to read as follows:
- 20 (1) The legislature finds that career and technical student
- 21 organizations prepare students to enter a postsecondary education
- 22 institute and a career. The legislature finds also that barriers for
- 23 agriculture education students should be removed.
- 24 (2) Subject to the availability of amounts appropriated for this
- 25 specific purpose, the office of the superintendent of public
- 26 instruction shall provide every student enrolled in an agriculture
- 27 education pathway course approved by the office of the
- 28 superintendent of public instruction, based on annual June 1st
- 29 enrollment, with state and national membership to the corresponding
- 30 career and technical student organizations.

- 32 **Sec. 6.** RCW 28A.300.100 and 1990 c 33 s 254 are each amended to
- 33 read as follows:

- 1 The <u>office of the</u> superintendent of public instruction, <u>in</u>
- 2 consultation with the board of directors of the Washington FFA
- 3 <u>association and</u> pursuant to chapter 34.05 RCW, shall adopt <u>and</u>
- 4 periodically revise such rules as are necessary to carry out the
- 5 provisions of RCW 28A.300.090 and section 5 of this act."

- <u>EFFECT:</u> (1) Modifies provisions governing an existing vocational agriculture education service area program within the Office of the Superintendent of Public Instruction (OSPI) and instead directs the OSPI to establish an agriculture education program (Program) as a career and technical education (CTE) program in the OSPI.
- (2) Establishes that the Program must provide assistance to school districts and coordinate activities with applicable CTE student organizations.
 - (3) Includes staffing provisions related to the Program.
- (4) Establishes specific duties for the Program supervisor, including, assisting school districts, developing in-service programs for teachers and administrators, serving as the FFA state advisor for Washington, and serving on the Washington FFA board of directors.
- (5) Directs the OSPI, subject to specific legislative funding, to provide every student enrolled in an agriculture education pathway course approved by the OSPI with membership to the corresponding state and national career and technical student organizations.
- (6) Directs the OSPI, in consultation with the board of directors of the Washington FFA Association, to adopt and periodically revise rules related to the Program and provisions for student memberships with corresponding state and national career and technical student organizations.
