**"PART V
PERFORMANCE REVIEWS**

1 NEW SECTION. **Sec. 501.** A new section is added to chapter
2 28A.630 RCW to read as follows:

3 (1) (a) The student achievement council must develop performance
4 measures for the joint legislative audit and review committee to use
5 to evaluate the success of the programs listed in subsection (2) of
6 this section in recruiting and retaining highly effective teachers,
7 especially in high-need subjects and geographic areas.

8 (b) In developing the performance measures and a data collection
9 plan, the student achievement council must consult with the joint
10 legislative audit and review committee, the education data center
11 established in RCW 43.41.400, the office of the superintendent of
12 public instruction, and the Washington professional educator
13 standards board. To the maximum extent possible, the performance
14 measures must use existing data and be disaggregated by subject and
15 geographic area.

16 (c) The student achievement council must submit the performance
17 measures and a data collection plan to the joint legislative audit
18 and review committee and the appropriate committees of the
19 legislature by January 10, 2020.

20 (2) The student achievement council must develop performance
21 measures and a data collection plan for the review of the following
22 programs:

23 (a) The regional educator recruitment program under section 102
24 of this act;

25 (b) The recruiting Washington teachers program under RCW
26 28A.415.370;

27 (c) The bilingual educator initiative under RCW 28A.180.120;

28 (d) The educational service district alternative route pilot
29 program under section 108 of this act;

30 (e) Grants for student teachers at Title I schools under RCW
31 28B.76.699;

32 (f) The teacher shortage conditional scholarship program under
33 RCW 28B.102.090;

34 (g) The alternative route conditional scholarship program under
35 section 216 of this act;

36 (h) The pipeline for paraeducators conditional scholarship
37 program under section 217 of this act;

38 (i) The educator retooling conditional scholarship program under
39 section 218 of this act;

1 (j) The career and technical education conditional scholarship
2 program under section 219 of this act;

3 (k) The federal student loan repayment in exchange for teaching
4 service program under RCW 28B.102.055;

5 (l) Expanded enrollments in high-need subjects and locations
6 under section 230 of this act; and

7 (m) The beginning educator support team program under RCW
8 28A.415.265.

9 (3) In developing performance measures, the student achievement
10 council must consider the following measures:

11 (a) Number of teaching vacancies and length of time each position
12 remains open;

13 (b) Number and percentage of teachers on limited certificates
14 assigned to teach;

15 (c) Number and percentage of teachers assigned to teach out of
16 field;

17 (d) Number and percentage of fully certificated teachers with
18 fewer than five years' experience;

19 (e) Demographics of teachers, such as race, ethnicity, and
20 gender, compared to demographics of students;

21 (f) Number and percentage of teachers who are fluent in a
22 language other than English;

23 (g) Resources spent by principals and human resource personnel on
24 recruitment efforts;

25 (h) Effect of educators on student growth, graduation rates, and
26 other student outcomes;

27 (i) Teacher program completion rates; and

28 (j) Teacher mobility trends, including how long teachers teach in
29 Washington.

30 (4) In fiscal year 2029, the student achievement council must
31 review state funding provided to the programs listed in subsection
32 (2) of this section and submit to the joint legislative audit and
33 review committee a report of the five programs provided with the most
34 funding over the prior nine fiscal years.

35 (5) This section expires July 1, 2032.

36 NEW SECTION. **Sec. 502.** A new section is added to chapter 44.28
37 RCW to read as follows:

1 (1) The joint committee must assist the student achievement
2 council with its development of performance measures and a data
3 collection plan as required under section 501 of this act.

4 (2)(a) Beginning in fiscal year 2030, the joint committee must
5 perform a review of the five programs provided with the most state
6 funding over the prior nine fiscal years, as identified by the
7 student achievement council. The joint committee must prioritize
8 these reviews in order of the programs that received the most state
9 funding. Each review must evaluate the success of the program in
10 recruiting and retaining highly effective teachers, especially in
11 high-need subjects and geographic areas.

12 (b) The joint committee must perform the reviews required under
13 this subsection (2) and submit the results of each review to the
14 appropriate committees of the legislature as the reviews are
15 completed, but no later than December 31, 2031, and in compliance
16 with RCW 43.01.036.

17 (3) This section expires July 1, 2032.

18 **PART VI**
19 **OTHER PROVISIONS"**

20 Renumber the remaining sections consecutively, correct any
21 internal references accordingly, and correct the title.

EFFECT: Directs the Washington Student Achievement Council (WSAC) to develop performance measures for the Joint Legislative and Audit Review Committee (JLARC) to use to evaluate the success of the listed programs in recruiting and retaining highly effective teachers, especially in high-need subjects and geographic areas. Lists measures that the WSAC must consider when developing its performance measures. Requires the WSAC to consult with the JLARC, the Education Research and Data Center, the Office of the Superintendent of Public Instruction, and the Professional Educator Standards Board in developing the performance measures and a data collection plan. Requires the WSAC to submit the resulting performance measures and a data collection plan to the JLARC and the Legislature by January 10, 2020. Requires the WSAC submit to the JLARC a report of the five programs provided with the most funding over the prior nine fiscal years, by the end of fiscal year 2029. Requires, beginning in fiscal year 2030, the JLARC to review the five most funded programs and submit the reviews to the Legislature no later than December 31, 2031. Expires the listed programs on July 1, 2032.
