EFFECT: (1) Modifies the requirement that a religious organization notify the county, city or town, or code city of its public meeting relating to its hosting the homeless as follows: (a) Notice must be provided forty-eight hours, rather two weeks, prior to the public meeting; and

- (b) Notice of the meeting is not required if the use is in response to a declared emergency.
- (2) Requires a county, city or town, or code city to publish notice of the meeting hosted by the a religious organization regarding its hosting of the homeless that must be:
- (a) Delivered to each local newspaper and local radio and television station that has requested to be notified of special meetings of an agency;
- (b) Posted on the agency's web site, with certain exceptions;
- (c) Displayed at the main entrance of the agency's location and the meeting site; and
- (d) Delivered or posted at any time prior to the meeting.
