(1) Any dangerous dog shall be immediately confiscated by an 5 animal control authority if the: (a) Dog is not validly registered 6 7 under RCW 16.08.080; (b) owner does not secure the liability insurance coverage required under RCW 16.08.080; (c) dog is not 8 9 maintained in the proper enclosure; or (d) dog is outside of the dwelling of the owner, or outside of the proper enclosure and not 10 11 under physical restraint of the responsible person. The owner must 12 costs of confinement and control. The animal control pay the 13 authority must serve notice upon the dog owner in person or by 14 regular and certified mail, return receipt requested, specifying the reason for the confiscation of the dangerous dog, that the owner is 15 responsible for payment of the costs of confinement and control, and 16 17 that the dog will be destroyed in an expeditious and humane manner if the deficiencies for which the dog was confiscated are not corrected 18 within twenty days. The animal control authority shall destroy the 19 20 confiscated dangerous dog in an expeditious and humane manner if any 21 deficiencies required by this subsection are not corrected within 22 twenty days of notification. In addition, the owner shall be quilty of a gross misdemeanor punishable in accordance with RCW 9A.20.021. 23

24 (2) If a dangerous dog of an owner with a prior conviction under 25 this chapter attacks or bites a person or another domestic animal, 26 the dog's owner is quilty of a class C felony, punishable in accordance with RCW 9A.20.021. It is an affirmative defense that the 27 28 defendant must prove by a preponderance of the evidence that he or 29 she was in compliance with the requirements for ownership of a dangerous dog pursuant to this chapter and the person or domestic 30 31 animal attacked or bitten by the defendant's dog trespassed on the 32 defendant's real or personal property or provoked the defendant's dog

without justification or excuse. In addition, the dangerous dog shall be immediately confiscated by an animal control authority, placed in quarantine for the proper length of time, and thereafter destroyed in an expeditious and humane manner.

(3) The owner of any dog that aggressively attacks and causes 5 6 severe injury or death of any human, whether or not the dog has previously been declared potentially dangerous or dangerous, shall, 7 upon conviction, be guilty of a class C felony punishable in 8 accordance with RCW 9A.20.021. It is an affirmative defense that the 9 defendant must prove by a preponderance of the evidence that the 10 11 human severely injured or killed by the defendant's dog: (a) 12 Trespassed on the defendant's real or personal property which was enclosed by fencing suitable to prevent the entry of young children 13 and designed to prevent the dog from escaping and marked with clearly 14 visible signs warning people, including children, not to trespass and 15 16 to beware of dog; or (b) provoked the defendant's dog without 17 justification or excuse on the defendant's real or personal property which was enclosed by fencing suitable to prevent the entry of young 18 children and designed to prevent the dog from escaping and marked 19 with clearly visible signs warning people, including children, not to 20 21 trespass and to beware of dog. In such a prosecution, the state has the burden of showing that the owner of the dog either knew or should 22 have known that the dog was potentially dangerous as defined in this 23 chapter. The state may not meet its burden of proof that the owner 24 25 should have known the dog was potentially dangerous solely by showing 26 the dog to be a particular breed or breeds. In addition, the dog 27 shall be immediately confiscated by an animal control authority, quarantined, and upon conviction of the owner destroyed in an 28 29 expeditious and humane manner.

30 (((4) Any person entering a dog in a dog fight is guilty of a 31 class C felony punishable in accordance with RCW 9A.20.021.))

27 (1) If a law enforcement officer or animal control officer has probable cause to believe that an owner of a domestic animal has 28 violated this chapter or a person owns, cares for, or resides with an 29 30 animal in violation of an order issued under RCW 16.52.200(4) and no responsible person can be found to assume the animal's care, the 31 officer may authorize, with a warrant, the removal of the animal to a 32 suitable place for feeding and care, or may place the animal under 33 the custody of an animal care and control agency. This section does not condone illegal entry onto private 7 8 property.

If a court order prevents 29 the agency from assuming ownership and the agency continues to care 30 31 for the animal, the court shall order the owner to post or renew a 32 bond or security for the agency's continuing costs for the animal's care. When a court has prohibited the owner from owning, caring for, 33 or residing with ((a similar)) animals under RCW 16.52.200(4), the 34 agency having custody of the animal may assume ownership upon seizure 35 and the owner may not prevent the animal's destruction or adoption by 36 petitioning the court or posting a bond. 37

1 petition shall be filed with the court. Copies of the petition must be served on the law enforcement or animal care and control agency 2 responsible for removing the animal and to the prosecuting attorney. 3 If the court grants the petition, the agency which seized the animal 4 must surrender the animal to the owner at no cost to the owner. If a 5 6 criminal action is filed after the petition is filed but before the 7 hearing on the petition, then the petition shall be joined with the criminal matter. 8

13 (7) Any authorized person treating or attempting to restore an 14 animal to health under this chapter shall not be civilly or 15 criminally liable for such action.

1 (1) The sentence imposed for a misdemeanor or gross misdemeanor 2 violation of this chapter may be deferred or suspended in accordance 3 with RCW 3.66.067 and 3.66.068, however the probationary period shall 4 be two years.

<u>EFFECT:</u> Removes the definition of "pain" for purposes of Animal Cruelty and related offenses. Modifies the definition of "sexual conduct" for purposes of Animal Cruelty in the first degree to provide that transfer of a person's saliva must be to the sex organs

or anus of the animal, rather than any part of the animal, to qualify. Retains all other provisions of the underlying bill.
