- "NEW SECTION. Sec. 17. (1) A local government must prepare a 4 written record of the basis of the decision to perform the public 5 works with local government employees rather than following the public 6 works contracting process. The written record must include, at a
- 7 minimum:
- 8 (a) A small business impact statement, as described in RCW 9 19.85.040; and
- 10 (b) A comprehensive impact assessment that includes, at a minimum:
- 11 (i) An estimate of the cost to complete the public works project,
- 12 including the fully allocated costs of the public works project, the
- 13 cost of the employees' salaries and benefits, space, equipment,
- 14 materials, and overhead and other costs necessary to complete the
- 15 public works project;
- 16 (ii) An estimate of the cost to contract out the public works 17 project;
- 18 (iii) Reasons for proposing the public works project be completed
- 19 with local government employees; and
- 20 (iv) Potential adverse impacts on the public from completing the
- 21 work with local government employees and any cumulative impact the
- 22 decision may have on future projects.
- 23 (2) The written report must be sent to the department of
- 24 enterprise services, and the department of enterprise services must
- 25 compile all submitted written reports received pursuant to this
- 26 section and must annually make a report to the appropriate committees
- 27 of the legislature.

- 1 (3) The public works written reports required under subsection
- 2 (1) of this section must include the local government entities

- (4) For purposes of this section, "local government" refers to
- 12 all counties, cities, towns, other political subdivisions, and
- 13 special purpose districts."
- 14 Correct the title.

EFFECT: Requires local governments, when performing a public works project without using the public works contracting process, to submit a written record of the basis of the decision to perform the public works with local government employees to the Department of Enterprise Services(DES) and requires DES to annually make a report to the appropriate committees of the legislature with the details of all of the submitted written reports.
