EFFECT: Removes an appropriation of up to \$53.4 million attributable to incentive savings. Creates the Wildfire Prevention and Preparedness Account (WPPA). Appropriates \$53.4M from the state general fund into the WPPA. Appropriates \$53.4M from the WPPA to the Department of Natural Resources for various fire prevention, preparedness, and forest health activities.
