7 (1) Special license plate series reviewed and approved by the
8 department:

9 (a) May be issued in lieu of standard issue or personalized
10 license plates for vehicles required to display one and two license
11 plates unless otherwise specified;

12 (b) Must be issued under terms and conditions established by the
13 department;

14 (c) Must not be issued for vehicles registered under chapter
15 46.87 RCW; and

16 (d) Must display a symbol or artwork approved by the department.

17 (2) The department approves and shall issue the following special
18 license plates, subject to subsection (5) of this section:

12 (3) Applicants for initial and renewal professional firefighters
13 and paramedics special license plates must show proof of eligibility
14 by providing a certificate of current membership from the Washington
15 state council of firefighters.

16 (4) Applicants for initial volunteer firefighters special license
17 plates must (a) have been a volunteer firefighter for at least ten
18 years or be a volunteer firefighter for one or more years and (b)
19 have documentation of service from the district of the appropriate
20 fire service. If the volunteer firefighter leaves firefighting
21 service before ten years of service have been completed, the
22 volunteer firefighter shall surrender the license plates to the
23 department on the registration renewal date. If the volunteer
24 firefighter stays in service for at least ten years and then leaves,
25 the license plate may be retained by the former volunteer firefighter
26 and as long as the license plate is retained for use the person will
27 continue to pay the future registration renewals. A qualifying
28 volunteer firefighter may have no more than one set of license plates
29 per vehicle, and a maximum of two sets per applicant, for their
30 personal vehicles. If the volunteer firefighter is convicted of a
31 violation of RCW 46.61.502 or a felony, the license plates must be
32 surrendered upon conviction.

33 (5) The department shall not issue the Washington wine special
34 license plate until the department receives signature sheets
35 satisfying the requirements identified in RCW 46.18.110(2)(f).

36 **Sec. 3.** RCW 46.68.420 and 2019 c 384 s 3 and 2019 c 177 s 3 are
37 each reenacted and amended to read as follows:

1 (1) The department shall:

2 (a) Collect special license plate fees established under RCW

3 46.17.220;

4 (b) Deduct an amount not to exceed twelve dollars for initial

5 issue and two dollars for renewal issue for administration and

6 collection expenses incurred by it; and

7 (c) Remit the remaining proceeds to the custody of the state

8 treasurer with a proper identifying detailed report.

9 (2) The state treasurer shall credit the proceeds to the motor

10 vehicle (~~(account—[fund])~~) fund until the department determines that

11 the state has been reimbursed for the cost of implementing the

12 special license plate. Upon determination by the department that the

13 state has been reimbursed, the state treasurer shall credit the

14 remaining special license plate fee amounts for each special license

15 plate to the following appropriate account as created in this section

(3) Except as otherwise provided in this section, only the director or the director's designee may authorize expenditures from the accounts described in subsection (2) of this section. The accounts are subject to allotment procedures under chapter 43.88 RCW, but an appropriation is not required for expenditures.

(4) Except as otherwise provided in this section, funds in the special license plate accounts described in subsection (2) of this section must be disbursed subject to the conditions described in subsection (2) of this section and under contract between the department and qualified nonprofit organizations that provide the services described in subsection (2) of this section.

(5) Funds from the Seattle Seahawks account may be provided to the lieutenant governor solely for the purpose of administering the Washington world fellows program. Of the amounts received by the lieutenant governor's office under this subsection, at least ninety percent must be provided as fellowships under the program.

(6) Beginning January 1, 2019, funds from the Seattle Mariners account may be provided to the office of lieutenant governor solely for the purpose of administering the sports mentoring program. Of the amounts received by the office of lieutenant governor, at least ninety percent must be applied towards services directly provided to youth participants.

(7) For the purposes of this section, a "qualified nonprofit organization" means a not-for-profit corporation operating in Washington that has received a determination of tax exempt status under 26 U.S.C. Sec. 501(c)(3). The qualified nonprofit organization must meet all the requirements under RCW 46.18.100(1).

NEW SECTION. **Sec. 4.** A new section is added to chapter 46.04 RCW to read as follows:

"Washington wine license plates" means special license plates issued under RCW 46.18.200 that display a landscape of Washington's wine regions.

1 NEW SECTION. **Sec. 5.** This act takes effect October 1, 2020."

2 On page 1, line 2 of the title, after "plates;" strike the
3 remainder of the title and insert "reenacting and amending RCW
4 46.17.220, 46.18.200, and 46.68.420; adding a new section to chapter
5 46.04 RCW; and providing an effective date."

EFFECT: Prohibits DOL from issuing the Washington wine special license plate until DOL receives signature sheets reflecting the required minimum number of intended purchases of the plate.
