7 appropriated and authorized to be incurred for capital projects
8 during the period beginning with the effective date of this act and
9 ending June 30, 2021, out of the several funds specified in this act.

11 **GENERAL GOVERNMENT**

13 follows:

14 **FOR THE DEPARTMENT OF COMMERCE**

15 Building Communities Fund Program (30000803)

16 The reappropriation in this section is subject to the following
17 conditions and limitations:

18 (1) \$1,455,000 of the amount reappropriated in this section is
19 provided solely for the Byrd Barr place, formerly known as
20 Centerstone, building renovation project.

21 (2) \$220,000 of the amount reappropriated in this section is
22 provided solely for El Centro de la Raza boiler fan and master plan
23 for rehabilitation. This amount is not subject to the match
24 requirements, pursuant to RCW 43.63A.125.

5 **FOR THE DEPARTMENT OF COMMERCE**

6 2019-21 Housing Trust Fund Program (40000036)

7 The appropriations in this section are subject to the following
8 conditions and limitations:

9 (1) \$129,050,000 of the state taxable building construction
10 account—state appropriation and ((~~\$45,950,000~~)) \$42,950,000 of the
11 state building construction account—state appropriation are provided
12 solely for production and preservation of affordable housing. Of the
13 amounts in this subsection:

14 (a) \$35,000,000 of the appropriation is provided solely for
15 housing projects that provide supportive housing and case-management
16 services to persons with ((~~behavioral or~~)) chronic mental illness.
17 When evaluating applications for this population, the department must
18 prioritize low-income supportive housing unit proposals that show:

19 (i) Evidence that the application was developed in collaboration
20 with one or more health care entities that provide behavioral health
21 care services to individuals eligible for the housing provided under
22 this subsection;

23 (ii) A commitment by the applicant to provide, directly or
24 through a formal partnership, necessary treatment and supportive
25 services to the tenants and maintain the beds or housing units for at
26 least a forty-year period;

27 (iii) Readiness to begin structural modifications or construction
28 resulting in a fast project completion;

29 (iv) Program requirements that adhere to the key elements of
30 permanent supportive housing programs including choice in housing and
31 living arrangements, functional separation of housing and services,
32 community integration, rights of tenancy, and voluntary recovery-
33 focused services; and

34 (v) To achieve geographic distribution, the department must
35 prioritize projects in rural areas as defined by the department per
36 RCW 43.185.050 and unserved communities with the goal of maximizing
37 the investment and increasing the number of supportive housing units
38 in rural, unserved communities.

1 (b) \$10,000,000 of the appropriation in this section is provided
2 solely for competitive grant awards for modular housing which
3 includes high quality affordable housing projects that will quickly
4 move people from homelessness into secure housing and are
5 significantly less expensive to construct than traditional housing.
6 These funds must be awarded to projects with a total project
7 development cost per housing unit of less than \$125,000, excluding
8 the value of land, off-site infrastructure costs, and any capitalized
9 reserves, compliant with the Americans with disabilities act, and
10 with a commitment by the applicant to maintain the housing units for
11 at least a fifty year period.

12 (c) \$10,000,000 of the appropriation in this section is provided
13 solely for a state match or state matches on private contributions
14 that fund the production and preservation of affordable housing.
15 Awards must be made using a competitive process. If any funding
16 remains unallocated after the first fiscal year during the 2019-2021
17 fiscal biennium, the department may allocate the remaining funding
18 through its annual competitive process for affordable housing
19 projects that serve and benefit low-income and special needs
20 populations in need of housing.

21 (d) (i) \$10,000,000 of the appropriation in this section is
22 provided solely for housing preservation grants or loans to be
23 awarded competitively.

24 (ii) The funds may be provided for major building improvements,
25 preservation, and system replacements, necessary for the existing
26 housing trust fund portfolio to maintain long-term viability. The
27 department must require a capital needs assessment to be provided
28 prior to contract execution. Funds may not be used to add or expand
29 the capacity of the property.

30 (iii) To allocate preservation funds, the department must review
31 applications and evaluate projects based on the following criteria:

32 (A) The age of the property, with priority given to buildings
33 that are more than fifteen years old;

34 (B) The population served, with priority given to projects with
35 at least 50 percent of the housing units being occupied by families
36 and individuals at or below 50 percent area median income;

37 (C) The degree to which the applicant demonstrates that the
38 improvements will result in a reduction of operating or utilities
39 costs, or both;

1 (D) The potential for additional years added to the affordability
2 period of the property; and

3 (E) Other criteria that the department considers necessary to
4 achieve the purpose of this program.

5 (e) (i) \$7,000,000 of the appropriation in this section is
6 provided solely for loans or grants to design and construct ultra-
7 high energy efficient affordable housing projects.

8 (ii) To receive funding, a project must provide a life-cycle cost
9 analysis report to the department and must demonstrate energy-saving
10 and renewable energy systems either designed to reach net-zero energy
11 use after housing is fully occupied or designed to achieve the most
12 recent building standard of the passive house institute US as of the
13 effective date of this section.

14 (iii) The department must consider, at a minimum and in any
15 order, the following factors in assigning a numerical ranking to a
16 project:

17 (A) Whether the proposed design has demonstrated that the project
18 will achieve either net-zero energy use when fully occupied or will
19 achieve the most recent building standard of the passive house
20 institute US as of the effective date of this section;

21 (B) The life-cycle cost of the project;

22 (C) That the project demonstrates a design, use of materials, and
23 construction process that can be replicated by the Washington
24 building industry;

25 (D) The extent to which the project leverages nonstate funds;

26 (E) The extent to which the project is ready to proceed to
27 construction;

28 (F) Whether the project promotes sustainable use of resources and
29 environmental quality;

30 (G) Whether the project is being well managed to fund maintenance
31 and capital depreciation;

32 (H) Reduction of housing and utilities carbon footprint; and

33 (I) Other criteria that the department considers necessary to
34 achieve the purpose of this program.

35 (iv) The department must monitor and track the results of the
36 housing projects that receive ultra-high energy efficiency funding
37 under this section.

38 (f) (~~(\$45,950,000)~~) \$42,950,000 of the appropriation in this
39 section is provided solely for the following list of housing

21 (g) \$6,000,000 of the appropriation for Capitol Hill Housing
22 Broadway (Seattle) in (f) of this subsection is provided solely for
23 the purchase of the three south annex properties. The state board for
24 community and technical colleges must transfer the three south annex
25 properties located at 1530 Broadway, 1534 Broadway, and 909 East Pine
26 street in Seattle to Capitol Hill Housing to provide services and
27 housing for homeless youth or young adults for a minimum of fifty
28 years. The transfer agreement between the state board for community
29 and technical colleges and Capitol Hill Housing must specify a
30 mutually agreed transfer date and require Capitol Hill Housing to
31 cover any closing costs with a total purchase price of nine million
32 dollars for all three properties. The contract between the department
33 and Capitol Hill Housing must provide that Capitol Hill Housing will
34 be responsible for maintaining and securing the property until it is
35 developed. The contract must also specify that, if Capitol Hill
36 Housing does not construct at least seventy affordable housing units
37 on the site by 2028, this funding must be fully repaid to the state
38 or the land must revert back to the state.

1 (h) \$57,050,000 of the appropriation in this section is provided
2 solely for affordable housing projects that serve and benefit low-
3 income and special needs populations in need of housing. Of the
4 amounts appropriated in this subsection, the department must allocate
5 the funds as follows:

6 (i) \$5,000,000 of the appropriation in this section is provided
7 solely for housing for veterans;

8 (ii) \$5,000,000 of the appropriation in this section is provided
9 solely for housing that serves people with developmental
10 disabilities;

11 (iii) \$5,000,000 of the appropriation in this section is provided
12 solely for housing that serves people who are employed as
13 farmworkers; and

14 (iv) (A) \$5,000,000 of the appropriation in this section is
15 provided solely for housing projects that benefit homeownership.

16 (B) During the 2019-2021 fiscal biennium, the department must use
17 a separate application form for applications to provide homeownership
18 opportunities and evaluate homeownership project applications as
19 allowed under chapter 43.185A RCW.

20 (C) In addition to the definition of "first-time home buyer" in
21 RCW 43.185A.010, for the purposes of awarding homeownership projects
22 during the 2019-2021 fiscal biennium "first time home buyer" also
23 includes:

24 (I) A single parent who has only owned a home with a former
25 spouse while married;

26 (II) An individual who is a displaced homemaker as defined in 24
27 C.F.R. Sec. 93.2 as it existed on the effective date of this section,
28 or such subsequent date as may be provided by the department by rule,
29 consistent with the purposes of this section, and has only owned a
30 home with a spouse;

31 (III) An individual who has only owned a principal residence not
32 permanently affixed to a permanent foundation in accordance with
33 applicable regulations; or

34 (IV) An individual who has only owned a property that is
35 discerned by a licensed building inspector as being uninhabitable.

36 (2) In evaluating projects in this section, the department must
37 give preference for applications based on some or all of the criteria
38 in RCW 43.185.070(5).

39 (3) (a) The department must strive to allocate all of the amounts
40 appropriated in this section within the 2019-2021 fiscal biennium in

1 the manner prescribed in subsection (1) of this section. However, if
2 upon review of applications the department determines there are not
3 adequate suitable projects in a category, the department may allocate
4 funds to projects serving other low-income and special needs
5 populations, provided those projects are located in an area with an
6 identified need for the type of housing proposed.

7 (b) By June 30, 2021, the department must report on its web site
8 the following for every previous funding cycle: The number of
9 homeownership and multifamily rental projects funded by housing trust
10 fund moneys; the percentage of housing trust fund investments made to
11 homeownership and multifamily rental projects; and the total number
12 of households being served at up to eighty percent of the area median
13 income, up to fifty percent of the area median income, and up to
14 thirty percent of the area median income, for both homeownership and
15 multifamily rental projects.

16 (4) (a) The department, in cooperation with the housing finance
17 commission, must develop and implement a process for the collection
18 of certified final development cost data from each grant or loan
19 recipient under this section. The department must use this data as
20 part of its cost containment policy.

21 (b) Beginning December 1, 2019, and continuing annually, the
22 department must provide the legislature with a report of its final
23 cost data for each project under this section. Such cost data must,
24 at a minimum, include total development cost per unit for each
25 project completed within the past year, descriptive statistics such
26 as average and median per unit costs, regional cost variation, and
27 other costs that the department deems necessary to improve cost
28 controls and enhance understanding of development costs. The
29 department must coordinate with the housing finance commission to
30 identify relevant development costs data and ensure that the measures
31 are consistent across relevant agencies.

32 (5) \$10,000,000 of the state building construction account—state
33 appropriation is provided solely for the preservation of affordable
34 multifamily housing at risk of losing affordability due to expiration
35 of use restrictions that otherwise require affordability, including,
36 but not limited to, United States department of agriculture funded
37 multifamily housing.

38 (a) Within the amount provided in this subsection (5), the
39 department must implement necessary procedures no later than July 1,
40 2020, to enable rapid commitment of funds on a first-come, first-

1 served basis to qualifying project proposals that satisfy the goal of
2 long-term preservation of Washington's affordable multifamily housing
3 stock, particularly in rural areas of the state.

4 (b) The department must adhere to the following award terms and
5 procedures for the rapid response program created with this
6 appropriation:

7 (i) The department shall evaluate applications for funding based
8 on some or all of the criteria in RCW 43.185.070(5).

9 (ii) The funding is not subject to the ninety-day application
10 periods in RCW 43.185.070 or 43.185A.050.

11 (iii) Awards must be in the form of a recoverable grant with a
12 forty-year low income housing covenant on the land.

13 (iv) If a capital needs assessment is required, the department
14 must work with the applicant to ensure that this does not create an
15 unnecessary impediment to rapidly accessing these funds.

16 (v) Awards may be used for acquisition, or for acquisition and
17 rehabilitation of, properties to preserve the affordable housing
18 units beyond existing use restrictions and keep them in Washington's
19 housing portfolio.

20 (vi) No single award may exceed \$2,500,000, although the
21 department must consider waivers of this award cap if an applicant
22 demonstrates sufficient need. If the department receives simultaneous
23 applications for funding under this program, proposals that reach the
24 greatest public benefit, as defined by the department, must be
25 prioritized. For purposes of this subsection (5), "greatest public
26 benefit" includes, but is not limited to:

27 (A) The greatest number of units that will be preserved;

28 (B) Whether the project has federally funded rental assistance
29 tied to it;

30 (C) The scarcity of the affordable housing applied for compared
31 to the number of available affordable housing units in the same
32 geographic location; and

33 (D) The program's established funding priorities under RCW
34 43.185.070(5).

35 (vii) The award limit in (vi) of this subsection (5) may only be
36 applied to the awards provided under this subsection (5). The amount
37 awarded from this subsection (5) may not be calculated in award
38 limitations for other housing trust fund awards.

23 **FOR THE DEPARTMENT OF COMMERCE**

24 Clean Energy Transition 4 (40000042)

25 The appropriations in this section are subject to the following
26 conditions and limitations:

27 (1) The appropriations are provided solely for projects that
28 provide a benefit to the public through development, demonstration,
29 and deployment of clean energy technologies that save energy and
30 reduce energy costs, reduce harmful air emissions, or increase energy
31 independence for the state. Priority must be given to projects that
32 benefit vulnerable populations, including tribes and communities with
33 high environmental or energy burden.

34 (2) In soliciting and evaluating proposals, awarding contracts,
35 and monitoring projects under this section, the department must:

1 (a) Ensure that competitive processes, rather than sole source
2 contracting processes, are used to select all projects, except as
3 otherwise noted in this section; and

4 (b) Conduct due diligence activities associated with the use of
5 public funds including, but not limited to, oversight of the project
6 selection process, project monitoring, and ensuring that all
7 applications and contracts fully comply with all applicable laws
8 including disclosure and conflict of interest statutes.

9 (3)(a) Pursuant to chapter 42.52 RCW, the ethics in public
10 service act, the department must require a project applicant to
11 identify in application materials any state of Washington employees
12 or former state employees employed by the firm or on the firm's
13 governing board during the past twenty-four months. Application
14 materials must identify the individual by name, the agency previously
15 or currently employing the individual, job title or position held,
16 and separation date. If it is determined by the department that a
17 conflict of interest exists, the applicant may be disqualified from
18 further consideration for award of funding.

19 (b) If the department finds, after due notice and examination,
20 that there is a violation of chapter 42.52 RCW, or any similar
21 statute involving a grantee who received funding under this section,
22 either in procuring or performing under the grant, the department in
23 its sole discretion may terminate the funding grant by written
24 notice. If the grant is terminated, the department must reserve its
25 right to pursue all available remedies under law to address the
26 violation.

27 (4) The requirements in subsections (2) and (3) of this section
28 must be specified in funding agreements issued by the department.

29 (5) \$6,107,000 of the state building construction account—state
30 appropriation is provided solely for grid modernization grants for
31 projects that: Advance clean and renewable energy technologies and
32 transmission and distribution control systems; support integration of
33 renewable energy sources, deployment of distributed energy resources,
34 and sustainable microgrids; and increase utility customer options for
35 energy sources, energy efficiency, energy equipment, and utility
36 services.

37 (a) Projects must be implemented by public and private electrical
38 utilities that serve retail customers in the state. Priority must be
39 given to: (i) Projects that benefit vulnerable populations, including
40 tribes and communities with high environmental or energy burden; and

1 (ii) projects that have a partner that is a tribe or nonprofit
2 organization that serves community eligible entities. Utilities may
3 partner with other public and private sector research organizations,
4 businesses, tribes, and nonprofit organizations in applying for
5 funding.

6 (b) The department shall develop a grant application process to
7 competitively select projects for grant awards, to include scoring
8 conducted by a group of qualified experts with application of
9 criteria specified by the department. In development of the
10 application criteria, the department shall, to the extent possible,
11 allow smaller utilities or consortia of small utilities to apply for
12 funding.

13 (c) Applications for grants must disclose all sources of public
14 funds invested in a project.

15 (d) \$4,400,000 of the state building construction account—state
16 appropriation is provided solely for providing shore power
17 electrification at terminal five for the northwest seaport alliance.
18 In order to receive this grant, the northwest seaport alliance must
19 demonstrate that they applied to the VW settlement for this project
20 and were denied.

21 (6) (a) \$8,100,000 of the state building construction account—
22 state appropriation is provided solely for competitive grants for
23 strategic research and development for new and emerging clean energy
24 technologies. These grants will be used to match federal or other
25 nonstate funds to research, develop, and demonstrate clean energy
26 technologies.

27 (b) The department shall consult and coordinate with the
28 University of Washington, Washington State University, the Pacific
29 Northwest national laboratory and other clean energy organizations to
30 design the grant program. Clean energy organizations who compete for
31 grants from the program may not participate in the design of the
32 grant program. Criteria for the grant program must include life cycle
33 cost analysis for projects that are part of the competitive process.

34 (c) The program may include, but is not limited to: Solar
35 technologies, advanced bioenergy and biofuels, development of new
36 earth abundant materials or lightweight materials, advanced energy
37 storage, battery components recycling, and new renewable energy and
38 energy efficiency technologies.

1 (d) \$1,000,000 of the state building construction account—state
2 appropriation is provided solely for grants that enhance the
3 viability of dairy digester bioenergy projects, energy efficiency,
4 and resource recovery to demonstrate advanced nutrient recovery
5 systems that produce value added biofertilizers, reduce trucking of
6 lagoon water, and improve soil health and air and water quality.
7 Grants shall include at least one project east of the Cascades and
8 one project west of the Cascades. State agencies must promote and
9 demonstrate the use of such recovered biofertilizers through state
10 procurement and contracts.

11 (7) (a) \$3,000,000 of the state taxable building construction
12 account—state appropriation is provided solely as grants to nonprofit
13 lenders to create a revolving loan fund to support the widespread use
14 of proven energy efficiency and renewable energy technologies by
15 households with high energy burden or environmental health risk now
16 inhibited by lack of access to capital.

17 (b) The department shall provide grant funds to one or more
18 competitively selected nonprofit lenders that will provide matching
19 private capital and will administer the loan fund. The department
20 must select the loan fund administrator or administrators through a
21 competitive process, with scoring conducted by a group of qualified
22 experts, applying criteria specified by the department.

23 (c) The department must establish guidelines that specify
24 applicant eligibility, the screening process, and evaluation and
25 selection criteria. The guidelines must be used by the nonprofit
26 lenders.

27 (8) \$5,000,000 of the state building construction account—state
28 appropriation is provided solely for the Washington Maritime
29 Innovation Center. The center must be used to support technology
30 acceleration and incubation, and act as a focal point for maritime
31 sustainability, including, but not limited to, supporting technology
32 development for maritime decarbonization and electrification.

33 (9) \$8,300,000 of the state taxable construction account—state
34 appropriation is provided solely for scientific instruments to help
35 accelerate research in grid-scale energy storage at the proposed
36 grid-scale energy storage research, development, and testing facility
37 at the Pacific Northwest national laboratory. The state funds are
38 contingent on securing federal funds for the new facility, and are
39 provided as a match to the federal funding. The instruments will

1 support collaborations with the University of Washington and the
2 Washington State University.

3 (10) \$593,000 of the state building construction account—state
4 appropriation is provided solely to the port of Grays Harbor for an
5 offshore ocean wave renewable energy demonstration project.

6 (11) \$1,500,000 of the state building construction account—state
7 appropriation is provided solely to the (~~Port of~~) Skagit county
8 public works department for the Guemes ferry dock shore power
9 charging infrastructure.

20 2019-21 Behavioral Health Capacity Grants (40000114)

21 The appropriation in this section is subject to the following
22 conditions and limitations:

23 (1) The appropriation in this section is provided solely for the
24 department of commerce to issue grants to community hospitals or
25 other community providers to expand and establish new capacity for
26 behavioral health services in communities. The department of commerce
27 must consult an advisory group consisting of representatives from the
28 department of social and health services, the health care authority,
29 one representative from a managed care organization, one
30 representative from an accountable care organization, and one
31 representative from the association of county human services. Amounts
32 provided in this section may be used for construction and equipment
33 costs associated with establishment of the facilities. The department
34 of commerce may approve funding for the acquisition of a facility or
35 land if the project results in increased capacity. Amounts provided
36 in this section may not be used for operating costs associated with
37 the treatment of patients using these services.

1 (2) The department must establish criteria for the issuance of
2 the grants, which must include:

3 (a) Evidence that the application was developed in collaboration
4 with one or more regional behavioral health entities that administer
5 the purchasing of services;

6 (b) Evidence that the applicant has assessed and would meet gaps
7 in geographical behavioral health services needs in their region;

8 (c) Evidence that the applicant is able to meet applicable
9 licensing and certification requirements in the facility that will be
10 used to provide services;

11 (d) A commitment by applicants to serve persons who are publicly
12 funded and persons detained under the involuntary treatment act under
13 chapter 71.05 RCW;

14 (e) A commitment by the applicant to maintain and operate the
15 beds or facility for a time period commensurate to the state
16 investment, but for at least a fifteen-year period;

17 (f) The date upon which structural modifications or construction
18 would begin and the anticipated date of completion of the project;

25 (4) Project funds are available on a reimbursement basis only,
26 and shall not be advanced under any circumstances.

27 (5) In contracts for grants authorized under this section the
28 department shall include provisions which require that capital
29 improvements be held by the grantee for a specified period of time
30 appropriate to the amount of the grant and that facilities be used
31 for the express purpose of the grant. If the grantee is found to be
32 out of compliance with provisions of the contract, the grantee shall
33 repay to the state general fund the principal amount of the grant

23 infrastructure plans by local or regional entities, and potential
24 public infrastructure needs;

25 (D) Transportation corridors in the immediate area and any
26 potential right-of-way needs; and

27 (E) Existing zoning regulations for the land and potential future
28 zoning needs to evaluate workforce housing, affordable housing, and
29 other commercial and industrial development compatible with the
30 Ballard-Interbay manufacturing industrial center designation;

31 (iii) Explore the potential funding sources and partners as well
32 as any needed transactions, and make recommendations, including:

33 (A) Any potential private partners or investors;

34 (B) Necessary real estate transactions;

35 (C) Federal funding opportunities; and

36 (D) State and local funding sources, including any tax-related
37 programs; and

38 (iv) Conduct at least three public meetings at a location within
39 the Ballard-Interbay manufacturing industrial center, where a quorum
40 of the Interbay public development advisory committee members are

10 (g) Legislative members of the Interbay advisory committee are
11 reimbursed for travel in accordance with RCW 44.04.120.
12 Nonlegislative members are not entitled to be reimbursed for travel
13 expenses if they are elected officials or are participating on behalf
14 of an employer, governmental entity, or other organization. Any
15 reimbursement for other nonlegislative members is subject to chapter

5 solely for the Harmony sports complex infrastructure and safety
6 improvements in Vancouver and is contingent upon the facility being
7 open to the public.

8 (15) \$250,000 of the appropriation in this section is provided
9 solely for the Asia Pacific cultural center in Tacoma. It is the
10 intent of the legislature that beyond the 2017-2019 fiscal biennium
11 no state funding is provided to the Asia Pacific cultural center in
12 Tacoma.
