1 AN ACT Relating to funding the governor's security and protection
2 while traveling outside Washington state for campaign-related or
3 nonstate business purposes; amending 2018 c 299 ss 116 and 402
4 (uncodified); adding a new section to chapter 43.06 RCW; creating new
5 sections; and making appropriations.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

7 NEW SECTION. **Sec. 1.** (1) The legislature finds that an increase
8 in the governor's out-of-state travel for campaign-related or other
9 nonstate business purposes is causing a budget shortfall in the
10 funding for the executive protection unit in the Washington state
11 patrol. The legislature supports the Washington state patrol
12 providing protection and security for the governor and the governor's
13 family as provided in RCW 43.43.035; however, the legislature finds
14 that the cost of protection and security for this extra travel not
15 related to state business and at the governor's discretion should not
16 be borne by the taxpayers of Washington state.

17 (2)(a) The legislature intends to resolve this current budget
18 shortfall by reducing existing appropriations to the governor's
19 office by the amount of the estimated shortfall for fiscal year 2019
20 and increasing the current fiscal year 2019 appropriation to the
21 Washington state patrol by that amount.

1 (b) The legislature intends to address this in the future by
2 creating the account in section 2 of this act to which private
3 contributions can be made to offset the extra protection and security
4 costs as a result of the travel described in this section. To the
5 extent private contributions do not cover the extra costs, the
6 legislature intends to reduce appropriations to the governor's office
7 and increase appropriations to the Washington state patrol by the
8 amount of the uncovered extra costs.

9 NEW SECTION. **Sec. 2.** A new section is added to chapter 43.06
10 RCW to read as follows:

11 The governor's nonstate business travel reimbursement account is
12 created in the custody of the state treasurer. Any gifts, grants, or
13 donations received by the governor's office to reimburse the state
14 for protection and security costs associated with the governor's out-
15 of-state travel for campaign-related or other nonstate business
16 purposes shall be deposited in the account. Expenditures from the
17 account may only be used to reimburse the Washington state patrol for
18 protection and security costs associated with the governor's out-of-
19 state travel for campaign-related or other nonstate business
20 purposes. Only the governor or governor's designee may authorize
21 expenditures from the account. The account is not subject to
22 allotment procedures and an appropriation is not required for
23 expenditures.

24 NEW SECTION. **Sec. 3.** By December 1, 2019, and December 1, 2020,
25 the governor and the Washington state patrol shall report to the ways
26 and means committee in the senate and the appropriations committee in
27 the house of representatives on the governor's out-of-state travel
28 and associated protection and security costs. The report must
29 specifically identify all travel considered to be out-of-state travel
30 for campaign-related or other nonstate business purposes and must
31 specifically identify the protection and security costs associated
32 with those trips. The report must also summarize the deposits and
33 expenditures related to the account created in section 2 of this act
34 for the period of the report.

36 follows:

10 The appropriations in this section are subject to the following
11 conditions and limitations:

12 (1) \$703,000 of the general fund—state appropriation for fiscal
13 year 2018 and \$703,000 of the general fund—state appropriation for
14 fiscal year 2019 are provided solely for the office of the education
15 ombuds.

16 (2) \$730,000 of the general fund—state appropriation for fiscal
17 year 2018 is provided solely for implementation of Engrossed Second
18 Substitute House Bill No. 1661 (child, youth, families/department).
19 The amount of state and federal funding to be transferred from the
20 department of social and health services to the department of
21 children, youth, and families for the working connections child care
22 services, administration, and staff must be included in the report
23 required by the bill on how to incorporate the staff responsible for
24 determining eligibility for the working connections child care
25 program into the department of children, youth, and families. If the
26 bill is not enacted by July 31, 2017, the amount provided in this
27 subsection shall lapse.

28 (3) \$1,216,000 of the general fund—state appropriation for fiscal
29 year 2019 is provided solely for implementation of Engrossed Second
30 Substitute House Bill No. 1889 (corrections ombuds). If the bill is
31 not enacted by June 30, 2018, the amount provided in this subsection
32 shall lapse.

33 (4) \$5,000 of the general fund—state appropriation for fiscal
34 year 2018 and \$5,000 of the general fund—state appropriation for
35 fiscal year 2019 are provided to the office of the governor to
36 support the Ruth Woo fellow. Funding will provide financial support
37 for the Ruth Woo fellow participating in the governor's leadership
38 academy internship program.

1 (5) \$291,000 of the general fund—state appropriation for fiscal
2 year 2019 is provided solely for implementation of Engrossed House
3 Bill No. 2759 (women's commission). If the bill is not enacted by
4 June 30, 2018, the amount provided in this subsection shall lapse.

33 The appropriations in this section are subject to the following
34 conditions and limitations:

35 (1) \$270,000 of the fire service training account—state
36 appropriation is provided solely for two FTEs in the office of the
37 state director of fire protection to exclusively review K-12

1 construction documents for fire and life safety in accordance with
2 the state building code. It is the intent of this appropriation to
3 provide these services only to those districts that are located in
4 counties without qualified review capabilities.

5 (2) \$12,400,000 of the disaster response account—state
6 appropriation is provided solely for Washington state fire service
7 resource mobilization costs incurred in response to an emergency or
8 disaster authorized under RCW 43.43.960 through 43.43.964. The state
9 patrol shall submit a report quarterly to the office of financial
10 management and the legislative fiscal committees detailing
11 information on current and planned expenditures from this account.
12 This work shall be done in coordination with the military department.

13 (3) \$700,000 of the fire service training account—state
14 appropriation is provided solely for the firefighter apprenticeship
15 training program.

16 (4) \$41,000 of the general fund—state appropriation for fiscal
17 year 2018 and \$41,000 of the general fund—state appropriation for
18 fiscal year 2019 are provided solely for implementation of chapter
19 272, Laws of 2017 (E2SHB 1163) (domestic violence).

20 (5) \$125,000 of the general fund—state appropriation for fiscal
21 year 2018 and \$116,000 of the general fund—state appropriation for
22 fiscal year 2019 are provided solely for implementation of chapter
23 261, Laws of 2017 (SHB 1501) (attempts to obtain firearms).

24 (6) \$104,000 of the general fund—state appropriation for fiscal
25 year 2018 and \$90,000 of the general fund—state appropriation for
26 fiscal year 2019 are provided solely for implementation of chapter
27 308, Laws of 2017 (SHB 1863) (fire incident reporting system).

28 (7) \$3,421,000 of the fingerprint identification account—state
29 appropriation is provided solely for the completion of the state
30 patrol's plan to upgrade the criminal history system, and is subject
31 to the conditions, limitations, and review provided in section 724 of
32 this act.

33 (8) \$1,039,000 of the fingerprint identification account—state
34 appropriation is provided solely for the implementation of a sexual
35 assault kit tracking database project and is subject to the
36 conditions, limitations, and review provided in section 724 of this
37 act.

38 (9) \$495,000 of the general fund—state appropriation for fiscal
39 year 2019 is provided solely for the costs related to the 1995 king

1 air maintenance. By June 30, 2019, the state patrol is directed to
2 sell the 1983 king air and proceeds generated from the sale of the
3 1983 king air must be deposited into the state patrol highway
4 account.

5 (10) \$2,803,000 of the dedicated marijuana account—state
6 appropriation for fiscal year 2019 is provided solely for the
7 Washington state patrol to create a new drug enforcement task force
8 for the purposes of controlling the potential diversion and illicit
9 production or distribution of marijuana and marijuana-related
10 products in Washington.

11 (11) \$100,000 of the general fund—state appropriation for fiscal
12 year 2019 is provided solely for the Washington state patrol to
13 coordinate with the governor's office of Indian affairs, federally
14 recognized tribal governments, and the U.S. justice department to
15 conduct a study to determine how to increase state criminal justice
16 protective and investigative resources for reporting and identifying
17 missing Native American women in the state.

18 (12) The amounts in this subsection are provided solely for
19 implementing the recommendations of the joint legislative task force
20 on sexual assault forensic examination, and for monitoring and
21 testing untested sexual assault examination kits.

22 (a) \$500,000 of the general fund—state appropriation for fiscal
23 year 2019 is provided solely for the state patrol to:

24 (i) Work in conjunction with state or nonstate entities to test
25 sexual assault kits pursuant to RCW 43.43.545;

26 (ii) Conduct forensic analysis of sexual assault examination kits
27 in the custody of the state patrol pursuant to chapter 247, Laws of
28 2015; and

29 (~~(iii)~~) (iii) Continue the task force.

30 (b) \$1,375,000 of the general fund—state appropriation for fiscal
31 year 2018 and \$1,375,000 of the general fund—state appropriation for
32 fiscal year 2019 are provided solely for the implementation of
33 chapter 247, Laws of 2015 to address the state's backlog in sexual
34 assault examination kits. The seven full-time employees funded under
35 this subsection must work exclusively on processing sexual assault
36 exam kits through the crime laboratory division.

37 (c) Within amounts provided in this section, the Washington state
38 patrol shall adopt rules necessary to implement RCW 43.43.545.

1 (13) \$715,000 of the general fund—state appropriation for fiscal
2 year 2019 is provided solely for cost increases in the executive
3 protection unit.
