1 AN ACT Relating to providing funding for the Washington state  
2 library-archives building and operations of library and archives  
3 facilities; amending RCW 36.18.010, 36.22.175, 36.22.175, 43.07.128,  
4 43.07.129, and 43.07.370; reenacting and amending RCW 43.79A.040;  
5 adding a new section to chapter 43.07 RCW; creating new sections;  
6 providing an effective date; and providing an expiration date.

7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

8 NEW SECTION. **Sec. 1.** The legislature finds that the current  
9 facilities housing the Washington state archives, Washington state  
10 library, Washington state corporations and charities office, and the  
11 state elections office is in need of modernization and update. This  
12 is due to these vital programs being housed in obsolete and crowded  
13 facilities that do not meet modern standards for the functions  
14 performed in each.

15 It is the intent of the secretary of state and the legislature to  
16 preserve and protect the state's vital records and collections,  
17 provide convenient service to the public, be excellent stewards of  
18 state funds, and house staff and collections in a state of the art,  
19 energy efficient building owned and operated by the office of the  
20 secretary of state. This will be accomplished by creating a new  
21 building funded by a certificate of participation. Certificate of

1 participation debt will be serviced by existing rents, existing fees,  
2 and a new fee on documents recorded at county recording offices.

3 This building, to be known as the library-archives building, will  
4 replace the existing state archives, the existing leased library  
5 location, the existing leased elections office, and the corporations  
6 and charities building on Capitol Way in addition to consolidating  
7 other archival structures. The consolidation of facilities will  
8 create efficiency under RCW 43.82.010(6) and convenience for  
9 customers with the eventual goal of housing all functions of the  
10 various divisions of the office of the secretary of state free of  
11 ongoing rent after payment of the certificate of participation debt.

12 NEW SECTION. **Sec. 2.** (1) The secretary of state shall enter  
13 into a financing contract (certificate of participation) for up to  
14 one hundred eight million dollars, plus financing expenses, less  
15 current and previous appropriations and required reserves pursuant to  
16 RCW 39.94.050, to construct the library-archives building in the city  
17 of Tumwater, Washington, for the state library, archives, and other  
18 divisions of the secretary of state's office in Tumwater, Washington,  
19 at 7370 Linderson Way. The building must be delivered using a general  
20 contractor/construction manager, as defined in RCW 39.10.210, with a  
21 guarantee for energy, operations, and maintenance performance.

22 (2) All omnibus capital appropriations act expenses relating to  
23 the library-archives project, less current and previous  
24 appropriations, must be financed with a certificate of participation  
25 or other financing method fully supported using fees and other  
26 revenue collected by the secretary of state. The secretary of state  
27 may consider the adjustment of fees, including the library operations  
28 account, and the library-archives building account, to support  
29 construction and future operating costs.

30 (3) The secretary of state's office shall oversee design and  
31 construction of the facility and own and operate the library-archives  
32 building. The secretary of state's office is authorized to enter into  
33 a long-term land lease from the port of Olympia for a period of up to  
34 seventy-five years. To comply with the provisions of this section,  
35 this project is exempt from the provisions of RCW 43.82.010.

36 (4) The director of enterprise services will delegate any and all  
37 functions under RCW 43.19.450 (1) and (3) to the secretary of state's  
38 office for the duration of the life of this project and completed  
39 facility.

1 (5) Original furniture and fixtures from the capitol campus  
2 currently not in use elsewhere may be transferred for use in the  
3 library-archives building. Furniture and fixtures currently in use by  
4 secretary of state divisions planned for the new facility that are  
5 part of the capitol campus original furnishings may be utilized for  
6 the new facility but must be returned to the capitol furnishings  
7 committee if not needed.

8 **Sec. 3.** RCW 36.18.010 and 2015 3rd sp.s. c 28 s 1 are each  
9 amended to read as follows:

10 County auditors or recording officers shall collect the following  
11 fees for their official services:

12 (1) For recording instruments, for the first page eight and one-  
13 half by fourteen inches or less, five dollars; for each additional  
14 page eight and one-half by fourteen inches or less, one dollar. The  
15 fee for recording multiple transactions contained in one instrument  
16 will be calculated for each transaction requiring separate indexing  
17 as required under RCW 65.04.050 as follows: The fee for each title or  
18 transaction is the same fee as the first page of any additional  
19 recorded document; the fee for additional pages is the same fee as  
20 for any additional pages for any recorded document; the fee for the  
21 additional pages may be collected only once and may not be collected  
22 for each title or transaction;

23 (2) For preparing and certifying copies, for the first page eight  
24 and one-half by fourteen inches or less, three dollars; for each  
25 additional page eight and one-half by fourteen inches or less, one  
26 dollar;

27 (3) For preparing noncertified copies, for each page eight and  
28 one-half by fourteen inches or less, one dollar;

29 (4) For administering an oath or taking an affidavit, with or  
30 without seal, two dollars;

31 (5) For issuing a marriage license, eight dollars, (this fee  
32 includes taking necessary affidavits, filing returns, indexing, and  
33 transmittal of a record of the marriage to the state registrar of  
34 vital statistics) plus an additional five dollar fee for use and  
35 support of the prevention of child abuse and neglect activities to be  
36 transmitted monthly to the state treasurer and deposited in the state  
37 general fund plus an additional ten dollar fee to be transmitted  
38 monthly to the state treasurer and deposited in the state general  
39 fund. The legislature intends to appropriate an amount at least equal

1 to the revenue generated by this fee for the purposes of the  
2 displaced homemaker act, chapter 28B.04 RCW;

3 (6) For searching records per hour, eight dollars;

4 (7) For recording plats, fifty cents for each lot except cemetery  
5 plats for which the charge shall be twenty-five cents per lot; also  
6 one dollar for each acknowledgment, dedication, and description:  
7 PROVIDED, That there shall be a minimum fee of twenty-five dollars  
8 per plat;

9 (8) For recording of miscellaneous records not listed above, for  
10 the first page eight and one-half by fourteen inches or less, five  
11 dollars; for each additional page eight and one-half by fourteen  
12 inches or less, one dollar;

13 (9) For modernization and improvement of the recording and  
14 indexing system, a surcharge as provided in RCW 36.22.170;

15 (10) For recording an emergency nonstandard document as provided  
16 in RCW 65.04.047, fifty dollars, in addition to all other applicable  
17 recording fees;

18 (11) For recording instruments, a three dollar surcharge to be  
19 deposited into the Washington state (~~heritage center~~) library  
20 operations account created in RCW 43.07.129;

21 (12) For recording instruments, a two dollar surcharge to be  
22 deposited into the Washington state library-archives building account  
23 created in section 9 of this act until the certificate of  
24 participation described in section 2 of this act is paid in full;

25 (13) For recording instruments, a surcharge as provided in RCW  
26 36.22.178; and

27 (~~(13)~~) (14) For recording instruments, except for documents  
28 recording a birth, marriage, divorce, or death or any documents  
29 otherwise exempted from a recording fee under state law, a surcharge  
30 as provided in RCW 36.22.179.

31 **Sec. 4.** RCW 36.22.175 and 2017 c 303 s 7 are each amended to  
32 read as follows:

33 (1)(a) In addition to any other charge authorized by law, the  
34 county auditor shall charge a surcharge of one dollar per instrument  
35 for each document recorded. Revenue generated through this surcharge  
36 shall be transmitted monthly to the state treasurer for deposit in  
37 the local government archives account under RCW 40.14.024. These  
38 funds shall be used solely for providing records schedule compliance,  
39 security microfilm inspection and storage, archival preservation,

1 cataloging, and indexing for local government records and digital  
2 data and access to those records and data through the regional branch

2 amended to read as follows:

3       (1)(a) In addition to any other charge authorized by law, the  
4 county auditor shall charge a surcharge of one dollar per instrument  
5 for each document recorded. Revenue generated through this surcharge  
6 shall be transmitted monthly to the state treasurer for deposit in  
7 the local government archives account under RCW 40.14.024. These  
8 funds shall be used solely for providing records scheduling, security  
9 microfilm inspection and storage, archival preservation, cataloging,

6 applications for certificates of authority for foreign corporations  
7 under Title 23B RCW;

8       (b) Certificates of formation for domestic limited liability  
9 companies or registrations of foreign limited liability companies  
10 under chapter 25.15 RCW;

11       (c) Registrations of foreign and domestic partnerships and  
12 limited liability partnerships under chapter 25.05 RCW;

24 received under RCW 36.18.010(11) and 43.07.128 must be deposited in  
25 the account. Expenditures from the account may be made only for the  
26 following purposes:

27       (1) Payment of the certificate of participation issued for the  
28 Washington state (~~heritage center~~) library-archives building;

29       (2) Capital maintenance of the Washington state (~~heritage~~  
30 ~~center~~) library-archives building and the specialized regional  
31 facility located in eastern Washington designed to serve the  
32 archives, records management, and digital data management needs of  
33 local government; and

34       (3) Program operations that serve the public, relate to the

3 ~~biennium, the legislature may appropriate from the Washington state~~  
4 ~~heritage center account for the purposes of state arts, historical,~~  
5 ~~and library programs. Additionally, during the 2011-2013 fiscal~~  
6 ~~biennium, the legislature may transfer from the Washington state~~

9 **Sec. 8.** RCW 43.07.370 and 2009 c 71 s 1 are each amended to read  
10 as follows:

11 (1) The secretary of state may solicit and accept gifts, grants,  
12 conveyances, bequests, and devises of real or personal property, or  
13 both, in trust or otherwise, and sell, lease, exchange, invest, or  
14 expend these donations or the proceeds, rents, profits, and income  
15 from the donations except as limited by the donor's terms.

16 (2) Moneys received under this section may be used only for the  
17 following purposes:

18 (a) Conducting the Washington state legacy project;

19 (b) Archival activities;

20 (c) Washington state library activities;

21 (d) Development, construction, and operation of the Washington  
22 state (~~heritage center~~) library-archives building; and

23 (e) Donation of Washington state flags.

24 (3)(a) Moneys received under subsection (2)(a) through (c) of  
25 this section must be deposited in the Washington state legacy  
26 project, state library, and archives account established in RCW

33 be deposited in the Washington state flag account created in RCW

35 (4) The secretary of state shall adopt rules to govern and  
36 protect the receipt and expenditure of the proceeds.

37 NEW SECTION. **Sec. 9.** A new section is added to chapter 43.07  
38 RCW to read as follows:

1       The Washington state library-archives building account is created  
2 in the custody of the state treasurer. All moneys received under RCW  
3 36.18.010(12), 36.22.175(3), and 43.07.370(3) must be deposited in  
4 the account. Expenditures from the account may be made only for the  
5 purposes of payment of the certificate of participation issued for  
6 the Washington state library-archives building. Only the secretary of  
7 state or the secretary of state's designee may authorize expenditures  
8 from the account. An appropriation is not required for expenditures,  
9 but the account is subject to allotment procedures under chapter  
10 43.88 RCW.

11       **Sec. 10.** RCW 43.79A.040 and 2018 c 260 s 28, 2018 c 258 s 4, and  
12 2018 c 127 s 6 are each reenacted and amended to read as follows:

13       (1) Money in the treasurer's trust fund may be deposited,  
14 invested, and reinvested by the state treasurer in accordance with  
15 RCW 43.84.080 in the same manner and to the same extent as if the  
16 money were in the state treasury, and may be commingled with moneys  
17 in the state treasury for cash management and cash balance purposes.

18       (2) All income received from investment of the treasurer's trust  
19 fund must be set aside in an account in the treasury trust fund to be  
20 known as the investment income account.

21       (3) The investment income account may be utilized for the payment  
22 of purchased banking services on behalf of treasurer's trust funds  
23 including, but not limited to, depository, safekeeping, and  
24 disbursement functions for the state treasurer or affected state  
25 agencies. The investment income account is subject in all respects to  
26 chapter 43.88 RCW, but no appropriation is required for payments to  
27 financial institutions. Payments must occur prior to distribution of  
28 earnings set forth in subsection (4) of this section.

29       (4)(a) Monthly, the state treasurer must distribute the earnings  
30 credited to the investment income account to the state general fund  
31 except under (b), (c), and (d) of this subsection.

32       (b) The following accounts and funds must receive their  
33 proportionate share of earnings based upon each account's or fund's  
34 average daily balance for the period: The 24/7 sobriety account, the  
35 Washington promise scholarship account, the Gina Grant Bull memorial  
36 legislative page scholarship account, the Washington advanced college  
37 tuition payment program account, the Washington college savings  
38 program account, the accessible communities account, the Washington

12 revolving account, the fruit and vegetable inspection account, the

30 class C purse fund account, the individual development account

34 cigarette ignition propensity account, the center for childhood  
35 deafness and hearing loss account, the school for the blind account,

38 board insurance reserve fund, (~~the~~) the public employees' and

2 and the library operations account.

3 (c) The following accounts and funds must receive eighty percent  
4 of their proportionate share of earnings based upon each account's or  
5 fund's average daily balance for the period: The advanced right-of-  
6 way revolving fund, the advanced environmental mitigation revolving  
7 account, the federal narcotics asset forfeitures account, the high  
8 occupancy vehicle account, the local rail service assistance account,  
9 and the miscellaneous transportation programs account.

10 (d) Any state agency that has independent authority over accounts  
11 or funds not statutorily required to be held in the custody of the  
12 state treasurer that deposits funds into a fund or account in the  
13 custody of the state treasurer pursuant to an agreement with the  
14 office of the state treasurer shall receive its proportionate share  
15 of earnings based upon each account's or fund's average daily balance
