- 1 AN ACT Relating to notifying Washington consumers of products
- 2 that transmit user data; adding a new chapter to Title 19 RCW; and
- 3 providing an expiration date.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** The definitions in this section apply 6 throughout this chapter unless the context clearly requires
- 7 otherwise.
- 8 (1) "Connected device" means any device or other physical object
- 9 that is capable of connecting to the internet, directly or
- 10 indirectly, and that is assigned an internet protocol address or
- 11 bluetooth address.
- 12 (2) "Office" means the office of privacy and data protection.
- 13 (3) "User data" means any information.
- 14 NEW SECTION. Sec. 2. (1) The office shall develop a user data
- 15 transmission sticker for the purpose of notifying Washington
- 16 consumers that a connected device has the capability to transmit user
- 17 data to the device manufacturer or any separate business entity. The
- 18 data transmission sticker must:
- 19 (a) Have a design that is easily identifiable and understandable
- 20 to children and adults;

- 1 (b) Include a graphic that appeals to children and adults;
- 2 (c) Be effective in alerting consumers that the product collects 3 and transmits user data to the device manufacturer or any separate 4 business entity; and
- 5 (d) Be easy to use for manufacturers and retailers of applicable connected devices.
- 7 (2) In determining whether a sticker design meets the 8 requirements specified under subsection (1) of this section, the 9 office must:
- 10 (a) Facilitate focus group discussions with children and adults 11 to solicit feedback on the design of the sticker; and
- 12 (b) Research existing labels intended to appeal to both children 13 and adults to use as a model for the sticker.
- 14 (3) This section expires January 1, 2022.
- NEW SECTION. Sec. 3. (1) Effective January 1, 2022, it is unlawful for a person or entity in Washington to sell or offer for sale at retail a connected device product that transmits user data to the device manufacturer or any separate business entity, unless the product package is labeled with a user data transmission sticker developed by the office.
- 21 (2) The user data transmission sticker must be:
- 22 (a) Placed in a prominent location on the principal display panel 23 or front of the product package;
- 24 (b) Of a size so as to be legible and readily visible by the 25 consumer:
- 26 (c) No smaller than an inch in diameter, unless recommended by 27 the office;
- 28 (d) Displayed on the product package in a manner that is not 29 altered or cropped; and
- 30 (e) Made available by the office in digital form to manufacturers 31 without cost. The digital file for the user data transmission sticker 32 must be made available on the office's web site.
- 33 (3) The office may adopt rules necessary to implement this 34 section.
- 35 <u>NEW SECTION.</u> **Sec. 4.** Sections 1 through 3 of this act 36 constitute a new chapter in Title 19 RCW.
