1 AN ACT Relating to paid family and medical leave; amending RCW
2 50A.05.010, 50A.10.010, 50A.10.040, 50A.15.020, 50A.15.060,
3 50A.15.080, 50A.15.100, 50A.25.070, 50A.30.010, 50A.30.035,
4 50A.40.010, 50A.40.020, 50A.40.030, 50A.50.010, and 26.23.060; adding
5 new sections to chapter 50A.40 RCW; and adding a new section to
6 chapter 50A.05 RCW.

7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

8 **Sec. 1.** RCW 50A.05.010 and 2019 c 13 s 1 are each amended to
9 read as follows:

10 Unless the context clearly requires otherwise, the definitions in
11 this section apply throughout this title.

12 (1)(a) "Casual labor" means work that:

13 (i) Is performed infrequently and irregularly; and

14 (ii) If performed for an employer, does not promote or advance
15 the employer's customary trade or business.

16 (b) For purposes of casual labor:

17 (i) "Infrequently" means work performed twelve or fewer times per
18 calendar quarter; and

19 (ii) "Irregularly" means work performed not on a consistent
20 cadence.

1 (2) "Child" includes a biological, adopted, or foster child, a
2 stepchild, a child's spouse, or a child to whom the employee stands
3 in loco parentis, is a legal guardian, or is a de facto parent,
4 regardless of age or dependency status.

5 ~~((2))~~ (3) "Commissioner" means the commissioner of the
6 department or the commissioner's designee.

7 ~~((3))~~ (4) "Department" means the employment security
8 department.

9 ~~((4))~~ (5)(a) "Employee" means an individual who is in the
10 employment of an employer.

11 (b) "Employee" does not include employees of the United States of
12 America.

13 ~~((5))~~ (6) "Employee's average weekly wage" means the quotient
14 derived by dividing the employee's total wages during the two
15 quarters of the employee's qualifying period in which total wages
16 were highest by twenty-six. If the result is not a multiple of one
17 dollar, the department must round the result to the next lower
18 multiple of one dollar.

19 ~~((6))~~ (7)(a) "Employer" means: (i) Any individual or type of
20 organization, including any partnership, association, trust, estate,
21 joint stock company, insurance company, limited liability company, or
22 corporation, whether domestic or foreign, or the receiver, trustee in
23 bankruptcy, trustee, or the legal representative of a deceased
24 person, having any person in employment or, having become an
25 employer, has not ceased to be an employer as provided in this title;
26 (ii) the state, state institutions, and state agencies; and (iii) any
27 unit of local government including, but not limited to, a county,
28 city, town, municipal corporation, quasi-municipal corporation, or
29 political subdivision.

30 (b) "Employer" does not include the United States of America.

31 ~~((7))~~ (8)(a) "Employment" means personal service, of whatever
32 nature, unlimited by the relationship of master and servant as known
33 to the common law or any other legal relationship performed for wages
34 or under any contract calling for the performance of personal
35 services, written or oral, express or implied. The term "employment"
36 includes an individual's entire service performed within or without
37 or both within and without this state, if:

38 (i) The service is localized in this state; or

39 (ii) The service is not localized in any state, but some of the
40 service is performed in this state; and

1 (A) The base of operations of the employee is in the state, or if
2 there is no base of operations, then the place from which such
3 service is directed or controlled is in this state; or

4 (B) The base of operations or place from which such service is
5 directed or controlled is not in any state in which some part of the
6 service is performed, but the individual's residence is in this
7 state.

8 (b) "Employment" does not include:

9 (i) Self-employed individuals;

10 (ii) Casual labor;

11 (iii) Services for remuneration when it is shown to the
12 satisfaction of the commissioner that:

13 (A) (I) Such individual has been and will continue to be free from
14 control or direction over the performance of such service, both under
15 his or her contract of service and in fact; and

16 (II) Such service is either outside the usual course of business
17 for which such service is performed, or that such service is
18 performed outside of all the places of business of the enterprises
19 for which such service is performed; and

20 (III) Such individual is customarily engaged in an independently
21 established trade, occupation, profession, or business, of the same
22 nature as that involved in the contract of service; or

23 (B) As a separate alternative:

24 (I) Such individual has been and will continue to be free from
25 control or direction over the performance of such service, both under
26 his or her contract of service and in fact; and

27 (II) Such service is either outside the usual course of business
28 for which such service is performed, or that such service is
29 performed outside of all the places of business of the enterprises
30 for which such service is performed, or the individual is
31 responsible, both under the contract and in fact, for the costs of
32 the principal place of business from which the service is performed;
33 and

34 (III) Such individual is customarily engaged in an independently
35 established trade, occupation, profession, or business, of the same
36 nature as that involved in the contract of service, or such
37 individual has a principal place of business for the work the
38 individual is conducting that is eligible for a business deduction
39 for federal income tax purposes; and

1 (IV) On the effective date of the contract of service, such
2 individual is responsible for filing at the next applicable filing
3 period, both under the contract of service and in fact, a schedule of
4 expenses with the internal revenue service for the type of business
5 the individual is conducting; and

6 (V) On the effective date of the contract of service, or within a
7 reasonable period after the effective date of the contract, such
8 individual has established an account with the department of revenue,
9 and other state agencies as required by the particular case, for the
10 business the individual is conducting for the payment of all state
11 taxes normally paid by employers and businesses and has registered
12 for and received a unified business identifier number from the state
13 of Washington; and

14 (VI) On the effective date of the contract of service, such
15 individual is maintaining a separate set of books or records that
16 reflect all items of income and expenses of the business which the
17 individual is conducting; or

18 (~~(iii)~~) (iv) Services that require registration under chapter
19 18.27 RCW or licensing under chapter 19.28 RCW rendered by an
20 individual when:

21 (A) The individual has been and will continue to be free from
22 control or direction over the performance of the service, both under
23 the contract of service and in fact;

24 (B) The service is either outside the usual course of business
25 for which the service is performed, or the service is performed
26 outside of all the places of business of the enterprise for which the
27 service is performed, or the individual is responsible, both under
28 the contract and in fact, for the costs of the principal place of
29 business from which the service is performed;

30 (C) The individual is customarily engaged in an independently
31 established trade, occupation, profession, or business, of the same
32 nature as that involved in the contract of service, or the individual
33 has a principal place of business for the business the individual is
34 conducting that is eligible for a business deduction for federal
35 income tax purposes, other than that furnished by the employer for
36 which the business has contracted to furnish services;

37 (D) On the effective date of the contract of service, the
38 individual is responsible for filing at the next applicable filing
39 period, both under the contract of service and in fact, a schedule of

1 expenses with the internal revenue service for the type of business
2 the individual is conducting;

3 (E) On the effective date of the contract of service, or within a
4 reasonable period after the effective date of the contract, the
5 individual has an active and valid certificate of registration with
6 the department of revenue, and an active and valid account with any
7 other state agencies as required by the particular case, for the
8 business the individual is conducting for the payment of all state
9 taxes normally paid by employers and businesses and has registered
10 for and received a unified business identifier number from the state
11 of Washington;

12 (F) On the effective date of the contract of service, the
13 individual is maintaining a separate set of books or records that
14 reflect all items of income and expenses of the business that the
15 individual is conducting; and

16 (G) On the effective date of the contract of service, the
17 individual has a valid contractor registration pursuant to chapter
18 18.27 RCW or an electrical contractor license pursuant to chapter
19 19.28 RCW.

20 ~~((+8))~~ (9) "Employment benefits" means all benefits provided or
21 made available to employees by an employer, including group life
22 insurance, health insurance, disability insurance, sick leave, annual
23 leave, educational benefits, and pensions.

24 ~~((+9))~~ (10) "Family leave" means any leave taken by an employee
25 from work:

26 (a) To participate in providing care, including physical or
27 psychological care, for a family member of the employee made
28 necessary by a serious health condition of the family member;

29 (b) To bond with the employee's child during the first twelve
30 months after the child's birth, or the first twelve months after the
31 placement of a child under the age of eighteen with the employee; or

32 (c) Because of any qualifying exigency as permitted under the
33 federal family and medical leave act, 29 U.S.C. Sec. 2612(a)(1)(E)
34 and 29 C.F.R. Sec. 825.126(b)(1) through (9), as they existed on
35 October 19, 2017, for family members as defined in subsection (10) of
36 this section.

37 ~~((+10))~~ (11) "Family member" means a child, grandchild,
38 grandparent, parent, sibling, or spouse of an employee.

39 ~~((+11))~~ (12) "Grandchild" means a child of the employee's child.

1 (~~(12)~~) (13) "Grandparent" means a parent of the employee's
2 parent.

3 (~~(13)~~) (14) "Health care provider" means: (a) A person licensed
4 as a physician under chapter 18.71 RCW or an osteopathic physician
5 and surgeon under chapter 18.57 RCW; (b) a person licensed as an
6 advanced registered nurse practitioner under chapter 18.79 RCW; or
7 (c) any other person determined by the commissioner to be capable of
8 providing health care services.

9 (~~(14)~~) (15) "Medical leave" means any leave taken by an
10 employee from work made necessary by the employee's own serious
11 health condition.

12 (~~(15)~~) (16) "Paid time off" includes vacation leave, personal
13 leave, medical leave, sick leave, compensatory leave, or any other
14 paid leave offered by an employer under the employer's established
15 policy.

16 (17) "Parent" means the biological, adoptive, de facto, or foster
17 parent, stepparent, or legal guardian of an employee or the
18 employee's spouse, or an individual who stood in loco parentis to an
19 employee when the employee was a child.

20 (~~(16)~~) (18) "Period of incapacity" means an inability to work,
21 attend school, or perform other regular daily activities because of a
22 serious health condition, treatment of that condition or recovery
23 from it, or subsequent treatment in connection with such inpatient
24 care.

25 (~~(17)~~) (19) "Premium" or "premiums" means the payments required
26 by RCW 50A.10.030 and paid to the department for deposit in the
27 family and medical leave insurance account under RCW 50A.05.070.

28 (~~(18)~~) (20) "Qualifying period" means the first four of the
29 last five completed calendar quarters or, if eligibility is not
30 established, the last four completed calendar quarters immediately
31 preceding the application for leave.

32 (~~(19)~~) (21) (a) "Remuneration" means all compensation paid for
33 personal services including commissions and bonuses and the cash
34 value of all compensation paid in any medium other than cash.

35 (b) Previously accrued compensation, other than severance pay or
36 payments received pursuant to plant closure agreements, when assigned
37 to a specific period of time by virtue of a collective bargaining
38 agreement, individual employment contract, customary trade practice,
39 or request of the individual compensated, is considered remuneration
40 for the period to which it is assigned. Assignment clearly occurs

1 when the compensation serves to make the individual eligible for all
2 regular fringe benefits for the period to which the compensation is
3 assigned.

4 (c) Remuneration also includes settlements or other proceeds
5 received by an individual as a result of a negotiated settlement for
6 termination of an individual written employment contract prior to its
7 expiration date. The proceeds are deemed assigned in the same
8 intervals and in the same amount for each interval as compensation
9 was allocated under the contract.

10 (d) Remuneration does not include:

11 (i) The payment of tips;

12 (ii) Supplemental benefit payments made by an employer to an
13 employee in addition to any paid family or medical leave benefits
14 received by the employee; or

15 (iii) Payments to members of the armed forces of the United
16 States, including the organized militia of the state of Washington,
17 for the performance of duty for periods not exceeding seventy-two
18 hours at a time.

19 (~~((20))~~) (22)(a) "Serious health condition" means an illness,
20 injury, impairment, or physical or mental condition that involves:

21 (i) Inpatient care in a hospital, hospice, or residential medical
22 care facility, including any period of incapacity; or

23 (ii) Continuing treatment by a health care provider. A serious
24 health condition involving continuing treatment by a health care
25 provider includes any one or more of the following:

26 (A) A period of incapacity of more than three consecutive, full
27 calendar days, and any subsequent treatment or period of incapacity
28 relating to the same condition, that also involves:

29 (I) Treatment two or more times, within thirty days of the first
30 day of incapacity, unless extenuating circumstances exist, by a
31 health care provider, by a nurse or physician's assistant under
32 direct supervision of a health care provider, or by a provider of
33 health care services, such as a physical therapist, under orders of,
34 or on referral by, a health care provider; or

35 (II) Treatment by a health care provider on at least one occasion
36 which results in a regimen of continuing treatment under the
37 supervision of the health care provider;

38 (B) Any period of incapacity due to pregnancy, or for prenatal
39 care;

1 (C) Any period of incapacity or treatment for such incapacity due
2 to a chronic serious health condition. A chronic serious health
3 condition is one which:

4 (I) Requires periodic visits, defined as at least twice a year,
5 for treatment by a health care provider, or by a nurse under direct
6 supervision of a health care provider;

7 (II) Continues over an extended period of time, including
8 recurring episodes of a single underlying condition; and

9 (III) May cause episodic rather than a continuing period of
10 incapacity, including asthma, diabetes, and epilepsy;

11 (D) A period of incapacity which is permanent or long term due to
12 a condition for which treatment may not be effective. The employee or
13 family member must be under the continuing supervision of, but need
14 not be receiving active treatment by, a health care provider,
15 including Alzheimer's, a severe stroke, or the terminal stages of a
16 disease; or

17 (E) Any period of absence to receive multiple treatments,
18 including any period of recovery from the treatments, by a health
19 care provider or by a provider of health care services under orders
20 of, or on referral by, a health care provider, either for: (I)
21 Restorative surgery after an accident or other injury; or (II) a
22 condition that would likely result in a period of incapacity of more
23 than three consecutive, full calendar days in the absence of medical
24 intervention or treatment, such as cancer, severe arthritis, or
25 kidney disease.

26 (b) The requirement in (a)(i) and (ii) of this subsection for
27 treatment by a health care provider means an in-person visit to a
28 health care provider. The first, or only, in-person treatment visit
29 must take place within seven days of the first day of incapacity.

30 (c) Whether additional treatment visits or a regimen of
31 continuing treatment is necessary within the thirty-day period shall
32 be determined by the health care provider.

33 (d) The term extenuating circumstances in (a)(ii)(A)(I) of this
34 subsection means circumstances beyond the employee's control that
35 prevent the follow-up visit from occurring as planned by the health
36 care provider. Whether a given set of circumstances are extenuating
37 depends on the facts. For example, extenuating circumstances exist if
38 a health care provider determines that a second in-person visit is
39 needed within the thirty-day period, but the health care provider
40 does not have any available appointments during that time period.

1 (e) Treatment for purposes of (a) of this subsection includes,
2 but is not limited to, examinations to determine if a serious health
3 condition exists and evaluations of the condition. Treatment does not
4 include routine physical examinations, eye examinations, or dental
5 examinations. Under (a)(ii)(A)(II) of this subsection, a regimen of
6 continuing treatment includes, but is not limited to, a course of
7 prescription medication, such as an antibiotic, or therapy requiring
8 special equipment to resolve or alleviate the health condition, such
9 as oxygen. A regimen of continuing treatment that includes taking
10 over-the-counter medications, such as aspirin, antihistamines, or
11 salves, or bed rest, drinking fluids, exercise, and other similar
12 activities that can be initiated without a visit to a health care
13 provider, is not, by itself, sufficient to constitute a regimen of
14 continuing treatment for purposes of this title.

15 (f) Conditions for which cosmetic treatments are administered,
16 such as most treatments for acne or plastic surgery, are not serious
17 health conditions unless inpatient hospital care is required or
18 unless complications develop. Ordinarily, unless complications arise,
19 the common cold, the flu, ear aches, upset stomach, minor ulcers,
20 headaches other than migraines, routine dental or orthodontia
21 problems, and periodontal disease are examples of conditions that are
22 not serious health conditions and do not qualify for leave under this
23 title. Restorative dental or plastic surgery after an injury or
24 removal of cancerous growths are serious health conditions provided
25 all the other conditions of this section are met. Mental illness
26 resulting from stress or allergies may be serious health conditions,
27 but only if all the conditions of this section are met.

28 (g)(i) Substance abuse may be a serious health condition if the
29 conditions of this section are met. However, leave may only be taken
30 for treatment for substance abuse by a health care provider or by a
31 licensed substance abuse treatment provider. Absence because of the
32 employee's use of the substance, rather than for treatment, does not
33 qualify for leave under this title.

34 (ii) Treatment for substance abuse does not prevent an employer
35 from taking employment action against an employee. The employer may
36 not take action against the employee because the employee has
37 exercised his or her right to take medical leave for treatment.
38 However, if the employer has an established policy, applied in a
39 nondiscriminatory manner that has been communicated to all employees,
40 that provides under certain circumstances an employee may be

1 terminated for substance abuse, pursuant to that policy the employee
2 may be terminated whether or not the employee is presently taking
3 medical leave. An employee may also take family leave to care for a
4 covered family member who is receiving treatment for substance abuse.
5 The employer may not take action against an employee who is providing
6 care for a covered family member receiving treatment for substance
7 abuse.

8 (h) Absences attributable to incapacity under (a)(ii)(B) or (C)
9 of this subsection qualify for leave under this title even though the
10 employee or the family member does not receive treatment from a
11 health care provider during the absence, and even if the absence does
12 not last more than three consecutive, full calendar days. For
13 example, an employee with asthma may be unable to report for work due
14 to the onset of an asthma attack or because the employee's health
15 care provider has advised the employee to stay home when the pollen
16 count exceeds a certain level. An employee who is pregnant may be
17 unable to report to work because of severe morning sickness.

18 ~~((21))~~ (23) "Service is localized in this state" has the same
19 meaning as described in RCW 50.04.120.

20 ~~((22))~~ (24) "Spouse" means a husband or wife, as the case may
21 be, or state registered domestic partner.

22 ~~((23))~~ (25) "State average weekly wage" means the most recent
23 average weekly wage calculated under RCW 50.04.355 and available on
24 January 1st of each year.

25 ~~((24))~~ (26) "Supplemental benefit payments" means payments made
26 by an employer to an employee as salary continuation or as paid time
27 off. Such payments must be in addition to any paid family or medical
28 leave benefits the employee is receiving.

29 (27) "Typical workweek hours" means:

30 (a) For an hourly employee, the average number of hours worked
31 per week by an employee ~~((since the beginning of))~~ within the
32 qualifying period; and

33 (b) Forty hours for a salaried employee, regardless of the number
34 of hours the salaried employee typically works.

35 ~~((25))~~ (28) "Wage" or "wages" means:

36 (a) For the purpose of premium assessment, the remuneration paid
37 by an employer to an employee. The maximum wages subject to a premium
38 assessment are those wages as set by the commissioner under RCW
39 50A.10.030;

1 (b) For the purpose of payment of benefits, the remuneration paid
2 by one or more employers to an employee for employment during the
3 employee's qualifying period. At the request of an employee, wages
4 may be calculated on the basis of remuneration payable. The
5 department shall notify each employee that wages are calculated on
6 the basis of remuneration paid, but at the employee's request a
7 redetermination may be performed and based on remuneration payable;
8 and

9 (c) For the purpose of a self-employed person electing coverage
10 under RCW 50A.10.010, the meaning is defined by rule.

11 **Sec. 2.** RCW 50A.10.010 and 2019 c 13 s 19 are each amended to
12 read as follows:

13 (1) For benefits payable beginning January 1, 2020, any self-
14 employed person, including a sole proprietor, independent contractor,
15 partner, or joint venturer, may elect coverage under this title for
16 an initial period of not less than three years and subsequent periods
17 of not less than one year immediately following a period of coverage.
18 Those electing coverage under this section must elect coverage for
19 both family leave and medical leave and are responsible for payment
20 of one hundred percent of all premiums assessed to an employee under
21 RCW 50A.10.030. The self-employed person must file a notice of
22 election in writing with the department, in a manner as required by
23 the department in rule. The self-employed person is eligible for
24 family and medical leave benefits after working eight hundred twenty
25 hours in the state during the qualifying period following the date of
26 filing the notice.

27 (2) A self-employed person who has elected coverage may withdraw
28 from coverage within thirty days after the end of each period of
29 coverage, or at such other times as the commissioner may adopt by
30 rule, by filing a notice of withdrawal in writing with the
31 commissioner, such withdrawal to take effect not sooner than thirty
32 days after filing the notice with the commissioner.

33 (3) The department may cancel elective coverage if the self-
34 employed person fails to make required payments or file reports. The
35 department may collect due and unpaid premiums and may levy an
36 additional premium for the remainder of the period of coverage. The
37 cancellation shall be effective no later than thirty days from the
38 date of the notice in writing advising the self-employed person of
39 the cancellation.

1 (4) Those electing coverage are considered employers or employees
2 where the context so dictates.

3 (5) For the purposes of this section, "independent contractor"
4 means an individual excluded from employment under RCW
5 50A.05.010(~~((7))~~) (8)(b) (~~((ii) and)~~) (iii) and (iv).

6 (6) In developing and implementing the requirements of this
7 section, the department shall adopt government efficiencies to
8 improve administration and reduce costs. These efficiencies may
9 include, but are not limited to, requiring that payments be made in a
10 manner and at intervals unique to the elective coverage program.

11 (7) The department shall adopt rules for determining the hours
12 worked and the wages of individuals who elect coverage under this
13 section and rules for enforcement of this section.

14 **Sec. 3.** RCW 50A.10.040 and 2019 c 13 s 22 are each amended to
15 read as follows:

16 (1) An employer may file an application with the department for a
17 conditional waiver for the payment of family and medical leave
18 premiums, assessed under RCW 50A.10.030, for any employee who (~~(is)~~):

19 (a) (~~(Physically based)~~) Primarily performs work outside of the
20 state;

21 (b) Is employed in the state on a limited or temporary work
22 schedule; and

23 (c) Is not expected to be employed in the state for eight hundred
24 twenty hours or more in a (~~(qualifying)~~) period of four consecutive
25 completed calendar quarters.

26 (2) (~~(The department must approve an application that has been~~
27 ~~signed by)~~) Both the employee and employer must sign the application
28 verifying their belief that the conditions in (~~(this)~~) subsection (1)
29 of this section will be met (~~(during the qualifying period)~~).

30 (3) If the (~~(employee exceeds the eight hundred twenty hours or~~
31 ~~more in a period of four consecutive complete calendar quarters)~~)
32 department finds any of the conditions in subsection (1) of this
33 section are no longer satisfied, or were not satisfied at any point
34 after a conditional waiver was approved and is in effect, the
35 department will consider the conditional waiver (~~(expires)~~) expired
36 and the employer and employee will be responsible for their shares of
37 all premiums that would have been paid during this period had the
38 waiver not been granted. Upon payment of the missed premiums, the
39 employee will be credited for the hours worked and will be eligible

1 for benefits under this title as if the premiums were originally
2 paid.

3 **Sec. 4.** RCW 50A.15.020 and 2019 c 13 s 3 are each amended to
4 read as follows:

5 (1) ~~((a))~~ Beginning January 1, 2020, family and medical leave
6 are available and benefits are payable to a qualified employee under
7 this section.

8 (a) Following a waiting period consisting of the first seven
9 consecutive calendar days, benefits are payable when family or
10 medical leave is required. However, no waiting period is required for
11 leave for the birth or placement of a child. The waiting period
12 begins the previous Sunday of the week when an otherwise eligible
13 employee takes leave for the minimum claim duration under subsection
14 (2)(c) of this section. Eligible employees may satisfy the waiting
15 period requirement while simultaneously receiving paid time off for
16 any part of the waiting period.

17 (b) Benefits may continue during the continuance of the need for
18 family ~~((and))~~ or medical leave, subject to the maximum and minimum
19 weekly benefits, duration, and other conditions and limitations
20 established in this title. ~~((Successive periods of family and medical~~
21 ~~leave caused by the same or related injury or sickness are deemed a~~
22 ~~single period of family and medical leave only if separated by less~~
23 ~~than four months.))~~

24 (2) The weekly benefit shall be prorated by the percentage of
25 hours on leave compared to the number of hours provided as the
26 typical workweek hours as defined in RCW 50A.05.010.

27 (a) The benefits in this section, if not a multiple of one
28 dollar, shall be reduced to the next lower multiple of one dollar.

29 (b) Hours on leave claimed for benefits under this title, if not
30 a multiple of one hour, shall be reduced to the next lower multiple
31 of one hour.

32 (c) The minimum claim duration payment is for eight consecutive
33 hours of leave.

34 (3)(a) The maximum duration of paid family leave may not exceed
35 twelve times the typical workweek hours during a period of fifty-two
36 consecutive calendar weeks.

37 (b) The maximum duration of paid medical leave may not exceed

22 plus reasonable attorneys' fees for the collection action, reasonable
23 expert witness fees, and other reasonable costs of the action.

24 (b) For purposes of this section, thirty calendar days begins the
25 day the determination is issued.

26 (2) The department is not responsible for collection action
27 against an employer that has defaulted the payment of an award
28 established under RCW 50A.40.030.

29 NEW SECTION. **Sec. 17.** A new section is added to chapter 50A.40
30 RCW to read as follows:

31 (1) A private action to recover damages under RCW 50A.40.030 may
32 be brought against any employer by any one or more employees for and
33 on behalf of:

34 (a) The employee or employees; or

35 (b) The employees and other employees similarly situated.

36 (2) Any action under subsection (1) of this section must be filed
37 with a court of competent jurisdiction within the state. Any private

1 action for an alleged violation of RCW 50A.40.010 must be commenced
2 within three years of the date of the alleged violation.

3 (3) In an action under subsection (1) of this section the court
4 shall, in addition to any judgment awarded to a prevailing plaintiff,
5 award reasonable attorneys' fees, reasonable expert witness fees, and
6 other costs of the action to be paid by the defendant.

7 (4) A private right of action is only available to an employee
8 who either has not filed a complaint with the department, has
9 withdrawn a filed complaint under subsection (5) of this section, or
10 has resolved a complaint under subsection (6) of this section.

11 (5) An employee who has filed a complaint with the department
12 under RCW 50A.40.020 may elect to withdraw the complaint by providing
13 written notice to the department within ten business days after
14 filing the complaint with the department. Withdrawing a complaint
15 terminates the department's administrative action.

16 (6) A complaint may be resolved upon agreement by all parties.
17 Resolution of a complaint must be communicated to the department
18 prior to the department's issuance of a determination. Resolution of
19 a complaint terminates the department's administrative action.

20 (7) In the event the department's administrative action is
21 terminated under subsection (5) or (6) of this section:

22 (a) The department will immediately discontinue its investigation
23 and any action against the employer; and

24 (b) The determination, if already issued, along with any related
25 findings of fact and conclusions of law, and any payments or offers
26 of payment made by the employer including interest, are not
27 admissible in any court action or other judicial or administrative
28 proceeding.

29 (8) Nothing in this section shall be construed to limit or
30 affect:

31 (a) Except as provided in subsection (4) of this section, the
32 right of any employee to pursue any judicial, administrative, or
33 other action available with respect to an employer;

34 (b) The right of the department to pursue any judicial,
35 administrative, or other action available with respect to an employee
36 that is identified as a result of a complaint under RCW 50A.40.020;
37 or

38 (c) The right of the department to pursue any judicial,
39 administrative, or other action available with respect to an employer
40 in the absence of a complaint.

1 NEW SECTION. **Sec. 18.** A new section is added to chapter 50A.05
2 RCW to read as follows:

3 (1) In the discharge of the duties imposed by this title, the
4 appeal tribunal and any duly authorized representative of the
5 commissioner shall have power to administer oaths and affirmations,
6 take depositions, certify to official acts, and issue subpoenas to
7 compel the attendance of witnesses and the production of books,
8 papers, correspondence, memoranda, and other records deemed necessary
9 as evidence in connection with any dispute or the administration of
10 this title. It shall be unlawful for any person, without just cause,
11 to fail to comply with subpoenas issued pursuant to the provisions of
12 this section.

13 (2)(a) Any authorized representative of the commissioner may
14 apply for and obtain a superior court order approving and authorizing
15 a subpoena in advance of its issuance. The application may be made in
16 the county where the subpoenaed person resides or is found, or the
17 county where the subpoenaed records or documents are located, or in
18 Thurston county. The application must:

19 (i) State that an order is sought pursuant to this subsection;
20 (ii) Adequately specify the records, documents, or testimony; and
21 (iii) Declare under oath that an investigation is being conducted
22 for a lawfully authorized purpose related to an investigation within
23 the department's authority and that the subpoenaed documents or
24 testimony are reasonably related to an investigation within the
25 department's authority.

26 (b) Where the application under this subsection is made to the
27 satisfaction of the court, the court must issue an order approving
28 the subpoena. An order under this subsection constitutes authority of
29 law for the department to subpoena the records or testimony.

30 (c) Any authorized representative of the commissioner may seek
31 approval and a court may issue an order under this subsection without
32 prior notice to any person, including the person to whom the subpoena
33 is directed and the person who is the subject of an investigation.

34 (3) Subsection (2) of this section is intended to comply with the
35 holdings of *State v. Miles*, 160 Wn.2d 236 (2007) and *State v. Reeder*,
36 184 Wn.2d 805 (2015), and Article I, section 7 of the state
37 Constitution. These provisions collectively require judicial review
38 of investigative subpoenas under certain circumstances. The

1 department is not required to receive court approval under subsection
2 (2) of this section unless otherwise required by law.
