- 1 AN ACT Relating to food benefits trafficking; amending RCW
- 2 9.91.140; reenacting and amending RCW 9.94A.515; repealing RCW
- 3 9.91.142 and 9.91.144; and prescribing penalties.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 **Sec. 1.** RCW 9.91.140 and 2003 c 53 s 49 are each amended to read 6 as follows:
- 7 ((A person who sells food stamps obtained through the program
 8 established under RCW 74.04.500 or food stamp benefits transferred
 9 electronically, or food purchased therewith, is guilty of the
 10 following:
- 11 (1) A gross misdemeanor if the value of the stamps, benefits, or
 12 food transferred exceeds one hundred dollars; or
- (2) A misdemeanor if the value of the stamps, benefits, or food transferred is one hundred dollars or less.)) (1) A person who sells food benefits, or items purchased using food benefits, is quilty of:
- 16 <u>(a) A gross misdemeanor if the value of the food benefits or</u>
 17 items sold exceeds one hundred dollars; or
- 18 <u>(b) A misdemeanor if the value of the food benefits or items sold</u> 19 is one hundred dollars or less.
