## SUBSTITUTE HOUSE BILL 2786

1 AN ACT Relating to establishing the opioid epidemic response 2 advisory council; and adding a new section to chapter 43.10 RCW.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 <u>NEW SECTION.</u> Sec. 1. A new section is added to chapter 43.10 5 RCW to read as follows:

6 (1) The attorney general shall convene an advisory council to 7 advise the legislature on how to use penalties received by the state 8 as a result of litigation in which the state is a party against an 9 opioid manufacturer or distributor relating to acts or omissions by 10 the manufacturer or distributor that contributed to increased rates 11 of opioid addiction in Washington.

12 (2) The advisory council must consist of one member appointed by13 the attorney general to represent each of the following:

14 15 (a) The pharmacy quality assurance commission;

(b) A statewide organization representing physicians;

16 (c) Substance use disorder professionals, opioid treatment 17 programs, or sober living programs;

(d) A statewide organization representing providers of addiction
 medicine. The member appointed under this subsection (2)(d) must be
 an addiction psychiatrist;

- (e) Providers of alternative pain management therapies, including
   acupuncture, chiropractic, or massage therapy;
- 3 (f) Nonprofit organizations conducting initiatives to address the 4 opioid epidemic;
- (g) A statewide organization representing ambulances. The member
  appointed under this subsection (2)(g) must be an emergency medical
  technician, advanced emergency medical technician, or a paramedic;
- 8 (h) State courts. The member appointed under this subsection 9 (2)(h) must be a judge or a law enforcement officer;
- 10
- (i) Individuals in opioid addiction recovery;
- (j) Individuals suffering from chronic pain, intractable pain, or rare diseases or conditions;
- 13 (k) Individuals with mental illness;

(m) Local health jurisdictions;

- 14 (1) A statewide organization representing hospitals;
- 15
- 16 (n) Behavioral health administrative services organizations;
- 17 (o) A statewide organization representing nurses;
- 18 (p) Children of addicted parents;
- 19 (q) Boys and girls clubs;
- 20 (r) A statewide substance abuse prevention organization; and

21 (s) Any other individuals or groups affected directly or 22 indirectly by the opioid epidemic.

(3) In addition to the members appointed under subsection (2) of this section, the attorney general shall invite two tribal members to participate as voting members.

26 (4) The department of social and health services, the department 27 of health, the health care authority, and the department of 28 corrections shall each appoint one nonvoting member to the advisory 29 council.

30 (5) The attorney general shall convene the advisory council 31 within thirty days of penalties being received by the state as a 32 result of litigation in which the state is a party against an opioid 33 manufacturer or distributor relating to acts or omissions by the 34 manufacturer or distributor that contributed to increased rates of 35 opioid addiction in Washington.

36 (6) The advisory council shall submit to the fiscal committees of 37 the legislature recommendations on how the penalties received can 38 best be utilized to prevent opioid addiction and treat victims of 39 opioid addiction. When making its recommendations, the advisory 40 council shall consider compensation for the most affected victims of 1 the opioid epidemic, especially families that have specifically lost

2 a loved one to an opiate overdose or whose lives have been devastated 3 by the effects of opioids.
