WHEREAS, Greg Stewart of Selah, Washington is retiring after an 1 2 illustrious and unparalleled 48-year career dedicated to the state of Washington and its fair industry; and 3 4 WHEREAS, Greg is an alumnus of Centralia College and Washington 5 State University, where he graduated with a degree in agricultural economics; and 6 7 WHEREAS, Greg served in the United States Army from 1966 to 1969, 8 including serving a tour of duty in Vietnam; and 9 WHEREAS, Greq Stewart and his wife Karen have been married since November 4, 1967, and raised two lovely daughters, Tami 10 and 11 Stephanie; and 12 WHEREAS, Greg was hired in 1972 by the Central Washington Fair 13 Association to be the Assistant General Manager; and WHEREAS, In 1973, Greg was appointed General Manager of what was 14 15 then a five-day fair, overseeing a full-time staff of three people; 16 and 17 WHEREAS, The Central Washington State Fair, home of the original 18 Washington State Fair and the 120-acre fairgrounds, now known as 19 State Fair Park, have grown considerably under Greg's leadership; and 20 WHEREAS, The Central Washington State Fair has grown to a 10-day 21 fair with the addition of the Yakima Valley SunDome, State Fair Park 22 Raceway, Yakima County Stadium, and a full-time staff of 25, and 181 23 event days; and

WHEREAS, Greg is a 21-year member of the Yakima Rotary Club,
the Greater Yakima Chamber of Commerce, Yakima Valley Tourism,
and the Central Washington Hispanic Chamber; and

4 WHEREAS, In December 2017, Mr. Stewart received an award 5 from the Yakima Latino Professional Association for his 6 excellent leadership, vision, and community support; and

7 WHEREAS, Greq was Director and Vice President of Western 8 Fairs Association from 1979-1981, on the International 9 Association of Fairs and Expositions (IAFE) Board from 10 1997-2003, Executive Treasurer 1997-2000, and Chair in 2002; and 11 WHEREAS, Greq was the first recipient out of the State of 12 California to be on the Western Fairs Association Board and to

13 receive the Hall of Fame award in 1995, received the Diploma of 14 Fair Management in 1977 from Western Fairs Association, and was 15 on the Western Fairs Association's Board from 1979-1981; and

16 WHEREAS, In 1984, Greg received the designation of Certified 17 Fair Executive from the International Association of Fairs and 18 Expositions; and

19 WHEREAS, In 2010, Mr. Stewart received the International 20 Association of Fairs and Expositions Hall of Fame award, the 21 highest honor recognized by the fair industry; and

22 WHEREAS, Mr. Stewart was the Director of the Mid-West Fairs 23 Association, where members are selected by invitation only; and

24 WHEREAS, In 2006, Mr. Stewart served as President of the 25 Mid-West Fairs Association, served on the Washington State Fair 26 Association's Board from 1972-1978, and was President of the 27 Board from 1976-1977; and

28 WHEREAS, Additionally, he has memberships with the Northwest 29 Showman's League, International Association of Auditorium 30 Managers, is a gold card member with the Professional Rodeo 31 Cowboy Association, and a board member of the Outdoor Amusement 32 Business Association; and

33 WHEREAS, In October of 2018, Greg received the Lifetime 34 Achievement Award from the Washington State Fairs Association; 35 and

36 WHEREAS, Enjoying his retirement, he hopes to expand on his 37 love of traveling, boating, horses, and fishing; 1 NOW, THEREFORE, BE IT RESOLVED, That the Washington State 2 Senate thank and commend Mr. Greg Stewart for his many years of 3 outstanding public service and dedication to the thousands of 4 people he touched in his career and wish him all the best in 5 retirement; and
