1       AN ACT Relating to the licensure and certification of massage  
2 therapists and reflexologists; and amending RCW 18.108.045.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4       **Sec. 1.** RCW 18.108.045 and 2016 c 41 s 5 are each amended to  
5 read as follows:

6       (1) A massage therapist licensed under this chapter or a  
7 reflexologist certified under this chapter must conspicuously display  
8 his or her credential in his or her principal place of business. If  
9 the licensed massage therapist or certified reflexologist does not  
10 have a principal place of business or conducts business in any other  
11 location, he or she must have a copy of his or her credential  
12 available for inspection while performing services within his or her  
13 authorized scope of practice.

14       (2) A massage therapist licensed under this chapter or a  
15 reflexologist certified under this chapter must have government-  
16 issued photo identification on his or her person or have it be  
17 available for inspection by city, county, or state law enforcement or  
18 department personnel at all times he or she practices massage therapy  
19 or reflexology. The name of the massage therapist or reflexologist on  
20 the government-issued photo identification must match the name on the  
21 massage therapy license or reflexology certification.
