EFFECT: (1) Requires a PUD to establish a separate utility system or function for the purpose of providing telecommunications or broadband. (2) Requires that all equipment and infrastructure not related to the transmission of electricity, as indicated by common industry practice, must be attributed to the cost of providing telecommunications or broadband internet access services, or both, including but not limited to the cost of fiber-to-the-home, and all common facilities must be allocated based on the number of locations served with no less than 50 percent of such common facilities allocated to telecommunications or broadband

internet access.
