3 (a) "Administrative segregation" means the imposition of solitary 4 confinement as a non-punitive measure for incarcerated persons who are 5 prone to escape, assault correctional facility staff or other 6 incarcerated persons, are a threat to themselves, or are in need of 7 medical isolation or infirmary status;

8 (b) "Disciplinary segregation" means the imposition of solitary 9 confinement as the result of a disciplinary hearing in which the 10 incarcerated person has been found to be in violation of a facility 11 rule or state or federal law and this status results in separating the 12 incarcerated person from the rest of the corrections facility 13 population to serve the consequence imposed;

14 (c) "Protective custody" means the imposition of solitary 15 confinement as a non-punitive measure, either requested or required, 16 to ensure an incarcerated person's safety; and

17 "Solitary confinement" confinement (d) means the of an 18 incarcerated person in a corrections facility housed alone in a cell 19 or similarly confined holding facility or living space pursuant to 20 disciplinary segregation, administrative segregation, or protective 21 custody. Solitary confinement does not include confinement due to a 22 facility-wide or unit-wide lockdown that is required to ensure the 23 safety of incarcerated persons or staff or confinement due to 24 quarantine or isolation measures undertaken in response to a public 25 health crisis or declared state of emergency"

EFFECT: Makes the following changes to the provisions requiring jails to collect and report specified data about the use of solitary confinement:

- redefines solitary confinement to mean circumstances in which a person is housed alone pursuant to disciplinary segregation, administrative segregation, or protective custody, and excludes confinement due to quarantine or isolation in response to a public health crisis or state of emergency;
- requires jails to collect data regarding whether the imposition of solitary confinement was the result of disciplinary segregation, administrative segregation, or protective custody,

and for disciplinary segregation, whether a due process hearing was conducted and the results of the hearing;

- modifies the requirement to collect data relating to access to education, programming, and ordinary necessities while in solitary confinement to refer to meaningful access, rather than full access; and
- Specifies that the obligation to collect data begins on July 1, 2022.
