GENERAL PROVISIONS

5 <u>NEW SECTION.</u> Sec. 101. SHORT TITLE. This chapter may be cited 6 as the revised uniform unclaimed property act.

7 <u>NEW SECTION.</u> Sec. 102. DEFINITIONS. The definitions in this 8 section apply throughout this chapter unless the context clearly 9 requires otherwise.

10 (1) "Administrator" means the department of revenue established 11 under RCW 82.01.050.

8 (13) "Insurance company" means an association, corporation, or 9 fraternal or mutual benefit organization, whether or not for profit, 10 engaged in the business of providing life endowments, annuities, or 11 insurance, including accident, burial, casualty, credit life, 12 contract performance, dental, disability, fidelity, fire, health, 13 hospitalization, illness, life, malpractice, marine, mortgage, 14 surety, wage protection, and worker compensation insurance.

(14) "Loyalty card" means a record given without direct monetary consideration under an award, reward, benefit, loyalty, incentive, rebate, or promotional program which may be used or redeemed only to obtain goods or services or a discount on goods or services. The term does not include a record that may be redeemed for money or otherwise monetized by the issuer.

(15) "Mineral" means gas, oil, coal, oil shale, other gaseous liquid or solid hydrocarbon, cement material, sand and gravel, road material, building stone, chemical raw material, gemstone, fissionable and nonfissionable ores, colloidal and other clay, steam and other geothermal resources, and any other substance defined as a mineral by law of this state other than this chapter.

(16) "Mineral proceeds" means an amount payable for extraction, production, or sale of minerals, or, on the abandonment of the amount, an amount that becomes payable after abandonment. The term includes an amount payable:

31 (a) For the acquisition and retention of a mineral lease, 32 including a bonus, royalty, compensatory royalty, shut-in royalty, 33 minimum royalty, and delay rental;

34 (b) For the extraction, production, or sale of minerals, 35 including a net revenue interest, royalty, overriding royalty, 36 extraction payment, and production payment; and

37 (c) Under an agreement or option, including a joint operating38 agreement, unit agreement, pooling agreement, and farm-out agreement.

(a) With respect to an amount owed on a life or endowmentinsurance policy, three years after the earlier of the date:

TAKING CUSTODY OF PROPERTY BY ADMINISTRATOR

30 (2) If property in a report under section 401 of this act is an 31 automatically renewable deposit and a penalty or forfeiture in the 32 payment of interest would result from paying the deposit to the 33 administrator at the time of the report, the date for payment of the 34 property to the administrator is extended until a penalty or 35 forfeiture no longer would result from payment, if the holder informs 36 the administrator of the extended date.

37 (3) Tangible property in a safe deposit box may not be delivered
38 to the administrator until 180 days after filing the report under
39 section 401 of this act.

1 (4) If property reported to the administrator under section 401 2 of this act is a security, the administrator may:

3 (a) Make an endorsement, instruction, or entitlement order on 4 behalf of the apparent owner to invoke the duty of the issuer, its 5 transfer agent, or the securities intermediary to transfer the 6 security; or

7

(b) Dispose of the security under section 702 of this act.

8 (5) If the holder of that property reported to the administrator 9 under section 401 of this act is the issuer of a certificated 10 security, the administrator may obtain a replacement certificate in 11 physical or book-entry form under RCW 62A.8-405. An indemnity bond is 12 not required.

13 (6) The administrator shall establish procedures for the 14 registration, issuance, method of delivery, transfer, and maintenance 15 of securities delivered to the administrator by a holder.

16 (7) An issuer, holder, and transfer agent or other person acting 17 under this section under instructions of and on behalf of the issuer 18 or holder is not liable to the apparent owner for, and must be 19 indemnified by the state against, a claim arising with respect to 20 property after the property has been delivered to the administrator.

<u>EFFECT:</u> (1) Provides an option for determining the presumption of abandonment for a demand, savings, or time deposit, of either: From the later of maturity, if applicable, of the deposit; or the owner's last indication of interest in the deposit.

(2) Changes the age of the apparent owner from 70.5 years to 72 years to align with the age for mandatory withdrawals when calculating the presumption of abandonment for tax deferred retirement accounts.

(3) Removes the \$250 limit on the Department of Revenue's (DOR) authority to return unclaimed property in the absence of a claim when the DOR reasonably believes the apparent owner, as identified in a holder report filed with the DOR, is entitled to receive the property.

(4) Modifies the provisions for a timely petition for administrative review.
