4 (1) To assist the task force established in RCW 74.08A.505,
5 there is created the intergenerational poverty advisory committee.

6 (2) The advisory committee must include diverse, statewide 7 representation from public, nonprofit, and for-profit entities. The 8 committee membership must reflect regional, racial, and cultural 9 diversity to adequately represent the needs of all children and 10 families in the state.

11 (3) Members of the advisory committee are appointed by the 12 secretary, with the approval of the task force.

13 (4) The advisory committee must include representatives from:

14 (a) Advocacy groups that focus on childhood poverty issues;

(b) Advocacy groups that focus on education and early childhood education issues;

17 (c) Academic experts in childhood poverty, education, or early 18 childhood education issues;

19 (d) Faith-based organizations that address childhood poverty, 20 education, or early childhood education issues;

- 21 (e) Tribal governments;
- 22 (f) Families impacted by poverty;

23 (g) Local government representatives that address childhood 24 poverty or education issues;

25 (h) The business community;

26 (i) <u>A group representing accredited financial counselors;</u>

27 (j) A subject matter expert in infant mental health;

1 (((<del>j)</del>)) (k) The department of children, youth, and families; and 2 ((<del>(k)</del>)) (1) The department.

3 (5) Each member of the advisory committee is appointed for a 4 four-year term unless a member is appointed to complete an unexpired 5 term. The secretary may adjust the length of term at the time of 6 appointment or reappointment so that approximately one-half of the 7 advisory committee is appointed every two years.

8 (6) The secretary may remove an advisory committee member:

9 (a) If the member is unable or unwilling to carry out the 10 member's assigned responsibilities; or

11 (b) For good cause.

12 (7) If a vacancy occurs in the advisory committee membership for13 any reason, a replacement may be appointed for the unexpired term.

14 (8) The advisory committee shall choose cochairs from among its 15 membership. The secretary shall convene the initial meeting of the 16 advisory committee.

(9) A majority of the advisory committee constitutes a quorum of the advisory committee at any meeting and the action of the majority of members present is the action of the advisory committee.

20 (10) The advisory committee shall:

(a) Meet quarterly at the request of the task force cochairs or22 the cochairs of the advisory committee;

(b) Make recommendations to the task force on how the task force and the state can effectively address the needs of children affected by intergenerational poverty and achieve the purposes and duties of the task force as described in RCW 74.08A.505;

(c) Ensure that the advisory committee's recommendations to the28 task force are supported by verifiable data; and

(d) Gather input from diverse communities about the impact of intergenerational poverty on outcomes such as education, health al care, employment, involvement in the child welfare system, and other related areas.

33 (11) The department shall provide staff support to the advisory 34 committee and shall endeavor to accommodate the participation needs 1 of its members. Accommodations may include considering the location 2 and time of committee meetings, making options available for remote 3 participation by members, and convening meetings of the committee in 4 locations with proximity to available child care whenever feasible. 5 (12) Members of the advisory committee may receive reimbursement 6 for travel expenses in accordance with RCW 43.03.050 and 43.03.060." 7
