 - EFFECT: (1) Removes the provision authorizing a public utility district (PUD) to provide either retail or wholesale, or both telecommunications services and telecommunications facilities within the district.
 - (2) Specifies when a PUD is authorized to maintain telecommunications facilities within or without the district's limits for the provision of wholesale telecommunications services.
 - (3) Authorizes a PUD to provide retail telecommunications services or telecommunications facilities within the district's limits or without the district's limits by contract with another public utility district, any political subdivision of the state authorized to provide retail telecommunications services in the state, or with any federally recognized tribe located in the state of Washington.
 - (4) Specifies that a port district may provide retail telecommunications services within or outside of the district limits.
 - (5) Makes technical corrections.
