1 On page 1, after line 4, insert the following:

2 "NEW SECTION. **Sec. 1.** (1) The legislature declares its specific
3 intent to dedicate any savings generated by this act to a special
4 account to be used for purposes specified in section 3 of this act.

5 (2) This section expires June 30, 2023."

6 Renumber the remaining sections consecutively and correct any
7 internal references accordingly.

8 On page 5, after line 18, insert the following:

9 "NEW SECTION. **Sec. 3.** A new section is added to chapter 72.09
10 RCW to read as follows:

11 (1) The corrections and public safety account is created in the
12 custody of the state treasurer to be used only for the purposes of
13 this section.

14 (2) Expenditures from the account may be used only for:

15 (a) Replacing the offender management network information system
16 maintained by the department with a more efficient and
17 technologically advanced system; and

18 (b) Implementing a comprehensive electronic health records system
19 at the department.

20 (3) It is the express intent of the legislature that moneys in
21 the corrections and public safety account may not be transferred to
22 any other account or spent for any purposes other than provided under
23 this section.

24 (4) Revenues to the corrections and public safety account consist
25 of:

26 (a) Funds transferred to the account pursuant to this act; and

27 (b) Any other revenues appropriated to or deposited into the
28 account.

29 (5) (a) For the 2021-2023 fiscal biennium, the state treasurer
30 shall transfer any savings generated by this act during the 2021-2023

1 fiscal biennium from the general fund to the corrections and public
2 safety account.

3 (b) Moneys transferred to the corrections and public safety
4 account in (a) of this subsection may only be used by the department
5 for the purposes of subsection (2) of this section.

6 (c) Moneys in the account as referenced in (a) of this subsection
7 may be spent only after appropriation.

8 (6) Moneys appropriated to the corrections and public safety
9 account may not be used to supplant existing funding or levels of
10 service.

11 (7) If the account balance in the corrections and public safety
12 account exceeds \$25,000,000 at any time, the amount in excess of
13 \$25,000,000 shall be transferred to the state general fund.

14 (8) During the 2021-2023 fiscal biennium, any residue in the
15 account shall be accumulated and shall not revert to the state
16 general fund until the end of the biennium.

17 (9) This section expires June 30, 2023."

20 On page 1, line 2 of the title, after "9.94A.728;" strike the
21 remainder of the title and insert "adding a new section to chapter
22 72.09 RCW; creating new sections; and providing expiration dates."

EFFECT: Establishes the corrections and public safety account in the custody of the state treasurer; specifies that funds in the account may only be used to replace the Offender Management Network Information System and implement a comprehensive electronic health records system; requires the state treasurer to transfer any savings generated by this act during the 2021-2023 fiscal biennium from the general fund to the corrections and public safety account for the 2021-2023 fiscal biennium; requires any excess balance over \$25,000,000 to be transferred to the state general fund; and sunsets the account at the end of the 2021-2023 biennium.
