1 On page 1, after line 4, insert the following:

2 "NEW SECTION. **Sec. 1.** (1) The legislature declares its specific  
3 intent to dedicate any savings generated by this act to a special  
4 account to be used for purposes specified in section 3 of this act.

5 (2) This section expires June 30, 2023."

6 Renumber the remaining sections consecutively and correct any  
7 internal references accordingly.

8 On page 5, after line 18, insert the following:

9 "NEW SECTION. **Sec. 3.** A new section is added to chapter 72.09  
10 RCW to read as follows:

11 (1) The corrections and public safety account is created in the  
12 custody of the state treasurer to be used only for the purposes of  
13 this section.

14 (2) Expenditures from the account may be used only for:

15 (a) Funding victims' services in local jurisdictions and superior  
16 courts; or

17 (b) Supplementing the crime victim's compensation account under  
18 RCW 7.68.045.

19 (3) It is the express intent of the legislature that moneys in  
20 the corrections and public safety account may not be transferred to  
21 any other account or spent for any purposes other than provided under  
22 this section.

23 (4) Revenues to the corrections and public safety account consist  
24 of:

25 (a) Funds transferred to the account pursuant to this act; and

26 (b) Any other revenues appropriated to or deposited into the  
27 account.

28 (5)(a) For the 2021-2023 fiscal biennium, the state treasurer  
29 shall transfer any savings generated by this act during the 2021-2023  
30 fiscal biennium from the general fund to the corrections and public  
31 safety account.

1 (b) Moneys transferred to the corrections and public safety  
2 account in (a) of this subsection may only be used by the department  
3 for the purposes of subsection (2) of this section.

4 (c) Moneys in the account as referenced in (a) of this subsection  
5 may be spent only after appropriation.

6 (6) Moneys appropriated to the corrections and public safety  
7 account may not be used to supplant existing funding or levels of  
8 service.

9 (7) If the account balance in the corrections and public safety  
10 account exceeds \$10,000,000 at any time, the amount in excess of  
11 \$10,000,000 shall be transferred to the state general fund.

12 (8) During the 2021-2023 fiscal biennium, any residue in the  
13 account shall be accumulated and shall not revert to the state  
14 general fund until the end of the biennium.

15 (9) This section expires June 30, 2023."

16 Renumber the remaining section consecutively and correct any  
17 internal references accordingly.

18 On page 1, beginning on line 2 of the title, after "9.94A.728;"  
19 strike all material through "section" on line 3 and insert "adding a  
20 new section to chapter 72.09 RCW; creating new sections; and  
21 providing expiration dates"

EFFECT: Requires savings to be reinvested in victims' services  
for local superior courts or the victims' compensation fund, or both.
