5 (1) A commercial whale watching <u>business</u> license is required for 6 commercial whale watching ((operators)) <u>businesses</u>. The annual fee 7 <u>for a commercial whale watching business license</u> is two hundred 8 dollars in addition to the annual application fee of seventy-five 9 dollars.

10 (2) The annual fees for a commercial whale watching <u>business</u> 11 license as described in subsection (1) of this section must include 12 fees for each motorized or sailing vessel or vessels as follows:

13 (a) One to twenty-four passengers, three hundred twenty-five14 dollars;

15 (b) Twenty-five to fifty passengers, five hundred twenty-five 16 dollars;

17 (c) Fifty-one to one hundred passengers, eight hundred twenty-18 five dollars;

(d) One hundred one to one hundred fifty passengers, one thousandeight hundred twenty-five dollars; and

23 (3) ((The annual fees for a commercial whale watching license as 24 described in subsection (1) of this section must include fees for 25 each kayak as follows:

(a) Surrenders the previously issued license to the department;

5 (b) Submits to the department an application that identifies the 6 currently designated vessel, the vessel proposed to be designated, 7 and any other information required by the department; and

8 (c) Pays to the department a fee of thirty-five dollars and an 9 application fee of one hundred five dollars.

10 (((5))) (4) Unless the <u>business</u> license holder owns all vessels 11 identified on the application described in subsection (((+))) (3)(b) 12 of this section, the department may not change the vessel designation 13 on the license more than once per calendar year.

14 (((6))) <u>(5) A commercial whale watching operator license is</u> 15 required for commercial whale watching operators. A person ((who is 16 not the license holder)) may operate a motorized or sailing 17 commercial whale watching vessel designated on ((the)) <u>a commercial</u> 18 <u>whale watching business</u> license only if:

(a) The person holds ((an alternate)) a commercial whale watching
 operator license issued by the director; and

(b) The person is designated as an ((alternate)) operator on the underlying commercial whale watching <u>business</u> license.

(((7))) <u>(6)</u> No individual may hold more than one ((alternate))
commercial whale watching operator license. An individual who holds
an ((alternate)) operator license may be designated as an
((alternate)) operator on an unlimited number of commercial whale
watching <u>business</u> licenses.

28 (((8))) <u>(7)</u> The annual fee for ((an alternate)) <u>a commercial</u> 29 <u>whale watching</u> operator license is ((two)) <u>one</u> hundred dollars in 30 addition to an annual application fee of seventy-five dollars.

31 (((9))) <u>(8) A person may conduct commercial whale watching via</u> 32 <u>guided kayak tours only if:</u>

33 (a) The person holds a kayak guide license issued by the 34 <u>director; and</u>

35 (b) The person is designated as a kayak guide on the underlying 36 commercial whale watching business license.

37 (9) No individual may hold more than one kayak guide license. An 38 individual who holds a kayak guide license may be designated on an 39 unlimited number of commercial whale watching business licenses.

1 (10) The annual fee for a kayak guide license is \$25 in addition to an annual application fee of \$25. 2 (11) The definitions in this subsection apply throughout this 3 section unless the context clearly requires otherwise. 4 (a) "Commercial whale watching" means the act of taking, or 5 6 offering to take, passengers aboard a vessel or guided kayak tour in order to view marine mammals in their natural habitat for a fee. 7 (b) (("Commercial whale watching operators" includes commercial 8 9 vessels and kayak rentals that are engaged in the business of whale watching. 10 (c)) "Commercial whale watching business" means a business that 11 12 engages in the activity of commercial whale watching. (c) "Commercial whale watching business license" means a 13 department-issued license to operate a commercial whale watching 14 15 business. (d) "Commercial whale watching license" means a commercial whale 16 17 watching business license, a commercial whale watching operator license, or a kayak guide license as defined in this section. 18 (e) "Commercial whale watching operator" means a person who 19 operates a motorized or sailing vessel engaged in the business of 20 21 whale watching. 22 (f) "Commercial whale watching operator license" means a 23 department-issued license to operate a commercial motorized or sailing vessel on behalf of a commercial whale watching business. 24 25 (q) "Commercial whale watching vessel" means any vessel that is 26 being used as a means of transportation for individuals to engage in 27 commercial whale watching. 28 (h) "Kayak guide" means a person who conducts guided kayak tours on behalf of a commercial whale watching business. 29 30 (i) "Kayak guide license" means a department-issued license to 31 conduct commercial guided kayak tours on behalf of a commercial whale 32 watching business. (12) The residency and business requirements of RCW 77.65.040 (2) 33 and (3) do not apply to Canadian individuals or corporations applying 34 for and holding Washington commercial whale watching licenses defined 35 36 in this section. 37 (13) The license and application fees in this section are waived for calendar years 2021 and 2022. 38

5 On page 1, line 1 of the title, after "licenses;" strike the 6 remainder of the title and insert "amending RCW 77.65.615; and 7 declaring an emergency."

EFFECT: Waives all license and application fees for commercial whale watching businesses for calendar years 2021 and 2022. Clarifies that a commercial whale watching operation must obtain a commercial whale watching business license. Establishes a commercial whale watching operator license. Removes fees for each kayak operated by a commercial whale watching licensee. Establishes a kayak guide license. Establishes that residency and business requirements do not apply to Canadian individuals or corporations applying for and holding commercial whale watching licenses.
