1 AN ACT Relating to creating the offense of unlawful branding of
2 another person; amending RCW 9.94A.515 and 9.94A.515; reenacting and
3 amending RCW 9A.04.080; adding a new section to chapter 9A.36 RCW;
4 prescribing penalties; providing an effective date; and providing an
5 expiration date.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

7 NEW SECTION. **Sec. 1.** A new section is added to chapter 9A.36
8 RCW to read as follows:

9 (1) A person is guilty of unlawful branding of another person if
10 he or she knowingly:

11 (a) Marks another person's body with a subdermal implant, tattoo,
12 or body art, with the knowledge that the mark is intended to be used
13 to track the person or mark the person for ownership as part of a
14 plan or scheme to engage in trafficking of the person under RCW
15 9A.40.100 or promoting prostitution of the person under RCW 9A.88.070
16 or 9A.88.080; or

17 (b) Uses force, fraud, or coercion to cause a person to have his
18 or her body marked with a subdermal implant, tattoo, or body art, for
19 the purpose of tracking the person or marking the person for
20 ownership as part of a plan or scheme to engage in trafficking of the

1 person under RCW 9A.40.100 or promoting prostitution of the person
2 under RCW 9A.88.070 or 9A.88.080.

3 (2) Unlawful branding of another person is a class B felony.

4 (3) For the purposes of this section:

5 (a) "Body art" has the same meaning as provided in RCW
6 18.300.010.

7 (b) "Coercion" has the same meaning as provided in RCW 9A.36.070.

8 (c) "Tattoo" means an indelible mark made by tattooing, as
9 defined in RCW 18.300.010.
