HOUSE BILL 2120

State of Washington 67th Legislature 2022 Regular Session

AN ACT Relating to crimes involving emergency services; amending RCW 9.94A.515 and 9.94A.515; adding new sections to chapter 9A.56 RCW; creating a new section; prescribing penalties; making an appropriation; providing an effective date; providing an expiration date; and declaring an emergency.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

NEW SECTION. Sec. 1. The legislature finds that incidents of theft from emergency services providers and agencies are becoming more frequent. These offenses are more egregious than other property crimes due to the potential severity of first responders being without essential equipment, which can result in destruction of property and loss of life. Local governments and emergency services agencies have made significant investments in vital equipment that is expensive to replace. Meanwhile, the absence of even an inexpensive item could be catastrophic in itself or could jeopardize the functionality of other life-saving equipment. In addition, scarcity shipping delays have left some affected agencies without essential equipment or the ability to source new equipment in a timely manner. In turn, this creates the potential for devastating outcomes for public safety. The urgency of this issue calls for an immediate response. Therefore, the legislature intends to create a
