2 Yakima where his family has lived and farmed in the Yakima Valley for
3 nearly a century; and

4 WHEREAS, He graduated from A.C. Davis High School in Yakima in
5 1996; and

6 WHEREAS, Dufault graduated from the University of Pennsylvania,
7 earned a Juris Doctorate degree from Harvard Law School, and
8 graduated from the United States Army Judge Advocate General School
9 at the University of Virginia; and

10 WHEREAS, He served during wartime in Kuwait and Afghanistan; and

11 WHEREAS, Dufault is a Lieutenant Colonel in the United States
12 Army Reserve and serves as a Judge Advocate General's (JAG) Corps
13 military lawyer; and

14 WHEREAS, He is an investor and real estate developer specializing
15 in senior, student, and family housing; and

16 WHEREAS, Dufault has been committed to public service having
17 served on the Selah City Council, chair of the Yakima County Veterans
18 Board, a member of the Yakima County Economic Development Board, and
19 chair of the Yakima Valley Technical Skills Center General Advisory
20 Council; and

21 WHEREAS, He is active in his community, including American Legion
22 Selah Post 88 and the Veterans of Foreign Wars; and

1 WHEREAS, Dufault was elected to the first of two terms in the
2 Washington State House of Representatives in 2018 to represent the
3 15th Legislative District; and

4 WHEREAS, He serves as assistant ranking member of the House
5 Finance and Consumer Protection and Business Committees,
6 respectively; and

7 WHEREAS, Dufault has worked tirelessly for the people, employers,
8 institutions, projects, and communities of the 15th Legislative
9 District, specifically promoting legislation that expanded mental
10 health care capacity, provided housing and services for homeless
11 veterans, and invested in schools, parks, youth programs, and roads
12 in Yakima County; and

13 WHEREAS, He has fought for constitutional rights, property
14 rights, lower taxes, and transparency in government; and

15 WHEREAS, Dufault is the loving father of three daughters - Ellie,
16 Lulu, and Addy - whose health, happiness, and prosperity are his top
17 priority;

18 NOW, THEREFORE, BE IT RESOLVED, That the Washington State House
19 of Representatives recognize Dufault's record of public service, both
20 in and out of this chamber, on behalf of his district, his
21 colleagues, and the people of the State of Washington.
