1 AN ACT Relating to salaries of elected officials; and amending  
2 RCW 43.03.011, 43.03.012, and 43.03.013.

3 BE IT ENACTED BY THE WASHINGTON CITIZENS' COMMISSION ON SALARIES FOR  
4 ELECTED OFFICIALS OF THE STATE OF WASHINGTON:

5 **Sec. 1.** RCW 43.03.011 and 2019 c 5 s 1 are each amended to read
