1 AN ACT Relating to Washington state horse racing commission
2 provisions; amending RCW 67.16.100; and providing an expiration date.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 **Sec. 1.** RCW 67.16.100 and 1998 c 345 s 5 are each amended to
5 read as follows:

6 (1) All sums paid to the commission under this chapter, including
7 those sums collected for license fees and excluding those sums
8 collected under RCW 67.16.102 and 67.16.105(3), (~~shall~~) must be
9 disposed of by the commission as follows: One hundred percent thereof
10 (~~shall~~) must be retained by the commission for the payment of the
11 salaries of its members, secretary, clerical, office, and other help
12 and all expenses incurred in carrying out the provisions of this
13 chapter. (~~No salary, wages, expenses, or compensation of any kind~~
14 ~~shall be paid by the state in connection with the work of the~~
15 ~~commission.~~)

16 (2) Any moneys collected or paid to the commission under the
17 terms of this chapter and not expended at the close of the fiscal
18 biennium (~~shall~~) must be paid to the state treasurer and be placed
19 in the fair fund created in RCW 15.76.115. The commission may, with
20 the approval of the office of financial management, retain any sum
21 required for working capital.

1 NEW SECTION. **Sec. 2.** This act expires June 30, 2023.
